DIGEST OF SB 212 (Updated January 27, 2014 3:01 pm - DI 55)

Citations Affected: Noncode.

Synopsis: Study of standards for septic systems. Urges the legislative council to assign to the appropriate committee for study during the 2014 legislative interim the topics of: (1) statewide standards for sewage disposal systems, including septic tanks and related facilities and devices; and (2) sewage disposal systems using alternative technologies that offer performance superior to that of traditional sewage disposal systems.

Effective: Upon passage.

A BILL FOR AN ACT concerning environmental law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **As used in this**

9 (1) **statewide standards for sewage disposal systems, including**
10 **septic tanks and related facilities and devices; and**

11 (2) **sewage disposal systems using alternative technologies that**
12 **offer performance superior to that of traditional sewage**
13 **disposal systems.**

14 (d) **If the legislative council assigns the topics described in**
15 **subsection (c) to a committee for study, the committee shall issue**
16 **to the legislative council a final report containing the committee's**
17 **findings and recommendations, if any, in an electronic format**
