DIGEST OF SB 214 (Updated January 31, 2024 4:15 pm - DI 152)

**Citations Affected:** IC 20-26.

**Synopsis:** Student mental health resources. Requires the department of education, in consultation with the office of the secretary of family and social services, to approve and make available student mental health resources for certain schools. Requires the governing body of a school corporation or the equivalent authority for a charter school to publish and publicly post the approved student mental health resources.

**Effective:** Upon passage.

## SENATE BILL No. 214

A BILL FOR AN ACT to amend the Indiana Code concerning education.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 20-26-5-44.5 IS ADDED TO THE INDIANA  
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
3 [EFFECTIVE UPON PASSAGE]: **Sec. 44.5. (a) As used in this**  
4 **section, "school" means the following:**  
5 (1) **A school maintained by a school corporation.**  
6 (2) **A charter school.**  
7 (b) **Not later than July 15, 2024, and each July 15 thereafter, the**  
8 **department shall approve, in consultation with the office of the**  
9 **secretary of family and social services, and make available to a**  
10 **school student mental health resources on the following subjects:**  
11 (1) **Youth suicide.**  
12 (2) **Human trafficking.**  
13 (3) **Interpersonal violence.**  
14 (4) **Child abuse and neglect.**  
15 (5) **Substance abuse.**  
16 (6) **Any other subject concerning student mental health that**  
17 **the department considers appropriate.**

1           **(c) The governing body of a school corporation or the equivalent**  
2 **authority for a charter school shall:**  
3           **(1) publish the student mental health resources approved**  
4 **under subsection (b) on the school:**  
5           **(A) website; and**  
6           **(B) social media platforms; and**  
7           **(2) post a hard copy of the student mental health resources**  
8 **approved under subsection (b) in a location that is visible and**  
9 **accessible to all students of the school.**  
10          **(d) Nothing in this section shall be construed to prevent the**  
11 **governing body of a school corporation or the equivalent authority**  
12 **for a charter school from publishing or posting mental health**  
13 **resources in addition to the student mental health resources**  
14 **approved by the department under subsection (b).**  
15          **SECTION 2. An emergency is declared for this act.**
