

SENATE BILL No. 237

DIGEST OF SB 237 (Updated January 16, 2020 12:35 pm - DI 135)

Citations Affected: IC 36-8.

Synopsis: Care of city police officers and firefighters. Requires a city to pay for the care of a police officer or firefighter who suffers an injury while on duty.

Effective: July 1, 2020.

SENATE BILL No. 237

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1.1C 36-8-4-5 IS AMENDED TO READ AS FOLLOWS
2	[EFFECTIVE JULY 1, 2020]: Sec. 5. (a) A city shall pay for the care
3	of a police officer or firefighter who suffers an injury while performing
4	the person's on duty or contracts illness caused by the performance of
5	the person's duty, including an injury or illness that results in a
6	disability or death presumed incurred in the line of duty under
7	IC 5-10-13. This care includes:
8	(1) medical and surgical care;
9	(2) medicines and laboratory, curative, and palliative agents and
10	means;
11	(3) X-ray, diagnostic, and therapeutic service, including during
12	the recovery period; and
13	(4) hospital and special nursing care if the physician or surgeon
14	in charge considers it necessary for proper recovery.
15	(b) Expenditures required by subsection (a) shall be paid from the
16	general fund of the city.
17	(c) A city that has paid for the care of a police officer or firefighter



1	under subsection (a) has a cause of action for reimbursement of the
1	
2	amount paid under subsection (a) against any third party against whom
3	the police officer or firefighter has a cause of action for an injury
4	sustained because of or an illness caused by the third party. The city's
5	cause of action under this subsection is in addition to, and not in lieu
6	of, the cause of action of the police officer or firefighter against the
7	third party.
