SENATE BILL No. 245

DIGEST OF SB 245 (Updated January 27, 2014 3:02 pm - DI 104)

Citations Affected: IC 20-34; IC 34-30.

Synopsis: Schools and auto-injectable epinephrine. Allows a health care provider with prescriptive authority to prescribe auto-injectable epinephrine to a school or school district. Sets requirements for certain individuals employed by a school or school district to fill, store, and administer auto-injectable epinephrine. Provides civil immunity for: (1) certain school employees in the administration of auto-injectable epinephrine; and (2) health care providers in the prescribing of auto-injectable epinephrine and in the training of school employees in the administration of auto-injectable epinephrine.

Effective: July 1, 2014.

SENATE BILL No. 245

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 20-34-4.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]:

4 **Chapter 4.5. Auto-Injectable Epinephrine**
5 **Sec. 1. (a) A school may fill a prescription for auto-injectable**
6 **epinephrine and store the auto-injectable epinephrine in the school**
7 **if a health care provider who is licensed in Indiana and whose**
8 **scope of practice includes the prescribing of medication writes the**
9 **prescription for auto-injectable epinephrine for the school or**
10 **school district.**

11 **(b) The school shall store the auto-injectable epinephrine in a**
12 **safe location in which only school personnel have access.**

13 **Sec. 2. (a) A school nurse may administer auto-injectable**
14 **epinephrine obtained under section 1 of this chapter to any of the**
15 **following individuals if the individual is demonstrating signs or**
16 **symptoms of life-threatening anaphylaxis and the individual does**

1 not have epinephrine at the school or the individual's prescription
2 is not available:

- 3 (1) Students at the school.
4 (2) School personnel.
5 (3) Visitors at the school.

6 (b) School employees may administer auto-injectable
7 epinephrine obtained under section 1 of this chapter if the
8 following are met:

- 9 (1) The school employee has voluntarily received training in:
10 (A) recognizing anaphylaxis; and
11 (B) the proper administration of auto-injectable
12 epinephrine;

13 by a health care provider who is licensed or certified in
14 Indiana, for whom the administration of auto-injectable
15 epinephrine is within the health care provider's scope of
16 practice, who has received training in the administration of

25 Sec. 3. (a) A health care provider who is licensed in Indiana and
26 whose scope of practice includes the prescribing of medication may
27 write a prescription, drug order, or protocol for auto-injectable
28 epinephrine for the school or school district.

29 (b) A pharmacist licensed under IC 25-26 may dispense a valid
30 prescription, drug order, or protocol for auto-injectable
31 epinephrine issued in the name of a school or school district.

32 Sec. 4. (a) A school nurse or school employee who administers
33 auto-injectable epinephrine in accordance with the manufacturer's
34 guidelines and with this chapter is not liable for civil damages
35 resulting from the administration of auto-injectable epinephrine
36 under this chapter unless the act or omission constitutes gross
37 negligence or willful or wanton misconduct.

39 (1) writes a prescription, drug order, or protocol under this

41 (2) provides training to school personnel under this chapter;

Page 2, line 13, delete "physician licensed under IC 25-22.5 or a registered nurse".

Page 2, line 14, delete "licensed under IC 25-23," and insert **"health care provider who is licensed or certified in Indiana, for whom the administration of auto-injectable epinephrine is within the health care provider's scope of practice, who has received training in the administration of auto-injectable epinephrine, and"**.

Page 2, line 30, after "with" insert **"the manufacturer's guidelines and with"**.
