DIGEST OF SB 294 (Updated March 16, 2017 10:54 am - DI 77)

Citations Affected: IC 15-17.

Synopsis: Bovine tuberculosis testing. Provides that expenses related to bovine tuberculosis testing for each calendar year are payable as follows: (1) 50% from the county council. (2) 50% from the Indiana state board of animal health (board). Provides that the board is responsible for paying for the board's share of expenses with funds appropriated to the board in the state board of animal health indemnity fund.

Effective: July 1, 2017.

ENGROSSED SENATE BILL No. 294

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 15-17-7-1, AS ADDED BY P.L.2-2008, SECTION
2 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1,
3 2017]: Sec. 1. (a) If the board determines that the cattle within an
4 accredited county must be tested for bovine tuberculosis to conform
5 with federal regulations governing the reaccreditation of the county, the
6 county council, **subject to subsection (d)**, shall appropriate a sufficient
7 amount of money to perform the testing. The board shall determine the
8 amount of the appropriation based on the most reliable source of
9 information.
10 (b) The appropriation under subsection (a) must reflect the number
11 of cattle within the county, but may not exceed a tax levy of
12 seventy-five ten-thousandths (0.0075) per dollar of assessed valuation.
13 (c) The board, before July 1 of the year in which the appropriation
14 under subsection (a) is made, shall notify the county auditor to include
15 the appropriation in the county budget for the year in which the testing
16 of cattle for reaccreditation purposes will be done.
