SENATE BILL No. 354

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 10-17-14 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE

4 **Chapter 14. Hoosier Women Veterans Program**
5 **Sec. 1. As used in this chapter, "coordinator" refers to the**
6 **Hoosier women veterans coordinator designated under section 7 of**
7 **this chapter.**
8 **Sec. 2. As used in this chapter, "department" refers to the**
9 **Indiana department of veterans' affairs established by**
10 **IC 10-17-1-2.**
11 **Sec. 3. As used in this chapter, "director" refers to the director**
12 **of veterans' affairs.**
13 **Sec. 4. As used in this chapter, "program" refers to the Hoosier**
14 **women veterans program established by section 6 of this chapter.**
15 **Sec. 5. As used in this chapter, "women veterans" means women**

1 (1) served in the armed forces of the United States; and
2 (2) were discharged under conditions other than dishonorable.
3 **Sec. 6. The Hoosier women veterans program is established**
4 **within the department.**
5 **Sec. 7. The director shall designate a coordinator who is**
6 **responsible for the administration of the program under the**
7 **direction and supervision of the director.**
8 **Sec. 8. The program has the following purposes and duties:**
9 (1) Perform outreach to improve women veterans' awareness
10 of eligibility for federal and state veterans' services and
11 benefits.
12 (2) Assess the needs of women veterans with respect to
13 benefits and services.
14 (3) Review programs, research projects, and other initiatives
15 designed to address or meet the needs of Indiana's women
16 veterans.
17 (4) Make recommendations to the director to improve benefits
18 and services for women veterans.
19 (5) Incorporate women veterans' issues in strategic planning
20 concerning benefits and services.
21 **Sec. 9. The department shall set the salary of the coordinator.**
22 **Sec. 10. The department shall adopt rules under IC 4-22-2 to**
23 **implement this chapter.**
