ENGROSSED SENATE BILL No. 354

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 10-17-14 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]:

4 **Chapter 14. Hoosier Women Veterans Program**
5 **Sec. 1. As used in this chapter, "coordinator" refers to the**
6 **Hoosier women veterans coordinator designated under section 7 of**
7 **this chapter.**

8 **Sec. 2. As used in this chapter, "department" refers to the**
9 **Indiana department of veterans' affairs established by**
10 **IC 10-17-1-2.**

11 **Sec. 3. As used in this chapter, "director" refers to the director**
12 **of veterans' affairs.**

13 **Sec. 4. As used in this chapter, "program" refers to the Hoosier**
14 **women veterans program established by section 6 of this chapter.**

15 **Sec. 5. As used in this chapter, "women veterans" means women**
16 **who:**

1 (1) served in the armed forces of the United States; and
2 (2) were discharged under conditions other than dishonorable.
3 **Sec. 6. The Hoosier women veterans program is established**
4 **within the department. The program must be funded using the**
5 **available resources of the department.**
6 **Sec. 7. The director may designate a coordinator who is**
7 **responsible for the administration of the program under the**
8 **direction and supervision of the director.**
9 **Sec. 8. The program has the following purposes and duties:**
10 **(1) Perform outreach to improve women veterans' awareness**
11 **of eligibility for federal and state veterans' services and**
12 **benefits.**
13 **(2) Assess the needs of women veterans with respect to**
14 **benefits and services.**
15 **(3) Review programs, research projects, and other initiatives**
16 **designed to address or meet the needs of Indiana's women**
17 **veterans.**
18 **(4) Make recommendations to the director to improve benefits**
19 **and services for women veterans.**
20 **(5) Incorporate women veterans' issues in strategic planning**
21 **concerning benefits and services.**
22 **Sec. 9. The department may set the salary of the coordinator**
23 **using only the available resources of the department.**
24 **Sec. 10. The department may adopt rules under IC 4-22-2 to**
25 **implement this chapter.**
