3 *Whereas, Lieutenant Tracy Hayden, a 17-year veteran of*
4 *the Decatur Township Fire Department, passed away on*
5 *November 9, 2019;*

6 *Whereas, Lieutenant Hayden was born January 14, 1981,*
7 *in Indianapolis and graduated from Ben Davis High School;*

8 *Whereas, After studying Fire Science at Lake Superior*
9 *State University, Lieutenant Hayden joined the Decatur*
10 *Township Fire Department;*

11 *Whereas, Lieutenant Hayden was promoted to Merit*
12 *Lieutenant in 2011, and to Division Chief of Fire and Life*
13 *Safety in 2014, where he investigated fires and worked in fire*
14 *education with schools and businesses;*

15 *Whereas, Involved with numerous fire organizations,*
16 *Lieutenant Hayden was a member of the Marion County Arson*
17 *Task Force, the International Association of Arson*
18 *Investigators, and the National Association of Fire*
19 *Investigators;*

20 *Whereas, When not at the firehouse, Lieutenant Hayden*
21 *loved playing video games, traveling to Las Vegas, taking*
22 *annual firefighter racing trips, and officiating high school*
23 *football;*



1 *Whereas, Lieutenant Hayden was diagnosed with leukemia*
2 *in May 2019, and the diagnosis was believed to be the result of*
3 *an October 2015 fire where he was exposed to toxic chemicals;*

4 *Whereas, A devoted family man, Lieutenant Hayden is*
5 *survived by his wife, Tammy, his sons, Oliver and Wyatt, and*
6 *his father, Robert; and*

7 *Whereas, Though he succumbed to leukemia on November*
8 *9, 2019, Lieutenant Hayden's service to the citizens of Decatur*
9 *Township and Marion County will never be forgotten:*
10 *Therefore,*

11 *Be it resolved by the Senate of the General Assembly*
12 *of the State of Indiana, the House of Representatives*
13 *concurring:*

14 SECTION 1. That the Indiana General Assembly
15 memorializes Decatur Township Firefighter Lieutenant Tracy
16 Hayden.

17 SECTION 2. The Secretary of the Senate is hereby directed
18 to transmit copies of this Resolution to Lieutenant Hayden's
19 wife, Tammy, his two sons, Oliver and Wyatt, his father,
20 Robert, and the Decatur Township Fire Department.
