7 *Whereas, Born January 12, 1971, in Monticello, Deputy*
8 *Bassett was a graduate of Knox High School and the Indiana*
9 *Law Enforcement Academy as a member of the 04-157*
10 *graduating class;*

11 *Whereas, Deputy Bassett's law enforcement career began*
12 *as a Reserve Deputy with the Burnettsville Police Department*
13 *before joining the Pulaski County Sheriff's Department as a*
14 *patrol deputy, where he served for two and a half years until*
15 *his death;*

16 *Whereas, A member of the Fraternal Order of Police Lodge*
17 *123, Deputy Bassett is survived by his wife, Shannon, daughter,*
18 *Madison, step-daughters, Dakota and Julie Hines, parents, Ron*
19 *Bassett and Penni Pigeccella, three sisters, Brukentta Geisler,*
20 *Cynaka Carr, and Sharim Shields, brother, Nathan Arbuckle,*
21 *and step-father, Paul Arbuckle;*

22 *Whereas, Known as a kind-hearted person, Deputy Bassett*
23 *was respected by his peers for his love of God, family, and*

10 SECTION 1. That the Indiana General Assembly expresses
11 its deepest gratitude and sympathies to the family of Deputy
12 Shadron K. Bassett and urges the Indiana Department of
13 Transportation to honor Deputy Bassett by naming a mile of
14 State Road 39 between Pulaski County Roads 300 North and
15 400 North the "Deputy Shadron K. Bassett Memorial Mile".

17 to transmit copies of this Resolution to the family of Deputy
18 Shadron K. Bassett, the Pulaski County Sheriff's Department,
