1           A CONCURRENT RESOLUTION honoring James G. McIntire  
2           upon his retirement as Executive Vice President of the Indiana State  
3           Medical Association.

4           *Whereas, Since 2006, James G. McIntire has served as the*  
5           *Executive Vice President of the Indiana State Medical*  
6           *Association, the largest physician member organization in*  
7           *Indiana;*

8           *Whereas, Jim, a Hoosier's Hoosier and graduate of*  
9           *Shortridge High School, received his Bachelor's Degree from*  
10          *Indiana University before going on to earn his law degree from*  
11          *Indiana University Robert H. McKinney School of Law;*

12          *Whereas, As Executive Vice President of the Indiana State*  
13          *Medical Association, Jim managed an outstanding staff of 28*  
14          *individuals who provide a variety of professional services,*  
15          *educational programs, and advocacy for the association's*  
16          *nearly 8,000 physician members in order to better the health of*  
17          *Indiana's citizens;*

18          *Whereas, Throughout Jim's tenure, the Indiana State*  
19          *Medical Association was successful in its support of numerous*  
20          *legislative health initiatives, including the Healthy Indiana*  
21          *Plan, a statewide smoking ban in public buildings, the*  
22          *expansion of graduate medical education opportunities in*  
23          *Indiana, combating infant mortality, and education on*  
24          *controlled substance prescribing;*

13           Vice President.
