5 *Whereas, Lt. Clayton Robert Cullen was born July 9, 1992,*
6 *in Evansville, Indiana;*

7 *Whereas, Lt. Cullen grew up in Bicknell, Indiana, graduated*
8 *from North Knox High School in 2011, and went on to earn a*
9 *Bachelor's Degree in History from Indiana University in 2015;*

10 *Whereas, While at Indiana University, Lt. Cullen joined the*
11 *Indiana University Army ROTC program;*

12 *Whereas, Upon graduation from Indiana University, Lt.*
13 *Cullen took an oath to become an active duty officer in the*
14 *United States Army, specializing in aviation;*

15 *Whereas, Lt. Cullen served as a member of the 4th Combat*
16 *Aviation Brigade, 4th Infantry Division;*

17 *Whereas, During his service, Lt. Cullen received several*
18 *awards, including the Army Achievement Medal, National*
19 *Defense Service Medal, and the Army Service Ribbon;*

20 *Whereas, Lt. Cullen tragically passed away on January 20,*
21 *2018, during a helicopter accident as part of a training exercise*
22 *at Fort Irwin, California;*

1 *Whereas, Lt. Cullen is survived by his parents, Robert and*
2 *Julie Cullen, his brother and sister-in-law, Ian and Katie Cullen,*
3 *his grandmother, Kathleen Curry Pack, along with numerous*
4 *aunts, uncles, cousins, and friends; and*

5 *Whereas, In recognition of Lt. Cullen's service and*
6 *dedication to his hometown, state, and country, it is fitting that*
7 *his life and service be recognized by the State of Indiana:*
8 *Therefore,*

9 *Be it resolved by the Senate of the General Assembly*
10 *of the State of Indiana, the House of Representatives*
11 *concurring:*

12 SECTION 1. That the Indiana General Assembly expresses
13 its deepest gratitude and sympathies to the family of First Lt.
14 Clayton Robert Cullen and urges the Indiana Department of
15 Transportation to honor Lt. Cullen by naming SR 67 between
16 Bicknell, Indiana and Bruceville, Indiana the "Lt. Clayton Robert
17 Cullen Memorial Highway".

18 SECTION 2. The Secretary of the Senate is hereby directed
19 to transmit copies of this Resolution to Robert and Julie Cullen,
20 Craig Lehman, and the Commissioner of the Indiana Department
21 of Transportation.
