5 *Whereas, In 2008, the Indiana General Assembly enacted*
6 *Public Law 69 establishing the Indiana Legislative Youth*
7 *Advisory Council;*

8 *Whereas, The Council consists of Hoosiers from across*
9 *Indiana appointed by the Governor, President Pro Tempore of*
10 *the Indiana Senate, the Speaker of the Indiana House, and both*
11 *the Minority Leader in the Senate and in the House. Each*
12 *Council member serves a two-year term;*

13 *Whereas, The Council convenes to advise the Indiana*
14 *General Assembly on topics related to Indiana's youth through*
15 *suggestion, endorsement, and advocacy;*

16 *Whereas, The actions and involvement of members of the*
17 *Council demonstrate the importance of individuals from*
18 *different backgrounds, political ideologies, and areas of*
19 *expertise engaging in policy discussions about government;*

20 *Whereas, Advised by the Indiana Bar Foundation, the*
21 *Council's members' involvement provides a firsthand lesson in*
22 *civic engagement that cannot be matched; and*

23 *Whereas, Through the dedication and service of the Indiana*



1 *Legislative Youth Advisory Council, the interests of Indiana's*
2 *youth will continue to be represented: Therefore,*

3 *Be it resolved by the Senate of the General Assembly*
4 *of the State of Indiana, the House of Representatives*
