5 *Whereas, Kappa Alpha Psi, originally Kappa Alpha Nu,*
6 *was established on January 5th, 1911 at Indiana University in*
7 *Bloomington;*

9 *Whereas, This was the first and only African-American*
10 *fraternity to this date founded on that campus and the third*
11 *African-American college-based fraternity founded in the*
12 *country;*

13 *Whereas, The young, intellectual, and talented 10*
14 *undergraduate college students herewith revered as the*
15 *Founders were Elder Watson Diggs, Dr. Ezra Dee Alexander,*
16 *Attorney Henry T. Asher, Dr. Byron K. Armstrong, Dr. Marcus*
17 *Peter Blakemore, Paul W. Caine, George Wesley Edmonds, Dr.*
18 *Guy Levis Grant, Edward Giles Irvin, and John Milton Lee;*

19 *Whereas, Kappa Alpha Psi Fraternity has grown to include*
20 *over 700 chapters and has initiated over 30,000 men. The*
21 *fraternity still maintains and lives by its motto from inception*
22 *"Achievement in Every Field of Human Endeavor"; and*

23 *Whereas, Kappa Alpha Psi continues to serve as an avenue*
24 *for young African American men to better themselves in the*
25 *company of fraternal brothers and it is with great pride that we*

2 *nationally and internationally in the state of Indiana:*

4 *Be it resolved by the Senate of the General Assembly*
5 *of the State of Indiana, the House of Representatives*
