5 *College in Indianapolis in 1937 and became Marian University*  
6 *in 2009;*

8           *Whereas, Marian University serves a student body of more*  
9 *than 2,700 full-time students, both at the undergraduate and*  
10 *graduate levels from across the United States and 14 countries*  
11 *through dedication to excellent teaching and learning in the*  
12 *Franciscan and liberal arts traditions;*

13           *Whereas, Marian University is committed to developing*  
14 *character strength and leadership skills through athletic*  
15 *excellence;*

17           *Whereas, Marian University established its football*  
18 *program in 2006;*

20           *Whereas, The Marian University Football Knights won the*  
21 *57<sup>th</sup> Annual NAIA Football National Championship, in Rome,*  
22 *Georgia on December 13, 2012. The Knights were also a*  
23 *finalist in the 59<sup>th</sup> Annual NAIA National Championship in*  
24 *Daytona Beach, Florida on December 19, 2014;*



1           *Whereas, The Marian University Football Knights won the*  
2           *60<sup>th</sup> Annual NAIA Football National Championship in Daytona*  
3           *Beach, Florida on December 19, 2015; and*

4           *Whereas, The Marian University Football Knights are led*  
5           *by head coach Mark Henninger, under the direction of Athletic*  
6           *Director Steve Downing, Executive Vice President and Provost*  
7           *Thomas J. Enneking and President Daniel J. Elsener, and with*  
8           *the enthusiastic support of Marian University's student, faculty,*  
9           *staff, alumni, and Board of Trustees and the entire Indianapolis*  
10           *community: Therefore,*

11           *Be it resolved by the Senate of the General Assembly*  
12           *of the State of Indiana, the House of Representatives concurring:*
