

## **SENATE JOINT RESOLUTION No. 18**

DIGEST OF SJR18 (Updated February 11, 2015 12:54 pm - DI ck)

**Citations Affected:** The Constitution of the State of Indiana.

**Synopsis:** Article V convention. Applies to Congress for a convention under Article V of the United States Constitution to propose amendments to the United States Constitution. Provides that such a convention be limited to proposing amendments to the Constitution of the United States that do the following: (1) Impose fiscal restraints on the federal government. (2) Limit the power and jurisdiction of the federal government regarding the Commerce and General Welfare Clauses. (3) Limit the terms of office for its officials and for members of Congress of Congress.

**Effective:** This proposed amendment must be agreed to by two consecutive general assemblies and ratified by a majority of the state's voters voting on the question to be effective.

A JOINT RESOLUTION proposing an amendment to the United States Constitution.

Be it resolved by the General Assembly of the State of Indiana:

SECTION 1. That the General Assembly of the State of Indiana

2	makes application to the Congress of the United States for a convention
3	under Article V of the Constitution of the United States to propose

5	SECTION 2. That such a convention called under Article V be

## COMMITTEE REPORT

Madam President: The Senate Committee on Rules and Legislative Procedure, to which was referred Senate Joint Resolution No. 18, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Delete the title and insert the following:

A JOINT RESOLUTION proposing an amendment to the United States Constitution.

Page 1, delete lines 1 through 6, begin a new paragraph and insert: "SECTION 1. That the General Assembly of the State of Indiana makes application to the Congress of the United States for a convention under Article V of the Constitution of the United States to propose amendments to the Constitution of the United States.

SECTION 2. That such a convention called under Article V be limited to proposing amendments to the Constitution of the United States that do the following:

- (1) Impose fiscal restraints on the federal government.
- (2) Limit the power and jurisdiction of the federal government regarding the Commerce and General Welfare Clauses.
- (3) Limit the terms of office for its officials and for members of Congress.

SECTION 3. That certified copies of this resolution be sent to the presiding officers of the Congress of the United States, to the Secretary of the United States Senate and the Clerk of the United States House of Representatives, to the presiding officer of each chamber of each state legislature in the United States, and to the members of the Congress of the United States from Indiana."

and when so amended that said Joint Resolution be reassigned to the Senate Committee on Judiciary.
