5 *Whereas, Charles P. Morris has served as a board member*
6 *for Guilford Township, located in Plainfield, Indiana, since*
7 *1979;*

8 *Whereas, Shortly after joining the Guilford Township*
9 *Board, Charles assisted in designating 200 acres of park land*
10 *for the Plainfield community with the 1984 establishment of*
11 *Hummel Park;*

12 *Whereas, With the support of the Township Board, Hummel*
13 *Park now boasts countless facilities and amenities, including a*
14 *community center, performing arts center, events pavilion,*
15 *gazebos, shelter houses, playgrounds, accessible paved trails,*
16 *restrooms, splash pad, sledding hill, basketball courts, sand*
17 *volleyball courts, and ball fields;*

18 *Whereas, In 2010, Charles worked to reorganize the fire*
19 *services within Plainfield and Guilford Township, eventually*



1 *establishing the Plainfield Fire Territory in order to meet the*
2 *increasing fire service needs of over 30,000 Township*
3 *residents;*

4 *Whereas, During his tenure on the Township Board,*
5 *Charles partnered with Hendricks County Meals on Wheels,*
6 *Sheltering Wings center for domestic violence victims, and*
7 *LINK transportation through Hendricks County Senior Services*
8 *in support of various township assistance initiatives; and*

9 *Whereas, Due to his dedication and leadership in Guilford*
10 *Township for the past 44 years, Charles was named the 2022*
11 *Charles Bogden Memorial Township Board Member of the*
12 *Year by the Indiana Township Association: Therefore,*

13 *Be it resolved by the Senate of the*
14 *General Assembly of the State of Indiana:*

15 SECTION 1. That the Indiana Senate congratulates Charles
16 Morris on being named the Indiana Township Association's
