## SENATE RESOLUTION \_\_\_\_\_

MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1           A SENATE RESOLUTION to recognize Second  
2           Presbyterian Church for their advocacy and work on housing  
3           related programs.

4           *Whereas, Second Presbyterian Church of Indianapolis*  
5           *works with and supports multiple organizations within the city*  
6           *to advocate for the housing needs of underserved populations;*

7           *Whereas, Second Presbyterian Church has worked with*  
8           *the Greater Indianapolis Habitat for Humanity for more than*  
9           *35 years to sponsor an annual interfaith build and participate*  
10          *in other Habitat activities throughout the year;*

11          *Whereas, Second Presbyterian Church sponsors and works*  
12          *with NeighborLink Indianapolis, which has served more than*  
13          *3,000 people and made more than 4,000 critical repairs for*  
14          *homeowners age 62 and older or with disabilities living in*  
15          *Marion County, with repairs being made at no cost to the*  
16          *homeowner so they may age in a place of safety;*

17          *Whereas, Second Presbyterian Church sponsors and works*  
18          *with Servants At Work, Inc. (SAWs) ramp building, a non-profit*  
19          *organization that specializes in wheel chair ramps for low-*

1 *income, permanently disabled individuals;*

2 *Whereas, Second Presbyterian Church sponsors and works*  
3 *with the Family Promise organization to eliminate*  
4 *homelessness in the Indianapolis area and Second Presbyterian*  
5 *Church was the title sponsor in 2022, donating \$123,606 to*  
6 *help multiple families obtain housing and access to AfterCare*  
7 *programs for two years; and*

8 *Whereas, Second Presbyterian Church works to address*  
9 *housing needs by repairing and building homes for our most*  
10 *vulnerable citizens in the local area, but their impact reaches*  
11 *across the country: Therefore,*

12 *Be it resolved by the Senate of the*  
13 *General Assembly of the State of Indiana:*

14 SECTION 1. That the Indiana Senate recognizes Second  
15 Presbyterian Church for their advocacy and work on housing  
16 related programs.

17 SECTION 2. That the Secretary of the Senate is hereby  
18 directed to transmit three copies of this Resolution to the  
19 Second Presbyterian Church.
