MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION honoring Jerry Alan King for
2 his exceptional military service and his many accomplishments
3 with the American Legion.

4 *Whereas, Jerry Alan King served in the United States Navy*
5 *for thirty-two distinguished years;*

6 *Whereas, King is a veteran of the Vietnam War;*

7 *Whereas, King served five years aboard a navy destroyer;*
8 *a total of twenty-seven years aboard naval submarines;*
9 *qualified on a diesel boat; qualified on three ballistic missile*
10 *submarines, including: the Will Rogers SSBN 659, the Thomas*
11 *Edison SSBN 610, and the USS Sam Houston SSBN 609; and*
12 *qualified on the USS Atlanta SSN 712;*

13 *Whereas, King has also served as a leading torpedo man,*
14 *first lieutenant, nuclear weapons handling supervisor, duty*
15 *chief, chief of the watch, and diving officer;*



1 *Whereas, Joining the American Legion in 1966, King*
2 *served as Post 9 Commander from 1999-2003, Post 7*
3 *Commander from 2003-2004, Post 9 Adjutant from 2005-2014,*
4 *and Post 9 Finance Officer from 2012-2014;*

5 *Whereas, King also served as the Department of Mexico*
6 *First Vice Commander from 2002-2004; Department of Mexico*
7 *Commander from 2004-2005; Department of Mexico First Vice*
8 *Commander from 2005-2006; Department of Mexico*
9 *Commander from 2007-2008; and on the Foreign Relations*
10 *Council Department Executive Committee from 2012-2014;*

12 *Whereas, It is fitting that the Indiana Senate recognizes*
13 *Jerry Alan King for his substantial commitment to his country*
14 *and his community: Therefore,*
