SENATE RESOLUTION NO. 28

MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION commending the passage of
2 the National Historic Preservation Act on the occasion of its
3 50th anniversary.

4 *Whereas, On October 15, 1966, President Lyndon B.*
5 *Johnson signed into law the National Historic Preservation*
6 *Act, which established the nation's legal framework for the*
7 *protection and preservation of historic buildings, landscapes,*
8 *and archaeological discoveries;*

9 *Whereas, Over the past 50 years since its enactment, the*
10 *National Historic Preservation Act has had a profound impact*
11 *on communities throughout the State of Indiana and the United*
12 *States as a whole;*

13 *Whereas, In the past 25 years alone, 1,600 communities*
14 *have revitalized historic downtowns and main streets and have*
15 *carried out 89,000 historic building rehabilitations;*

16 *Whereas, Due to these efforts, the National Register of*
17 *Historic Places, created by the National Historic Preservation*
18 *Act, now lists more than 80,000 historic properties, with nearly*
19 *2,000 of those properties being listed in the State of Indiana;*



1 *Whereas, The National Historic Preservation Act also*
2 *created the Federal Preservation Tax Incentives Program,*
3 *which is the largest federal program supporting historic*
4 *preservation, and which has helped to create millions of jobs,*
5 *save tens of thousands of historic structures that represent our*
6 *nation's history, and attract billions of dollars in investment;*

7 *Whereas, The State of Indiana in particular has a*
8 *distinguished history of and dedication to the preservation of*
9 *historic places, with great Hoosiers such as Eli Lilly, Glenn*
10 *Black, Agnes McCullough Hanna, and Wilbur Peat having*
11 *fostered early historic preservation efforts by investigating*
12 *sites, calling attention to long-forgotten architectural wonders,*
13 *and then restoring buildings through private efforts as well as*
14 *public projects, such as the state's ongoing preservation of the*
15 *J.F.D. Lanier Mansion;*

16 *Whereas, The State of Indiana now leads the nation with its*
17 *Indiana Historic Sites and Structure Inventory, the only*
18 *identification program in the country that has succeeded in*
19 *completing its mission of recording historic districts, buildings,*
20 *sites, structures, and objects in all of its 92 counties;*

21 *Whereas, Historic preservation efforts throughout the state,*
22 *beyond maintaining Indiana's heritage, are also a critical*
23 *component of the economy, providing heritage tourism and*
24 *federal tax credits for certified preservation projects; and*

25 *Whereas, To ensure a strong future for preservation efforts,*
26 *the United States and thousands of other public, private, and*
27 *nonprofit sector partners, including the Indiana Division of*
28 *Historic Preservation, are commemorating the 50th anniversary*
29 *of the National Historic Preservation Act throughout 2016*
30 *under the banner of "Preservation50": Therefore,*

31 *Be it resolved by the Senate of the*
32 *General Assembly of the State of Indiana:*



1 SECTION 1. That the Indiana Senate commends the passage of
2 the National Historic Preservation Act on the occasion of its 50th
3 anniversary.

4 SECTION 2. The Secretary of the Senate is hereby directed to
5 transmit a copy of this Resolution to the Preservation50 Advisory
6 Committee.
