MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1 A SENATE RESOLUTION urging the Legislative Council
2 to assign to the appropriate study committee the topics of the
3 qualifications, training, certification, and available workforce
4 for local veteran service officers in the state of Indiana,
5 including the prospect of creating multi-county offices.

6 *Whereas, The Indiana Department of Veterans Affairs aims*
7 *to assist Hoosier veterans with the transfer to civilian life by*
8 *locating apprenticeships and on-the-job training opportunities;*

9 *Whereas, Workforce Development Offices across the state*
10 *are crucial in helping veterans find employment opportunities;*

11 *Whereas, The Disabled Veterans' Outreach Program*
12 *specializes in job placement and job tailoring for veterans with*
13 *service-related disabilities;*

14 *Whereas, The state of Indiana is home to roughly 550,000*
15 *veterans;*

16 *Whereas, The state of Indiana spends approximately*
17 *\$130,000 on veteran education and vocational opportunities*

1 *Whereas, The state of Indiana is obligated to provide its*
2 *veterans with opportunities that help the transition to civilian*
3 *life; and*

4 *Whereas, In order to fulfill the obligation to provide*
5 *veterans with opportunities, the members of the Indiana*
6 *General Assembly must have current and thorough information*
7 *on the qualifications, training, certification, and available*
8 *workforce for local veteran service officers, and the prospect of*
9 *multi-county offices: Therefore,*

10 *Be it resolved by the Senate of the*
11 *General Assembly of the State of Indiana:*

12 SECTION 1. That the Indiana State Senate urges the
13 Legislative Council to assign to the appropriate study
14 committee the topics of the qualifications, training,
15 certification, and available workforce for local veteran service
16 officers in the state of Indiana, including the prospect of
17 creating multi-county offices.
