I offer the following resolution and move its adoption:

4 *Whereas, Highland Hills Middle School, located in*
5 *Georgetown, Indiana, has been named a 2015 School to Watch*
6 *by the National Forum to Accelerate Middle-Grades Reform;*

7 *Whereas, Schools to Watch is an initiative launched by the*
8 *National Forum to Accelerate Middle-Grades Reform in 1999;*

9 *Whereas, Through the Schools to Watch initiative, the*
10 *National Forum identifies schools across the United States that*
11 *are well on their way to meeting the Forum's criteria for high*
12 *performance;*

13 *Whereas, The Forum's three conditions for bestowing the*
14 *award take into account whether the school is academically*
15 *excellent, developmentally responsive, and socially equitable;*



1 *Whereas, To achieve this level of excellence, high*
2 *performing schools such as Highland Hills Middle School*
3 *establish norms, structures, and organizational arrangements*
4 *to support and sustain their trajectory towards excellence with*
5 *a sense of purpose that drives every facet of practice and*
6 *decision-making;*

7 *Whereas, This national title has been earned by only a few*
8 *schools in the State of Indiana;*

9 *Whereas, With this new title comes the opportunity for*
10 *Highland Hills Middle School to send a small team of*
11 *educators to attend the Schools to Watch Conference in*
12 *Washington, D.C. in Summer 2015; and*

13 *Whereas, It is fitting that the Indiana Senate gives special*
14 *recognition to Highland Hills Middle School for its substantial*
15 *contribution to education in the State of Indiana: Therefore,*

16 *Be it resolved by the Senate of the*
17 *General Assembly of the State of Indiana:*

18 SECTION 1. That the Indiana Senate congratulates Highland Hills
19 Middle School for being named a 2015 School to Watch by the
20 National Forum to Accelerate Middle-Grades Reform.
