## MADAM PRESIDENT:

I offer the following resolution and move its adoption:

1	A SENATE RESOLUTION honoring Senator Scott
2	Schneider upon his retirement from the Indiana State Senate.
3	Whereas, Senator Scott Schneider has served the
4	constituents of District 30, encompassing parts of Hamilton and
5	Marion Counties, since 2009;
6	Whereas, As an active member of the Senate Majority
7	Caucus, Senator Schneider serves on the Senate Committees on
8	Education and Career Development and Environmental
9	Affairs;
10	Whereas, Senator Schneider has been a leading voice for
11	fiscal responsibility and protecting taxpayers during his time in
12	the Senate by voting to permanently cap property taxes for all
13	Hoosiers, co-authoring legislation to eliminate Indiana's
14	inheritance tax, authoring legislation to make the property tax
15	appeal process friendlier to taxpayers, and introducing an
16	amendment to withhold taxpayer money from abortion

Whereas, Senator Schneider also co-authored school choice legislation, led the effort to move Indiana away from

6	Schneider serves on the board of the Indiana School for the
7	Blind and Visually Impaired; volunteers for Sack Hunger and
8	Golf for the Cure; is a member of College Park Church; and
9	previously served on the Indianapolis City-County Council, the
10	Marion County Sheriff's Merit Board, and the Citizens' Police
11	Complaint Board;
12	Whereas, Senator Schneider's honors include the 2012
13	Respect Life Award from Indianapolis Right to Life, the 2012
14	Charter School Warrior of the Year Award from School Choice
15	Indiana, and the 2010 Legislator of the Year Award from the
16	Marion County Judiciary;
17	Whereas, Senator Schneider gained a public servant's heart
18	from both of his parents: His father, William G. Schneider, who
19	served as Ward Chairman, a Marion County Commissioner
20	from 1968 to 1971, and as Indianapolis City-County Councilor
21	from 1971 until 199; and his mother, Patricia Schneider, who
22	served as Vice Ward Chairwoman, has managed numerous
23	political campaigns, and serves on the Board of Directors for
24	the Eagle Forum;
25	Whereas, Senator Schneider graduated from Heritage
26	Christian School and received his B.A. from Indiana Wesleyan
27	University, and works for his father's company, Mister Ice of
28	Indianapolis, Inc.;
29	Whereas, Senator Schneider is married to his loving wife
30	Kris, with whom he has five children; and
31	Whereas, Senator Schneider's thoughtfulness and
32	commitment to his principles will be greatly missed within the
