1 AN ACT concerning motor vehicles; relating to registration; permanent
2 registration of certain vehicles, annual report; amending K.S.A. 2014
3 Supp. 8-1,134 and repealing the existing section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2014 Supp. 8-1,134 is hereby amended to read as
7 follows: 8-1,134. (a) Except as provided in subsection (d): (1) Each motor
8 vehicle, trailer or semitrailer owned or leased by any city, county,
9 township or school district of this state or by any agency or instrumentality
10 of any city, county or township and used exclusively for governmental or
11 school district purposes and not for any private purposes, which is not
12 otherwise exempt from registration; or (2) each truck tractor, trailer or
13 semitrailer leased by a community college or technical college and used
14 exclusively for a truck driver training program, which is not otherwise
15 exempt from registration, shall be registered for a fee established by rules
16 and regulations adopted by the secretary of revenue, except that such fee
17 shall not exceed the actual cost of such registration. Such registration shall
18 be permanent in nature and designed in such a manner as to remain with a
19 vehicle for the duration of the life span of the vehicle, the duration of the
20 lease or until the title is transferred to an owner who is not a city, county,
21 township, school district, community college or technical college.

22 (b) License plates issued for city, county, township, school district,
23 community college or technical college vehicles shall be distinctive and
24 shall contain the words city, county, township, school district, community
25 college or technical college, as applicable and there shall be no year date
26 thereon.

27 ~~(c) Each city, county, township, school district, community college or~~
28 ~~technical college shall file an annual report with the division of vehicles~~
29 ~~identifying such vehicle registered under this section.~~

30 ~~(d)~~ Vehicles registered under this section which are used for utility
31 purposes shall be issued license plates as prescribed by subsection (b),
32 except that such license plates shall be issued for periods of five years, but
33 shall be required to pay all license fees imposed pursuant to K.S.A. 8-143,
34 and amendments thereto, as though such vehicles were registered annually.
35 The secretary of revenue shall design decals to be affixed to such license
36 plates containing the word utility and the date the registration is to expire.

1 ~~(e)~~(d) The secretary of revenue shall adopt rules and regulations
2 necessary to carry out the provisions of this act.

3 Sec. 2. K.S.A. 2014 Supp. 8-1,134 is hereby repealed.

4 Sec. 3. This act shall take effect and be in force from and after its
5 publication in the statute book.
