

HOUSE BILL No. 2418

1 AN ACT concerning health and healthcare; establishing an on-site state
2 employee health clinic; making and concerning appropriations for the
3 fiscal year ending June 30, 2018, for the department of administration.
4

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. (a) For the fiscal year ending June 30, 2018, appropriations
7 are hereby made, restrictions and limitations are hereby imposed and
8 transfers, capital improvement projects, fees, receipts, disbursements and
9 acts incidental to the foregoing are hereby directed or authorized as
10 provided in this act.

11 (b) This act shall not be subject to the provisions of K.S.A. 75-
12 6702(a), and amendments thereto.

14 DEPARTMENT OF ADMINISTRATION

15 (a) There is appropriated for the above agency from the state general
16 fund for the fiscal year ending June 30, 2018, the following:

17 On-site state employee health clinic.....\$2,700,000

18 *Provided*, That expenditures from the on-site state employee health clinic
19 account for the construction or renovation of premises related to the
20 establishment of an on-site state employee health clinic pursuant to section
21 3, and amendments thereto, shall not exceed the sum of \$500,000.

22 Sec. 3. (a) Subject to appropriations, the department of administration
23 shall procure the services of a vendor to establish an on-site state
24 employee health clinic, including any services necessary to construct,
25 renovate and operate such clinic.

26 (b) Any procurement contract solicited and executed pursuant to this
27 section shall be subject to the competitive bid requirements established in
28 K.S.A. 75-3737a et seq., and amendments thereto.

29 (c) Any procurement contract executed pursuant to this section shall
30 include, at a minimum, the following requirements:

31 (1) The vendor shall employ a physician licensed by the state board
32 of healing arts to oversee the clinic.

33 (2) The vendor shall provide clinic services to state employees free of
34 charge or, for state employees who participate in the state health care
35 benefits program and who elect a high-deductible health plan and health
36 savings account, for the minimum charge permissible by federal law.

1 (3) The vendor shall establish and maintain an online, secure patient
2 portal that allows secure messaging with clinic physicians, scheduling and
3 access to the patient's personal medical record.

4 (4) The vendor shall offer, at a minimum, the following services at
5 the clinic: General primary healthcare services; limited supply and
6 dispensing of medications, to the extent permitted under the pharmacy act
7 of the state of Kansas; on-site laboratory services that are granted waived
8 status under the federal clinical laboratory improvement amendments of
9 1988 by the United States food and drug administration; third-party
10 laboratory services that are not granted such waived status; behavioral
11 health services; and chiropractic services.

12 (5) The vendor shall offer clinic services that align with the state of
13 Kansas health and wellness program administered by the department of
14 health and environment and the Kansas state employees health care
15 commission, including services that align with rules and regulations
16 adopted pursuant to subsection (d).

17 (6) The vendor shall provide data security for all clinic and patient
18 data and shall not contract with or otherwise rely upon a third party to
19 provide such security.

20 (7) The vendor shall provide an electronic medical record system that
21 is interoperable, that enables the exchange of health data with outside
22 electronic medical record systems, public health entities, clinicians,
23 administrative staff and health provider organizations and that enables
24 physicians to view health data within the physician's work flow from other
25 healthcare providers across healthcare delivery venues.

26 (8) The vendor shall be required to prepare a report detailing cost
27 avoidance and return on investment over a period of five years and shall
28 submit such report to the secretary of administration, the house of
29 representatives standing committee on appropriations and the senate
30 standing committee on ways and means.

31 (9) The contract shall include performance guarantees, including, but
32 not limited to, guarantees related to: Patient experience, including patient
33 satisfaction, wait time and complaint resolution; compliance and reporting,
34 including near-real-time health clinic reporting, quality and peer review
35 and regulatory compliance; and clinical outcomes, including care
36 coordination and chronic condition management for at least three years
37 after treatment.

38 (d) The Kansas state employees health care commission and the
39 secretary of health and environment may adopt rules and regulations to
40 establish criteria for providing financial or clinic incentives to state
41 employees who participate in the state of Kansas health and wellness
42 program administered by the department of health and environment and
43 the Kansas state employees health care commission.

1 (e) The department of administration shall advise and consult with the
2 Kansas state employees health care commission regarding the
3 establishment of the on-site state health employee health clinic described
4 in this section, including any bids submitted to establish the on-site state
5 health employee health clinic.

6 (f) The department of administration shall advise and consult with the
7 joint committee on state building construction regarding the identification
8 and selection of space and premises to establish the on-site state health
9 employee health clinic described in this section.

10 (g) The department of administration shall advise and consult with
11 the department of health and environment regarding the operation of the
12 on-site state employee health clinic described in this section.

13 Sec. 4. This act shall take effect and be in force from and after its
14 publication in the statute book.
