1 AN ACT concerning civil commitment of sexually violent predators;
2 amending K.S.A. 59-29a01, 59-29a03 and 59-29a10 and K.S.A. 2014
3 Supp. 59-2401a, 59-29a04, 59-29a04a, 59-29a05, 59-29a06, 59-29a07,
4 59-29a08, 59-29a11, 59-29a22, 59-29a23, 59-29a24 and 77-603 and
5 repealing the existing sections; also repealing K.S.A. 59-29a18.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 59-29a01 is hereby amended to read as follows: 59-
9 29a01. (a) The legislature finds that there exists an extremely dangerous
10 group of sexually violent predators who have a mental abnormality or
11 personality disorder and who are likely to engage in repeat acts of sexual
12 violence if not treated for their mental abnormality or personality disorder.
13 Because the existing civil commitment procedures under K.S.A. 59-2901
14 et seq., and amendments thereto, are inadequate to address the special
15 needs of sexually violent predators and the risks they present to society,
16 the legislature determines that a separate involuntary civil commitment
17 process for the potentially long-term control, care and treatment of
18 sexually violent predators is necessary. The legislature also determines that
19 because of the nature of the mental abnormalities or personality disorders
20 from which sexually violent predators suffer, and the dangers they present,
21 it is necessary to house involuntarily committed sexually violent predators
22 in an environment separate from persons involuntarily committed under
23 K.S.A. 59-2901 et seq., and amendments thereto.

24 (b) Notwithstanding any other evidence of legislative intent, it is
25 hereby declared that any time requirements set forth in K.S.A. 59-29a01 et
26 seq., and amendments thereto, either as originally enacted or as amended,
27 are intended to be directory and not mandatory and serve as guidelines for
28 conducting proceedings under K.S.A. 59-29a01 et seq., and amendments
29 thereto.

30 (c) *The provisions of K.S.A. 59-29a01 et seq., and amendments*
31 *thereto, shall be known and may be cited as the Kansas sexually violent*
32 *predator act.*

33 Sec. 2. K.S.A. 59-29a03 is hereby amended to read as follows: 59-
34 29a03. (a) When it appears that a person may meet the criteria of a

1 sexually violent predator as defined in K.S.A. 59-29a02, and amendments
2 thereto, the agency with jurisdiction shall give written notice of such to the
3 attorney general and the multidisciplinary team established in subsection
4 ~~(d)~~ (f), 90 days prior to:

5 (1) The anticipated release from total confinement of a person who
6 has been convicted of a sexually violent offense, except that in the case of
7 persons who are returned to prison for no more than 90 days as a result of
8 revocation of postrelease supervision, written notice shall be given as soon
9 as practicable following the person's readmission to prison;

10 (2) release of a person who has been charged with a sexually violent
11 offense and who has been determined to be incompetent to stand trial
12 pursuant to K.S.A. 22-3305, and amendments thereto;

13 (3) release of a person who has been found not guilty by reason of
14 insanity of a sexually violent offense pursuant to K.S.A. 22-3428, and
15 amendments thereto; or

16 (4) release of a person who has been found not guilty of a sexually
17 violent offense pursuant to K.S.A. 22-3428, and amendments thereto, and
18 the jury who returned the verdict of not guilty answers in the affirmative to
19 the special question asked pursuant to K.S.A. 22-3221, and amendments
20 thereto.

21 (b) The agency with jurisdiction shall inform the attorney general and
22 the multidisciplinary team established in subsection ~~(d)~~ (f) of the
23 following:

24 (1) The person's name, identifying factors, anticipated future
25 residence and offense history; and

26 (2) documentation of institutional adjustment and any treatment
27 received.

28 (c) *Any reports of evaluations prepared or provided pursuant to*
29 *subsection (b) shall demonstrate that the person evaluated was informed*
30 *of the following: (1) The nature and purpose of the evaluation; and (2)*
31 *that the evaluation will not be confidential and that any statements made*
32 *by the person and any conclusions drawn by the evaluator may be*
33 *disclosed to a court, the detained person's attorney, the prosecutor and the*
34 *trier of fact at any proceeding conducted under the Kansas sexually*
35 *violent predator act.*

36 (d) *The permitted disclosures required to be submitted to the attorney*
37 *general under this section shall be deemed to be in response to the*
38 *attorney general's civil demand for relevant and material information to*
39 *investigate whether a petition shall be filed. The information provided*
40 *shall be specific to the purposes of the Kansas sexually violent predator*
41 *act and as limited in scope as reasonably practicable.*

42 ~~(e)~~ (e) The agency with jurisdiction, its employees, officials,
43 members of the multidisciplinary team established in subsection ~~(d)~~ (f),

1 members of the prosecutor's review committee appointed as provided in
2 subsection ~~(e)~~ (g) and individuals contracting, appointed or volunteering to
3 perform services hereunder shall be immune from liability for any good-
4 faith conduct under this section.

5 ~~(d)~~ (f) The secretary of corrections shall establish a multidisciplinary
6 team which may include individuals from other state agencies to review
7 available records of each person referred to such team pursuant to
8 subsection (a). *The team shall include the mental health professional who*
9 *prepared any evaluation, interviewed the person or made any*
10 *recommendation to the attorney general.* The team, ~~within 30 days of~~
11 ~~receiving notice,~~ shall assess whether or not the person meets the
12 definition of a sexually violent predator, as established in K.S.A. 59-
13 29a02, and amendments thereto. The team shall notify the attorney general
14 of its assessment.

15 ~~(e)~~ (g) The attorney general shall appoint a prosecutor's review
16 committee to review the records of each person referred to the attorney
17 general pursuant to subsection (a). The prosecutor's review committee
18 shall assist the attorney general in the determination of whether or not the
19 person meets the definition of a sexually violent predator. The assessment
20 of the multidisciplinary team shall be made available to the attorney
21 general and the prosecutor's review committee.

22 ~~(f)~~ (h) The provisions of this section are not jurisdictional, and failure
23 to comply with such provisions *not affecting constitutional rights* in no
24 way prevents the attorney general from proceeding against a person
25 otherwise subject to the ~~provision of K.S.A. 59-29a01 et seq., and~~
26 ~~amendments thereto~~ *provisions of the Kansas sexually violent predator act.*

27 Sec. 3. K.S.A. 2014 Supp. 59-29a04 is hereby amended to read as
28 follows: 59-29a04. (a) ~~When it appears that the person presently confined~~
29 ~~may be a sexually violent predator and~~ the prosecutor's review committee,
30 appointed as provided in ~~subsection (e) of~~ K.S.A. 59-29a03(g), and
31 amendments thereto, has determined that the person meets the definition of
32 a sexually violent predator, the attorney general, within 75 days of the date
33 the attorney general received the written notice ~~by the agency of~~
34 ~~jurisdiction~~ as provided in ~~subsection (a) of~~ K.S.A. 59-29a03(a), and
35 amendments thereto, may file a petition in the county where the person
36 was convicted of or charged with a sexually violent offense alleging that
37 the person is a sexually violent predator and stating sufficient facts to
38 support such allegation.

39 (b) *Notwithstanding the provisions of subsection (a), when the person*
40 *named in the petition is a person who has been convicted of or charged*
41 *with a federal or other state offense that under the laws of this state would*
42 *be a sexually violent offense, as defined in K.S.A. 59-29a02, and*
43 *amendments thereto, the attorney general may file the petition in the*

1 *county where the person now resides, was charged or convicted of any*
2 *offense, or was released.*

3 *(c) Service of the petition on the attorney appointed or hired to*
4 *represent the person shall be deemed sufficient service.*

5 ~~*(b) (d) The provisions of this section are not jurisdictional, and failure*~~
6 ~~*to comply with such provisions not affecting constitutional rights in no*~~
7 ~~*way prevents the attorney general from proceeding against a person*~~
8 ~~*otherwise subject to the provision of K.S.A. 59-29a01 et seq., and*~~
9 ~~*amendments thereto provisions of the Kansas sexually violent predator act.*~~

10 ~~*(e) (e) Whenever a determination is made regarding whether a person*~~
11 ~~*may be a sexually violent predator, the county responsible for the costs*~~
12 ~~*incurred, including, but not limited to, costs of investigation, prosecution,*~~
13 ~~*defense, juries, witness fees and expenses, expert fees and expenses and*~~
14 ~~*other expenses related to determining whether a person may be a sexually*~~
15 ~~*violent predator, shall be reimbursed for such costs by the office of the*~~
16 ~~*attorney general from the sexually violent predator expense fund. The*~~
17 ~~*attorney general shall develop and implement a procedure to provide such*~~
18 ~~*reimbursements. If there are no moneys available in such fund to pay any*~~
19 ~~*such reimbursements, the county may file a claim against the state*~~
20 ~~*pursuant to article 9 of chapter 46, of the Kansas Statutes Annotated, and*~~
21 ~~*amendments thereto.*~~

22 *(f) The person against whom a petition is filed shall be responsible*
23 *for the costs of the medical care and treatment provided or made*
24 *accessible by the governmental entity having custody, and the*
25 *governmental entity having custody may seek reimbursement from the*
26 *person against whom a petition has been filed for such costs.*

27 *(g) Pre-commitment proceedings, post-commitment proceedings,*
28 *including conditional release and final discharge, and other court*
29 *proceedings are civil in nature. Such proceedings shall follow the*
30 *procedures set forth in chapter 60 of the Kansas Statutes Annotated, and*
31 *amendments thereto, except as expressly provided elsewhere in the Kansas*
32 *sexually violent predator act.*

33 Sec. 4. K.S.A. 2014 Supp. 59-29a04a is hereby amended to read as
34 follows: 59-29a04a. (a) There is hereby created in the state treasury the
35 sexually violent predator expense fund which shall be administered by the
36 attorney general. All moneys credited to such fund shall be used to
37 reimburse counties under:

38 (1) K.S.A. 59-29a04, and amendments thereto, responsible for the
39 costs related to determining whether a person may be a sexually violent
40 predator; and

41 (2) K.S.A. 2014 Supp. 59-29a23, and amendments thereto, for the
42 costs related to a person filing a ~~petition pursuant to K.S.A. 60-1501 et~~

3 (b) All expenditures from the sexually violent predator expense fund
4 shall be made in accordance with appropriation acts upon warrants of the
5 director of accounts and reports issued pursuant to vouchers approved by
6 the attorney general or the attorney general's designee.

7 Sec. 5. K.S.A. 2014 Supp. 59-29a05 is hereby amended to read as
8 follows: 59-29a05. (a) Upon filing of a petition under K.S.A. 59-29a04,
9 *and amendments thereto*, the judge shall determine whether probable cause
10 exists to believe that the person named in the petition is a sexually violent
11 predator. If such determination is made, the judge shall:

12 (1) Direct that person be taken into custody *and detained in the*
13 *county jail until such time as a determination is made that the person is a*
14 *sexually violent predator subject to commitment under the Kansas sexually*
15 *violent predator act; and*

16 (2) *file a protective order permitting disclosures of protected health*
17 *information to the parties, their counsel, evaluators, experts and others*
18 *necessary to the litigation during the course of the proceedings subject to*
19 *the Kansas sexually violent predator act.*

20 (b) Within 72 hours after a person is taken into custody pursuant to
21 subsection (a), *or as soon as reasonably practicable or agreed upon by the*
22 *parties*, such person shall be provided with notice of, and an opportunity to
23 appear in person at, a hearing to contest probable cause as to whether the
24 detained person is a sexually violent predator. At this hearing the court
25 shall: (1) Verify the detainer's identity; and (2) determine whether probable
26 cause exists to believe that the person is a sexually violent predator. The
27 state may rely upon the petition and supplement the petition with
28 additional documentary evidence or live testimony.

29 (c) At the probable cause hearing as provided in subsection (b), the
30 detained person shall have the following rights in addition to the rights
31 previously specified: (1) To be represented by counsel; (2) to present
32 evidence on such person's behalf; (3) to cross-examine witnesses who
33 testify against such person; and (4) to view and copy all petitions and
34 reports in the court file.

35 (d) If the probable cause determination is made, the court shall order
36 that the person be transferred to an appropriate secure facility, including,
37 but not limited to, a county jail, for an evaluation as to whether the person
38 is a sexually violent predator. The evaluation ordered by the court shall be
39 conducted by a person deemed to be professionally qualified to conduct
40 such an examination.

41 (e) The person conducting the evaluation ordered by the court
42 pursuant to this section shall notify the detained person of the following:
43 (1) The nature and purpose of the evaluation; and (2) that the evaluation

1 will not be confidential and that any statements made by the detained
2 person, and any conclusions drawn by the evaluator, will be disclosed to
3 the court, the detained person's attorney, the prosecutor and the trier of fact
4 at any proceeding conducted under ~~K.S.A. 59-29a01 et seq., and~~
5 ~~amendments thereto~~ *the Kansas sexually violent predator act.*

6 Sec. 6. K.S.A. 2014 Supp. 59-29a06 is hereby amended to read as
7 follows: 59-29a06. (a) Within 60 days after the completion of any hearing
8 held pursuant to K.S.A. 59-29a05, and amendments thereto, the court shall
9 ~~conduct a trial~~ *set the matter for a pretrial conference to establish a*
10 *mutually agreeable date for trial* to determine whether the person is a
11 sexually violent predator. The trial may be continued upon the request of
12 either party and a showing of good cause, or by the court on its own
13 motion in the due administration of justice, and when the respondent will
14 not be substantially prejudiced.

15 (b) ~~At all stages of the proceedings under K.S.A. 59-29a01 et seq.,~~
16 ~~and amendments thereto, any person subject to K.S.A. 59-29a01 et seq.,~~
17 ~~and amendments thereto, In proceedings under this section, the person~~
18 shall be entitled to the assistance of counsel *and an independent*
19 *examination pursuant to K.S.A. 60-235, and amendments thereto*, and if
20 the person is indigent, the court shall appoint counsel to assist such person.
21 ~~Whenever any person is subjected to an examination under K.S.A. 59-~~
22 ~~29a01 et seq., and amendments thereto, such person may retain experts or~~
23 ~~professional persons to perform an examination of such person's behalf.~~
24 ~~When the person wishes to be examined by a qualified expert or~~
25 ~~professional person of such person's own choice, such pursuant to K.S.A.~~
26 ~~60-235, and amendments thereto, the examiner shall be permitted to have~~
27 reasonable access to the person for the purpose of such examination, as
28 well as to all relevant medical and psychological records and reports. In
29 the case of a person who is indigent, the court, upon the person's request,
30 shall determine whether the services are necessary and reasonable
31 compensation for such services. If the court determines that the services
32 are necessary and the ~~expert or professional person's~~ *examiner's* requested
33 compensation for such services is reasonable, the court shall assist the
34 person in obtaining an ~~expert or professional person~~ *examiner* to perform
35 an examination or participate in the trial on the person's behalf. The court
36 shall approve payment for such services upon the filing of a certified claim
37 for compensation supported by a written statement specifying the time
38 expended, services rendered, expenses incurred on behalf of the person
39 and compensation received in the same case or for the same services from
40 any other source.

41 (c) Notwithstanding K.S.A. 60-456, and amendments thereto, at any
42 proceeding conducted under ~~K.S.A. 59-29a01 et seq., and amendments~~
43 ~~thereto, the Kansas sexually violent predator act~~ the parties shall be

1 permitted to call expert witnesses. The facts or data in the particular case
2 upon which an expert bases an opinion or inference may be those
3 perceived by or made known to the expert at or before the hearing. If the
4 facts or data are of a type reasonably relied upon by experts in the
5 particular field in forming opinions or inferences upon the subject, such
6 facts and data need not be admissible in evidence in order for the opinion
7 or inference to be admitted.

8 (d) The person, the attorney general, or the judge shall have the right
9 to demand that the trial be before a jury. Such demand for the trial to be
10 before a jury shall be filed, in writing, at least four days prior to trial.
11 Number and selection of jurors shall be determined as provided in K.S.A.
12 22-3403, and amendments thereto. If no demand is made, the trial shall be
13 before the court.

14 (e) A jury shall consist of 12 jurors unless the parties agree in writing
15 with the approval of the court that the jury shall consist of any number of
16 jurors less than 12 jurors. The person and the attorney general shall each
17 have eight peremptory challenges, or in the case of a jury of less than 12
18 jurors, a proportionally equal number of peremptory challenges.

19 (f) ~~The provisions of this section are not jurisdictional, and failure to~~
20 ~~comply with such provisions in no way prevents the attorney general from~~
21 ~~proceeding against a person otherwise subject to the provision of K.S.A.~~

24 Sec. 7. K.S.A. 2014 Supp. 59-29a07 is hereby amended to read as
25 follows: 59-29a07.(a) The court or jury shall determine whether, beyond a
26 reasonable doubt, the person is a sexually violent predator. If such
27 determination that the person is a sexually violent predator is made by a
28 jury, such determination shall be by unanimous verdict of such jury. Such
29 determination may be appealed *in the manner provided for civil cases in*
30 *article 21 of chapter 60 of the Kansas Statutes Annotated, and*
31 *amendments thereto.* If the court or jury determines that the person is a
32 sexually violent predator, the person shall be committed to the custody of
33 the secretary for aging and disability services for control, care and
34 treatment until such time as the person's mental abnormality or personality
35 disorder has so changed that the person is safe to be at large. Such control,
36 care and treatment shall be provided at a facility operated by the Kansas
37 department for aging and disability services.

38 (b) At all times, persons committed for control, care and treatment by
39 the Kansas department for aging and disability services pursuant to ~~K.S.A.~~
40 ~~59-29a01 et seq., and amendments thereto,~~ *the Kansas sexually violent*
41 *predator act* shall be kept in a secure facility and such persons shall be
42 segregated ~~at all times on different units~~ from any other patient under the
43 supervision of the secretary for aging and disability services and

1 commencing June 1, 1995, such persons committed pursuant to ~~K.S.A. 59-~~
2 ~~29a01 et seq., and amendments thereto,~~ *the Kansas sexually violent*
3 *predator act* shall be kept in a facility or building separate from any other
4 patient under the supervision of the secretary. The provisions of this
5 subsection shall apply to any facility or building utilized in any transitional
6 release program or conditional release program.

7 (c) The Kansas department for aging and disability services is
8 authorized to enter into an interagency agreement with the department of
9 corrections for the confinement of such persons. Such persons who are in
10 the confinement of the secretary of corrections pursuant to an interagency
11 agreement shall be housed and managed separately from offenders in the
12 custody of the secretary of corrections, and except for occasional instances
13 of supervised incidental contact, shall be segregated from such offenders.

14 (d) If any person while committed to the custody of the secretary
15 pursuant to ~~K.S.A. 59-29a01 et seq., and amendments thereto,~~ *the Kansas*
16 *sexually violent predator act* shall be taken into custody by any law
17 enforcement officer as defined in K.S.A. 2014 Supp. 21-5111, and
18 amendments thereto, pursuant to any parole revocation proceeding or any
19 arrest or conviction for a criminal offense of any nature, upon the person's
20 release from the custody of any law enforcement officer, the person shall
21 be returned to the custody of the secretary for further treatment pursuant to
22 ~~K.S.A. 59-29a01 et seq., and amendments thereto~~ *the Kansas sexually*
23 *violent predator act*. During any such period of time a person is not in the
24 actual custody or supervision of the secretary, the secretary shall be
25 excused from the provisions of K.S.A. 59-29a08, and amendments thereto,
26 with regard to providing that person an annual examination, annual notice
27 and annual report to the court, except that the secretary shall give notice to
28 the court as soon as reasonably possible after the taking of the person into
29 custody that the person is no longer in treatment pursuant to ~~K.S.A. 59-~~
30 ~~29a01 et seq., and amendments thereto,~~ *the Kansas sexually violent*
31 *predator act* and notice to the court when the person is returned to the
32 custody of the secretary for further treatment.

33 (e) If the court or jury is not satisfied beyond a reasonable doubt that
34 the person is a sexually violent predator, the court shall direct the person's
35 release.

36 (f) Upon a mistrial, the court shall direct that the person be held at an
37 appropriate secure facility, including, but not limited to, a county jail, until
38 another trial is conducted. Any subsequent trial following a mistrial shall
39 be held within 90 days of the previous trial, unless such subsequent trial is
40 continued as provided in K.S.A. 59-29a06, and amendments thereto.

41 (g) If the person charged with a sexually violent offense has been
42 found incompetent to stand trial, and is about to be released pursuant to
43 K.S.A. 22-3305, and amendments thereto, and such person's commitment

1 is sought pursuant to subsection (a), the court shall first hear evidence and
2 determine whether the person did commit the act or acts charged. The
3 hearing on this issue must comply with all the procedures specified in this
4 section. In addition, the rules of evidence applicable in criminal cases shall
5 apply, and all constitutional rights available to defendants at criminal trials,
6 other than the right not to be tried while incompetent, shall apply. After
7 hearing evidence on this issue, the court shall make specific findings on
8 whether the person did commit the act or acts charged, the extent to which
9 the person's incompetence or developmental disability affected the
10 outcome of the hearing, including its effect on the person's ability to
11 consult with and assist counsel and to testify on such person's own behalf,
12 the extent to which the evidence could be reconstructed without the
13 assistance of the person and the strength of the prosecution's case. If after
14 the conclusion of the hearing on this issue, the court finds, beyond a
15 reasonable doubt, that the person did commit the act or acts charged, the
16 court shall enter a final order, appealable by the person, on that issue, and
17 may proceed to consider whether the person should be committed pursuant
18 to this section.

19 Sec. 8. K.S.A. 2014 Supp. 59-29a08 is hereby amended to read as
20 follows: 59-29a08. (a) Each person committed under ~~K.S.A. 59-29a01 et~~
21 ~~seq., and amendments thereto,~~ *the Kansas sexually violent predator act*
22 shall have a current examination of the person's mental condition made
23 once every year. *When the person is not in transitional or conditional*
24 *release,* the secretary shall provide the committed person with an annual
25 written notice of the person's right to petition the ~~court office of~~
26 *administrative hearings* for release over the secretary's objection. The
27 notice shall *be notarized and* contain a waiver of ~~rights~~ *the person's rights*
28 *to petition the secretary pursuant to the Kansas administrative procedure*
29 *act.* The secretary shall also forward the annual report, as well as the
30 annual notice and waiver form, to the ~~court that committed the person~~
31 ~~under K.S.A. 59-29a01 et seq., and amendments thereto.~~ The person may
32 retain, or if the person is indigent and so requests the court may appoint a
33 qualified professional person to examine such person, and such expert or
34 professional person shall have access to all records concerning the person.
35 The ~~court that committed the person under K.S.A. 59-29a01 et seq., and~~
36 ~~amendments thereto,~~ shall then conduct an annual review of the status of
37 the committed person's mental condition. The committed person shall have
38 a right to have an attorney represent the person at the hearing but the
39 person is not entitled to be present at the hearing *attorney general and the*
40 *office of administrative hearings.*

41 (b) ~~Nothing contained in K.S.A. 59-29a01 et seq., and amendments~~
42 ~~thereto,~~ shall prohibit the person from otherwise petitioning the court for
43 discharge at this hearing. *Within 30 days after the person's receipt of the*

1 *annual report and notice of the person's right to petition the office of*
2 *administrative hearings, the person committed under the Kansas sexually*
3 *violent predator act who is not in the transitional or conditional release*
4 *program may petition the office of administrative hearings for a hearing to*
5 *determine if there is probable cause to believe the person's mental*
6 *abnormality or personality disorder has significantly changed so that it is*
7 *safe for the person to be placed in transitional release. The petition and*
8 *all other communications to the office of administrative hearings by any*
9 *party relating to a case under the Kansas sexually violent predator act,*
10 *other than in scheduled proceedings before the assigned hearing officer,*
11 *shall be in writing. The petitioner shall attach to the petition certification*
12 *from a mental health professional who provides treatment to the petitioner,*
13 *or from the person who prepared the annual report, that the petitioner has*
14 *participated in and complied with all prescribed treatment since the last*
15 *annual review. A failure to follow prescribed treatment or a failure to*
16 *attend treatment may be excused if, in the discretion of the person*
17 *providing treatment or the person supervising the program, the failure did*
18 *not interfere with the prescribed treatment. If a petition is not filed within*
19 *30 days as required by this section, the person's right to petition for*
20 *transitional release shall be deemed waived.*

21 (e) (1) ~~If the court at the hearing determines that probable cause exists~~
