1 AN ACT concerning the state banking board; increasing the compensation
2 of members; amending K.S.A. 74-3005 and K.S.A. 2020 Supp. 9-815
3 and repealing the existing sections.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2020 Supp. 9-815 is hereby amended to read as
7 follows: 9-815. (a) Any applicant making application under article 8 of
8 chapter 9 of the Kansas Statutes Annotated, and amendments thereto, shall
9 pay to the commissioner a fee in an amount established pursuant to K.S.A.
10 2020 Supp. 9-1726, and amendments thereto, to defray the expenses of the
11 state banking board, commissioner or other designees in the examination
12 and investigation of the application.

13 (b) The commissioner shall remit all moneys received under this
14 section to the state treasurer in accordance with the provisions of K.S.A.
15 75-4215, and amendments thereto. Upon receipt of each such remittance,
16 the state treasurer shall deposit the entire amount in the state treasury to
17 the credit of the bank investigation fund. The moneys in the bank
18 investigation fund shall be used to pay the expenses of the commissioner,
19 or designee, in the examination and investigation of such applications and
20 any unused balance shall be transferred to the bank commissioner fee
21 fund.

22 (c) Any members of the state banking board who make such an
23 examination or investigation shall be paid ~~the sum of \$35 per diem~~
24 *compensation as determined by the commissioner, based on the daily rate*
25 *of not less than \$100 nor more than \$150, for the time the members*
26 *actually are engaged in performing duties as members of the state banking*
27 *board and shall be compensated from such funds all the actual and*
28 *necessary expenses incurred in the performance of the members' duties.*

29 Sec. 2. K.S.A. 74-3005 is hereby amended to read as follows: 74-
30 3005. *Subject to the limitations of appropriations therefor, members of the*
31 *state banking board attending meetings of such board, or attending a*
32 *subcommittee meeting thereof authorized by such board, shall be paid*
33 *compensation, ~~subsistence allowances,~~ as determined by the*
34 *commissioner, based on the daily rate of not less than \$100 nor more than*
35 *\$150. Members of the board shall be paid mileage and other expenses as*
36 *provided in K.S.A. 75-3223, and amendments thereto. The commissioner*

1 shall act as secretary for ~~said~~ *such* board and shall keep a permanent record
2 of all meetings and proceedings of ~~said~~ *such* board in ~~his~~ *the*
3 *commissioner's* office.

4 Sec. 3. K.S.A. 74-3005 and K.S.A. 2020 Supp. 9-815 are hereby
5 repealed.

6 Sec. 4. This act shall take effect and be in force from and after its
7 publication in the statute book.
