## 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- "Newborn infant" means an infant who is medically determined to be less than 5 (a) 6 thirty (30) days old; and
- 7 "Participating place of worship" means a recognized place of religious (b) 8 worship that has voluntarily agreed to perform the duty granted in this section 9 and display signage prominently on its premises regarding its participation in 10 this section and its operating hours during which staff will be present.
- (2) A parent who places a newborn infant with an emergency medical services provider 12 or at a staffed police station, fire station, hospital, or participating place of worship 13 and expresses no intent to return for the infant shall have the right to remain 14 anonymous and not be pursued and shall not be considered to have abandoned or endangered the newborn infant under KRS Chapters 508 and 530.
  - (3) (a) Any emergency medical services provider, police officer, or firefighter who accepts physical custody of a newborn infant in accordance with this section shall immediately arrange for the infant to be taken to the nearest hospital emergency room and shall have implied consent to any and all appropriate medical treatment.
- 21 (b) Any staff member at a participating place of worship who accepts physical 22 custody of a newborn infant in accordance with this section shall immediately 23 contact the 911 emergency telephone service as set forth in KRS 65.750 to 24 65.760, wireless enhanced 911 system as set forth in KRS 65.7621 to 65.7643, 25 or emergency medical services as set forth in KRS Chapter 311A for 26 transportation to the nearest hospital emergency room.
