3		<b>→</b> S	ection 1. KRS 321.175 is amended to read as follows:
4	<u>(1)</u>	This	chapter shall be known as the Kentucky Veterinary Medicine Practice Act.
5	<u>(2)</u>	It is	hereby declared that:
6		<u>(a)</u>	The <u>practices[practice]</u> of veterinary medicine, <u>veterinary technology</u> , <u>animal</u>
7			euthanasia, and allied animal health professionals and the operation of
8			veterinary facilities, AAHP facilities, and board-certified animal control
9			agencies are privileges which are[ is a privilege which is] granted by
10			legislative authority and are subject to regulation and control in the interest
11			of public health, safety, and welfare[.] to protect the public from:
12			1. Being misled by incompetent, unscrupulous, and unauthorized
13			practitioners: [, and from]
14			2. Unprofessional or illegal practices by persons licensed to practice
15			veterinary medicine, veterinary technology, animal euthanasia, and
16			the allied animal health professions;
17			3. Substandard care; and
18			4. Unlicensed persons; [this chapter is enacted in the interest of the health,
19			safety, and welfare of the animal population and the citizens of
20			Kentucky.]
21		<u>(b)</u>	It is a matter of public interest and concern that the practices of veterinary
22			medicine, veterinary technology, animal euthanasia, and allied animal
23			health professions working on animals merit and receive the confidence of
24			the public and that only qualified individuals be permitted to practice these
25			professions in the Commonwealth. This chapter shall be liberally construed
26			to carry out these objectives and purposes;
27		<u>(c)</u>	The intent of this chapter is to regulate the professions of veterinary

1		meaicine, veterinary technology, animal euthanasia, and alitea animal
2		health professional work on animals and to establish standards for
3		veterinary premises and AAHP premises, both fixed and mobile, and shall
4		result in displacing competition by restricting licensure, permitting,
5		certification, and registration to practice these professions, as this practice
6		is defined and interpreted by the board, to persons and premises determined
7		by the board to be qualified under this chapter; and
8		(d) Any resulting restriction on competition is outweighed by the broader
9		interest in protection of the public health, safety, and welfare. It is
10		understood that the regulatory structure calls for veterinarians, veterinary
11		technicians, AAHPs, and citizens at large to serve on the board and this
12		chapter recognizes the need for professional expertise provided by
13		veterinarians and veterinary technicians serving the public interest.
14	<u>(3)</u>	This chapter is intended to provide active oversight and supervision through its
15		legislative enactment, the promulgation of administrative regulations, the
16		appointment of board members by the Governor, legal representation of the
17		board by competent counsel, legislative appropriation of moneys and spending
18		authority to support the board, and engagement in the administrative regulation
19		review process under the auspices of the Legislative Research Commission.
20	<u>(4)</u>	It is the purpose of this chapter to promote, preserve, and protect the public
21		health, safety, and welfare by and through the licensure, permitting, certification,
22		registration, and regulation of individuals, whether physically located within or
23		outside of the Commonwealth, who practice veterinary medicine, veterinary
24		technology, animal euthanasia, and AAHP services within Kentucky, and the
25		registration of veterinary facility locations, AAHP facility locations, and mobile
26		facilities where veterinary medicine or AAHP activities are being practiced. In
27		furtherance of this purpose, the Kentucky Board of Veterinary Examiners is

1		created, and its members, functions, and procedures shall be established in
2		accordance with this chapter.
3	<u>(5)</u>	The purpose of this chapter is to establish a comprehensive scheme to fully
4		occupy the fields of veterinary medicine, veterinary technology, AAHP work on
5		animals, and animal euthanasia, and provide a uniform regulatory scheme to be
6		enforced by the Kentucky Board of Veterinary Examiners as defined in the scopes
7		of practice.
8		→ SECTION 2. KRS 321.181 IS REPEALED AND REENACTED TO READ
9	AS l	FOLLOWS:
10	<u>As u</u>	sed in this chapter:
11	<u>(1)</u>	"Allied animal health professional" or "AAHP" means a professional who has
12		completed an approved allied animal health professional program and who offers
13		specialized, limited services to an animal patient in one (1) of the following areas:
14		(a) Animal chiropractic; or
15		(b) Equine dentistry;
16	<u>(2)</u>	(a) "Allied animal health professional facility" or "AAHP facility" means any

5	<u>(3)</u>	"Allied animal health professional manager" or "AAHP manager" means at
6		least one (1) board-permitted AAHP who registers to assume responsibility for the
7		registration, management, and operation of a registered allied animal health
8		professional facility;
9	<u>(4)</u>	"Allied animal health professional permit" or "AAHP permit" means a
10		credential issued to an allied animal health professional who is permitted by the
11		board to practice on animals in the Commonwealth and to conduct specialized
12		services for an animal patient limited to the scope of work as defined in
13		administrative regulation by the board;
14	<u>(5)</u>	"Animal" means any member of the animal kingdom other than a human,
15		whether living or dead;
16	<u>(6)</u>	"Animal shelter" means a public agency or private humane society, society for
17		the prevention of cruelty to animals, animal protection shelter or control agency,
18		or other facility that provides shelter and care for homeless, stray, unwanted, or
19		injured animals;
20	<u>(7)</u>	"Applicant" means a person who submits an application for licensure,
21		certification, permit, or registration, whether complete or not, to the board;
22	<u>(8)</u>	"Approved allied animal health professional program" means a school or
23		educational program offering specialized training to provide limited services to
24		an animal patient that has been approved by the board as meeting its
25		administrative standards;
26	<u>(9)</u>	"Approved foreign equivalency program" means a school or educational
27		program that has been approved by the board as meeting its administrative

1	standards, which offers additional training and testing for persons who graduated
2	from a non-board-approved veterinary medical program or non-board-approved
3	veterinary technology program;
4	(10) "Approved program of continuing education" means an educational program
5	approved by the board or offered by an approved provider of continuing
6	education;
7	(11) "Approved provider of continuing education" means any person that has met the
8	requirements of the board to provide educational courses that are designed to
9	ensure continued competence in the practice of veterinary medicine, veterinary
10	technology, animal euthanasia, or other area of practice governed by the board;
11	(12) "Approved veterinary medical program" means a school of veterinary medicine
12	or a veterinary medical education program that has been approved by the board
13	as meeting its administrative standards;
14	(13) "Approved veterinary technology program" means a school of veterinary
15	technology or a veterinary technology education program that has been approved
16	by the board as meeting its administrative standards;
17	(14) "Background check" means an inquiry within a system for the collection,
18	processing, preservation, or dissemination of criminal history records maintained
19	by one (1) or more local, state, or federal agencies;
20	(15) "Board" means the Kentucky Board of Veterinary Examiners;
21	(16) "Certificate holder" means a person certified by the board;
22	(17) "Certified animal control agency" means an animal shelter that is certified by
23	the board;
24	(18) "Certified animal euthanasia specialist" means a person employed by a certified
25	animal control agency who is authorized by the board to humanely euthanize
26	animals by administering drugs designated by the board for euthanasia and
2.7	sedation including animals owned by the certified animal control agency or

1	animals in emergency care circumstances;
2	(19) "Chemical restraint" means the use of any controlled substance, veterinary drug,
3	prescription, veterinary prescription drug, or legend drug that restrains or
4	tranquilizes the animal;
5	(20) "Client" means the owner, owner's agent, or other person presenting the patient
6	for care, who has entered into an agreement with a veterinarian or allied animal
7	health professional on behalf of a patient for the purposes of obtaining veterinary
8	medical services or allied animal health professional services in person or by any
9	means of communication or telehealth;
10	(21) "Compensation" includes any gift, bonus, fee, money, credit, or other thing of
11	<u>value;</u>
12	(22) ''Complementary and alternative veterinary medicine therapies'' means a
13	heterogeneous group of preventive, diagnostic, and therapeutic philosophies and
14	practices that are not considered part of conventional veterinary medicine. These
15	therapies include but are not limited to:
16	(a) Veterinary acupuncture, acutherapy, and acupressure;
17	(b) Veterinary homeopathy;
18	(c) Veterinary manual or manipulative therapy, such as therapies based on
19	techniques practiced in osteopathy, chiropractic medicine, or physical

23	(23) "Consultation" means a veterinarian's receipt of advice, assistance in person, or

26	responsibility for the welfare of the patient remains with the veterinarian
27	receiving consultation;

1	(24) "Continuing education" means training that is designed to ensure continued
2	competence in the practice of veterinary medicine, veterinary technology, or for
3	certified animal euthanasia specialists, permitted allied animal health
4	professionals, or any board credential holder;
5	(25) "Continuing education contact hour" means a fifty (50) minute clock hour of
6	instruction, not including breaks or meals;
7	(26) "Conviction" means a formal declaration that someone is guilty of a crime by a
8	court of competent jurisdiction and shall include a finding or verdict of guilt, an
9	admission of guilt, a no contest plea, a plea of nolo contendere, or a guilty plea;
10	(27) "Credential" means:
11	(a) Any license, certificate, permit, registration, or other credential issued or
12	approved by the board; or
13	(b) The authorization to serve as the veterinarian manager or registered
14	responsible party designated on a veterinary facility registration, as the
15	AAHP manager or registered responsible party designated on an AAHP
16	facility registration, or as the designated on-site manager designated for a
17	certified animal control agency;
18	(28) "Credential holder" means a person who holds an approved credential issued by
19	the board, which may be one (1) or more of the following:
20	(a) Certificate;
21	(b) License;
22	(c) Permit;
23	(d) Registration; or
24	(e) Special permit;
25	(29) "Designated on-site manager" means a person who registers with the board to
26	assume responsibility for the ordering, management, use, and disposal of
2.7	controlled substances at a certified animal control agency:

1	(30) "Discipline" means any final order, settlement agreement, reprimand, fine, or
2	other adverse consequence assessed against a person by the board or any of its
3	counterparts in other jurisdictions;
4	(31) "Embryo transfer" means to remove an embryo from any animal for the purpose
5	of transplanting the embryo into another animal, cryopreserving the embryo, or
6	implanting the embryo into any animal, including food and companion animals;
7	(32) "Emergency care" means immediate treatment that is necessary to sustain life or
8	end suffering of an animal that is in a life-threatening condition;
9	(33) "Examination" means a qualifying examination approved by the board as a
10	condition for certification, licensure, permit, or registration;
11	(34) "Expired" is a licensure status whereby the credential holder failed to renew the
12	credential in a timely manner in accordance with the deadline set by the board;
13	(35) "Extralabel use" means actual use or intended use of a drug in an animal in a
14	manner that is not in accordance with the approved labeling and includes but is
15	not limited to:
16	(a) Use in species or production class not listed in the labeling;
17	(b) Use for indications such as disease or other conditions not listed in the
18	<u>labeling;</u>
19	(c) Use at dosage levels, frequencies, or routes of administration other than
20	those stated in the labeling; and
21	(d) Deviation from the labeled withdrawal time based on these different uses;
22	(36) "Felony" means a criminal act as defined by any jurisdiction or by definition
23	under federal law;
24	(37) "Fixed facility" means a permanent location that is generally not moveable;
25	(38) "Grievance" or "complaint" means any allegation of misconduct that may
26	constitute a violation of this chapter or any administrative regulation
27	promulgated under the authority of this chapter;

1	(39) "Impaired" means that a credential holder, designated on-site manager,
2	veterinarian manager, AAHP manager, or registered responsible party may
3	reasonably be unable to perform that person's duties with competence, skill, and
4	safety because of a physical or mental disability or incapacity, including
5	deterioration of mental capacity, loss of motor skills, or substance use or disorder
6	of sufficient degree which may reasonably diminish the person's ability to deliver
7	competent patient care;
8	(40) "In-person" means physically in the same physical space;
9	(41) "Informed consent" or "consent" means the veterinarian or allied animal health
10	professional permittee has informed the client or the client's authorized
11	representative in a manner understood by the client or the client's authorized
12	representative of the diagnostic and treatment options, potential outcomes, risk
13	assessment, prognosis, and options and the client has consented to or knowingly
14	declined the recommended services or treatment;
15	(42) "Jurisdiction" means:
16	(a) Any Commonwealth, state, or territory of the United States of America,
17	including the District of Columbia;
18	(b) Any province of Canada; or
19	(c) A regulatory organization, including an international body;
20	that issues licenses, registrations, permits, or certificates related to the
21	professional fields of veterinary medicine;
22	(43) "Licensee" means a person licensed by the board under this chapter;
23	(44) "Livestock" means bovines, equines, sheep, goats, swine, poultry, captured or
24	cultivated aquatic species, farm-raised cervidae and camelidae, bees, and any
25	other species used in the production of fiber, meat, eggs, honey, milk, and other
26	animal food products;
27	(45) "Mobile facility" or "mobile unit" means a motor vehicle that is utilized

1	prevention of disease in a patient;
2	(53) "Registrant" means a person or premises registered with the board under this
3	<u>chapter;</u>
4	(54) "Registered allied animal health professional facility" or "registered AAHP
5	facility" means an AAHP facility that is registered with the board;
6	(55) "Registered facility" means any AAHP facility or any veterinary facility that is
7	registered with the board;
8	(56) "Registered responsible party" means at least one (1) person who:

24	pursuant to currently acceptable standards of care;
25	(b) "Immediate supervision" means the supervising veterinarian is physically
26	in the immediate area and within audible and visual range of the patient

1	(c) "Direct supervision" means the supervising veterinarian is readily available
2	on the premises where the patient is being treated; and
3	(d) "Indirect supervision" means the supervising veterinarian need not be on
4	the premises but has given either written or oral instructions for the
5	treatment of the patient and is readily available for communication;
6	(59) "Teleadvice" means the provision of any health information, opinion, guidance,
7	or recommendation concerning prudent future actions that are not specific to a
8	particular patient's health, illness, or injury;
9	(60) "Teleconsulting" means telehealth in which a veterinarian, veterinary
10	technician, AAHP, or other credential holder uses telehealth tools to
11	communicate with a specialist or another professional to gain insights and advice
12	on the care of a patient;
13	(61) "Telehealth" means all uses of technology to remotely gather and deliver health
14	information, advice, education, and care;
15	(62) "Telemedicine" or "connected care" means the integration of digital
16	technologies to enhance and support the VCPR and facilitate proactive and
17	ongoing care through improved communication, diagnosis, and monitoring;
18	(63) "Telemonitoring," or "mHealth" or "mobile health," means remote monitoring
19	of a patient who is not at the same location as the health care provider;
20	(64) "Telesupervision" means the supervision of individuals using media such as
21	audio or audio/video conference, text messaging, and e-mail;
22	(65) "Teletriage" means the safe, appropriate, and timely assessment and
23	management of an animal patient via electronic consultation with its owner,
24	regardless of whether there is an immediate referral to a veterinarian and where
25	a diagnosis is not rendered;
26	(66) "Veterinarian" means an individual who is licensed to engage in the practice of
27	veterinary medicine under this chapter;

I	(67) "Veterinarian manager" means at least one (1) Kentucky-licensed veterinarian
2	who registers to assume responsibility for the registration, management, and
3	operation of a registered veterinary facility;
4	(68) "Veterinarian-client-patient relationship" or "VCPR" has the same meaning as
5	in Section 10 of this Act;
6	(69) "Veterinary assistant" means a layperson or noncredential holder who is
7	employed by a veterinarian in accordance with Section 29 of this Act;
8	(70) (a) "Veterinary facility" means any building, fixed facility, place, premises,
9	mobile facility, or mobile unit location from which the practice of veterinary
10	medicine and practice of veterinary technology are conducted or performed,
11	including but not limited to a mobile clinic or facility, outpatient clinic,
12	veterinary hospital or clinic, emergency facility, specialty facility, referral
13	facility or center, temporary health clinic, or spay/neuter location. A
14	veterinary facility shall include all fixed buildings used for the practice of
15	veterinary medicine at a single physical premises location.
16	(b) "Veterinary facility" does not include:
17	1. The premises of a veterinary client unless a fixed veterinary facility is
18	located on the veterinary client's premises;
19	2. A research facility;
20	3. A federal military base;
21	4. Locations for temporary animal exhibition;
22	5. State or federal regulatory facilities;
23	6. Officially designated emergency and disaster response locations;
24	7. A facility with current accreditation by the Association of Zoos and
25	Aquariums; or
26	8. An American Veterinary Medical Association-accredited college of
27	veterinary medicine or veterinary technology;

1	(71) "Veterinary specialist" means a veterinarian that has been awarded and
2	maintains certification from an American Veterinary Medical Association-
3	recognized veterinary specialty organization, program, or college, and is
4	registered in this specialty with the board;
5	(72) "Veterinary student" means:
6	(a) A person enrolled in an approved veterinary medical program while
7	pursuing a degree in veterinary medicine; or
8	(b) A person in a post-Doctor of Veterinary Medicine temporary private
9	internship, residency, or veterinary hospital-based program, not to exceed
10	thirty (30) days in a calendar year;
11	(73) "Veterinary technician" means a person who has completed an approved
12	veterinary technology program, is licensed in accordance with this chapter, and
13	meets the requirements in Section 28 of this Act;
14	(74) "Veterinary wellness committee" means a committee appointed by the board that
15	is composed of individuals who have expertise in the areas of alcohol abuse,
16	chemical dependence, drug abuse, or physical or mental condition designated by
17	the board to perform activities related to the veterinary wellness program; and
18	(75) "Veterinary wellness program" means the board-sponsored program for the
19	identification, intervention, and monitoring of credential holders or applicants

23	READ AS FOLLOWS:
24	Telehealth shall be authorized for veterinary practice. Telehealth is divided into
25	categories based on who is involved in the communication. For communication
26	between veterinarians and other persons, there are distinctions in practice related to
27	whether a VCPR as set forth in Section 10 of this Act has been established with the

1	patient.	Different types of veterinary telehealth include the following:
2	(1) Te	lemonitoring, mHealth, or mobile health applications and wearables which
3	are	<u>":</u>
4	<u>(a)</u>	Designed to augment animal health care within VCPRs; or
5	<u>(b)</u>	Designed and marketed directly to consumers for their education and for
6		animal monitoring without clinical input and outside the context of a
7		<u>VCPR;</u>
8	(2) Te	lesupervision, which shall be permitted as a part of telehealth practice;
9	(3) Tel	lemedicine or connected care, which provides the delivery of information
10	spe	ecific to a particular patient and shall be conducted within the context of an
11	est	ablished VCPR to ensure protection for the patient, subject to the following:
12	<u>(a)</u>	Telemedicine or connected care is an approach to veterinary practice that is
13		patient- and client-centered, and actively engages the entire veterinary
14		healthcare team. This type of telehealth involves use of one (1) or more tools
15		to exchange medical information electronically from one (1) site to another
16		to improve a patient's clinical health status, which may be utilized to
17		augment the practice of veterinary medicine. The appropriate application of
18		connected care or telemedicine can enhance animal care by facilitating
19		communication, diagnostics, treatments, client education, scheduling, and
20		other tasks;
21	<u>(b)</u>	Practitioners providing telemedicine or connected care to patients in the
22		Commonwealth shall be credentialed to practice by the board and operate in
23		association with a registered veterinary facility or registered allied animal
24		health professional facility in Kentucky. Practitioners practicing this type of
25		telemedicine shall comply with all state and federal statutes and regulations,
26		including requirements for access to follow-up care; and
27	<u>(c)</u>	Telemedicine or connected care provided to patients in Kentucky shall only

1	be conducted within an existing VCPR as set forth in Section 10 of this Act
2	and is required to be reestablished through an in-person visit every twelve
3	(12) months, with the exception of advice given in an emergency care
4	situation or teletriage until a patient can be seen by or transported to a
5	veterinarian. The VCPR for that twelve (12) months shall be deemed to
6	constitute a relationship in Kentucky, regardless of whether the patient or
7	client travels outside the Commonwealth; and
8	(4) Telehealth conducted without a VCPR, which may include only the delivery of
9	general advice, educational information, and teletriage. Telehealth which may be
10	conducted without a VCPR includes:
11	(a) Teleadvice, which is general advice that is not intended to diagnose,
12	prognose, treat, correct, change, alleviate, or prevent animal disease, illness,
13	pain, deformity, defect, injury, or other physical, dental, or mental
14	conditions. If the practitioner providing the teleadvice is a qualified
15	veterinarian, veterinary technician, allied animal health professional, or
16	other board credential holder, the practitioner shall be required to hold a
17	valid credential from the Kentucky board, except as authorized by Section
18	14 of this Act, shall comply with all state and federal statutes and
19	regulations, and shall disclose the practitioner's name and Kentucky
20	credential number to the person receiving services;
21	(b) Teleconsulting, in which the established VCPR remains with the
22	veterinarian seeking advice or counsel; and
23	(c) Teletriage, when in assessing patient condition electronically, the assessor
24	determines urgency and the need for immediate referral to a veterinarian,
25	based on the owner's or responsible party's report of history and clinical
26	signs, sometimes supplemented by visual information, such as photographs
27	or video. Practitioners providing teletriage to patients in the Commonwealth

1	shall be credentialed to practice by the board in Kentucky, shall comply with
2	all state and federal statutes and regulations, and shall disclose the
3	practitioner's name and Kentucky credential number to the person receiving
4	services.
5	→SECTION 4. A NEW SECTION OF KRS CHAPTER 321 IS CREATED TO
6	READ AS FOLLOWS:
7	(1) Each veterinarian or AAHP who provides medical services to animals shall
8	maintain accurate electronic or legibly written medical records that include the
9	identity of the credential holder or authorized representative who makes the
10	entry.
11	(2) The information in the medical records are the property of the client, and the
12	client has a right to a copy of those records. The practice where the records were
13	prepared shall be the official records custodian. Original patient records shall be
14	retained by the practice, veterinarian, or AAHP who prepared them and be
15	readily retrievable for a period of five (5) years following the last patien
16	encounter. Records shall not be stored by a third party without a record of signed
17	informed consent by the client. Records stored by a third party shall not relieve
18	the veterinarian or AAHP from the responsibility of supplying records to the
19	client upon request.
20	(3) (a) The veterinarian or AAHP may require that a request for medical records
21	be in writing and may charge a reasonable fee for copying or the staff time
22	in preparing the requested medical records, unless there is a board
23	investigation, in which case no charges shall be authorized.
24	(b) Copies of the medical records shall be provided to the client, designated
25	veterinarian, AAHP permittee, or authorized representative within seven (7)
26	calendar days after receipt of a proper request or sooner in accordance with
27	the patient's medical condition.

1	(c) Failure to provide the medical records in a timely fashion upon proper
2	request shall be considered unprofessional conduct.
3	(4) All records required by law to be kept by a veterinarian or AAHP shall be open to
4	inspection by the board or its authorized representatives, and a copy shall be
5	provided immediately upon request.
6	(5) All records shall comply with the requirements set forth by the board in
7	administrative regulations.
8	(6) An animal patient's medical record and medical condition is confidential and
9	may not be furnished to or discussed with any person other than the client or
10	other veterinarians, veterinary technicians, veterinary assistants, veterinary
11	practice staff, AAHP permittees, or consultants involved in the care or treatment
12	of the patient, except upon authorization of the client or under the following
13	circumstances:
14	(a) Access to the records is specifically required by law, or as described in
15	Sections 10 and 11 of this Act;
16	(b) In response to a court order or subpoena with notice given to the client or
17	the client's legal representative;
18	(c) For statistical and scientific research, if the information is abstracted in a
19	way as to protect the identity of the patient and client;
20	(d) As part of an inspection or investigation conducted by the board or an agent
21	of the board;
22	(e) To verify the rabies vaccination status of an animal;
23	(f) In the course of a consultation; and
24	(g) As required by other state or federal law.
25	(7) A veterinarian or AAHP shall not intentionally create a false record, make a false
26	statement, or alter or modify any medical record, document, or report concerning
27	treatment of a patient. When correcting a medical record, the original content

1		should be readable, and the alteration shall be clearly identified with the
2		correction, reason for correction, date, and author's name.
3		→SECTION 5. A NEW SECTION OF KRS CHAPTER 321 IS CREATED TO
4	REA	AD AS FOLLOWS:
5	<u>(1)</u>	Each person who is licensed as a veterinary technician shall submit a completed
6		renewal application by the renewal deadline and pay to the board an annual
7		renewal fee for the renewal of the person's license.

9		which time individuals may renew their licenses upon submission of a completed

16		technician license may have their licenses reinstated upon submission of a
17		completed reinstatement application and payment of a reinstatement fee to the
18		board. No person who applies for reinstatement after expiration of the person's
19		license shall be required to submit to an examination as a condition for
20		reinstatement if a reinstatement application is made within five (5) years from the
21		date of expiration.
22	<u>(4)</u>	A suspended license is subject to expiration and termination and shall be renewed
23		as provided in this chapter. Renewal or reinstatement shall not entitle the licensee
24		to engage in the practice until the suspension has ended or is otherwise removed
25		by the board and the right to practice is restored by the board.
26	<u>(5)</u>	A revoked license is subject to expiration or termination but may not be renewed.
27		If it is reinstated, the licensee shall pay the reinstatement fee.

1	<u>(6)</u>	A person who fails to reinstate a license within five (5) years after its expiration
2		or termination may not have it renewed, restored, reissued, or reinstated. A
3		person may apply for and obtain a new license by meeting the requirements of

5	<u>(7)</u>	The board may require that a person applying for renewal or reinstatement of
6		licensure show evidence of completion of continuing education as established in
7		administrative regulations promulgated in accordance with KRS Chapter 13A.
8	<u>(8)</u>	The board may grant retired or inactive licensure status and may establish
9		conditions under which retired or inactive licenses may be renewed as established
10		in administrative regulations promulgated in accordance with KRS Chapter 13A.
11		→ SECTION 6. A NEW SECTION OF KRS CHAPTER 321 IS CREATED TO
12	REA	AD AS FOLLOWS:
13	<u>(1)</u>	Each person who is certified as an animal euthanasia specialist shall submit a
14		complete renewal application by the renewal deadline and pay to the board an
15		annual renewal fee for the renewal of the person's certificate.

4		expiration. Animal control agencies may be subject to inspection prior to
5		reinstatement.
6	<u>(5)</u>	A suspended certificate is subject to expiration and termination and shall be
7		renewed as provided in this chapter. Renewal or reinstatement shall not entitle
8		the certificate holder to engage in the practice until the suspension has ended or
9		is otherwise removed by the board and the right to practice is restored by the

11	<u>(6)</u>	A revoked certificate is subject to expiration or termination but may not be
12		renewed. If it is reinstated, the certificate holder shall pay the reinstatement fee.

When in the judgment of the board, an alleged violation is not of a serious nature, (3) and the evidence presented to the board after the investigation and appropriate opportunity for the *credential holder* [licensee] to respond, provides a clear indication that the alleged violation did in fact occur, the board may issue a written reprimand to the *credential holder* [licensee]. A copy of the reprimand shall be placed in the permanent file of the credential holder[licensee]. The credential **holder**[licensee] shall have the right to file a response to the reprimand within thirty (30) days of its receipt and to have the response placed in the permanent licensure file. The *credential holder*[licensee] may alternatively, within thirty (30) days of the receipt, file a request for hearing with the board.
