1	AN ACT relating to school bus safety.
2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
4	READ AS FOLLOWS:
5	As used in Sections 1 to 6 of this Act, unless the context requires otherwise:
6	(1) "Camera monitoring system" means a system with one (1) or more camera
7	sensors and computers installed and operated on a school bus that:
8	(a) Produces recorded images; and
9	(b) Records the activation status of the stop arm and time, date, and location of
10	the motor vehicle when the recorded image or video is captured;
11	(2) "Code enforcement board" has the same meaning as in KRS 65.8805;
12	(3) "County" means a county, urban-county, consolidated local government, unified
13	local government, or charter county;
14	(4) "Owner" has the same meaning as in KRS 186.010;
15	(5) "Recorded images" means two (2) or more photographic images or a segment of
16	any video medium recorded by a camera monitoring system which show on at
17	least one (1) image or portion of video the registration plate number of a motor
18	vehicle being operated in violation of subsection (1) of Section 8 of this Act; and
19	(6) "Stop arm camera violation" means a violation of subsection (1) of Section 8 of
20	this Act recorded by a camera monitoring system and enforced in accordance
21	with an ordinance adopted by a county.
22	→SECTION 2. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
23	READ AS FOLLOWS:
24	The legislative body of a county may:
25	(1) Authorize, by ordinance:
26	(a) A local school district to:
27	1. Install and maintain a camera monitoring system in or on the school

1	buses operated by a school district for the purpose of recording
2	violations of subsection (1) of Section 8 of this Act; or
3	2. Contract with a private vendor to do so on behalf of the school district
4	<u>and</u>
5	(b) Enforcement of a civil penalty against the owner of a motor vehicle for a
6	stop arm camera violation; and
7	(2) Enter into an interlocal agreement in accordance with KRS 65.210 to 65.300 for
8	the purposes of implementing and enforcing an ordinance enacted in accordance
9	with subsection (1) of this section, with a requirement that a stop arm camera
10	violation shall be enforced by a law enforcement authority.
11	→SECTION 3. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
12	READ AS FOLLOWS:
13	(1) The amount of a civil penalty for a stop arm camera violation shall be set by the
14	legislative body of the county but shall not exceed:
15	(a) Three hundred dollars (\$300) for the first civil penalty; and
16	(b) Five hundred dollars (\$500) for each subsequent civil penalty issued to an
17	owner within a three (3) year period.
18	(2) All revenue generated from a civil penalty for stop arm camera violations shall be
19	retained by the county, unless the fine is collected as a result of action taken in
20	the Court of Justice in which court costs may be deducted from the amount paid
21	to the county.
22	(3) A stop arm camera violation shall not result in points being assessed against the
23	driving record of the owner or operator of the vehicle in violation.
24	→SECTION 4. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
25	READ AS FOLLOWS:
26	(1) An ordinance adopted pursuant to Section 2 of this Act shall specify by whom the
27	following documents shall be sent by certified mail to the owner of a motor

1		vehicle within thirty (30) days of a stop arm camera violation:
2		(a) The stop arm camera form as described in subsection (2) of this section;
3		(b) A copy of the recorded images for the stop arm camera violation; and
4		(c) A signed, sworn statement from a law enforcement officer that, based on
5		inspection of recorded images, the motor vehicle was being operated in
6		violation of subsection (1) of Section 8 of this Act. This statement may be
7		admissible in any proceeding challenging a stop arm camera violation.
8	<u>(2)</u>	The form of a stop arm camera violation shall be designated by the legislative
9		body of the county, but shall contain in substance the following information:
10		(a) The name and address of the registered owner of the vehicle;
11		(b) A statement that the notice represents a determination that a stop arm
12		camera violation has been committed by the owner of the vehicle and that
13		the determination shall be final unless contested in accordance with Section
14		5 of this Act;
15		(c) The date and time of the violation;
16		(d) The location of the violation;
17		(e) The amount of the civil penalty imposed and the date by which the civil
18		penalty shall be paid;
19		(f) Instructions on how to pay the civil penalty;
20		(g) Information advising the owner as to the manner and time in which the
21		uniform civil citation may be contested; and
22		(h) A warning that failure to pay the civil penalty imposed or to contest the
23		matter in a timely manner is an admission of liability and shall result in the
24		suspension of the motor vehicle's registration.
25		→ SECTION 5. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
26	REA	AD AS FOLLOWS:
27	<i>(1)</i>	In a contest to a stop arm camera violation, it shall be a defense that:

1	<u>(a)</u>	The motor vehicle or the motor vehicle registration plates were stolen before
2		the violation occurred and were not under the control or possession of the
3		owner at the time of the violation;
4	<u>(b)</u>	The ordinance is not enforceable because at the time and place of the
5		violation the stop arm was not extended or the signal lights were not
6		activated so as to be seen by an ordinarily observant individual;
7	<u>(c)</u>	The owner was not operating the vehicle at the time of the violation. An
8		owner who uses this defense shall identify who was operating the vehicle at
9		the time of the violation, including, at a minimum, the operator's name and
10		address; or
11	<u>(d)</u>	The person operating the motor vehicle received a citation from a law
12		enforcement officer for a violation of subsection (1) of Section 8 of this Act
13		at the date and approximate time listed on the stop arm camera violation
14		<u>form.</u>
15	(2) (a)	In a county with a code enforcement board, a contest to a stop arm camera
16		violation shall be conducted in accordance with KRS 65.8825, 65.8828,
17		65.8829, and 65.88.8831, except notwithstanding KRS 65.8828(4), when a
18		board determines that a violation has been committed, the board shall issue
19		an order upholding the citation and shall order the offender to pay the civil
20		penalty in full.
21	<u>(b)</u>	In a county without a code enforcement board, a contest to a stop arm
22		camera violation shall be heard by the District Court, and the legislative
23		body of the county shall direct the county attorney to defend the stop arm
24		camera violation in the in accordance with KRS 69.210(1).
25	<b>→</b> Si	ECTION 6. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO
26	READ AS	S FOLLOWS:
27	(1) If $a$	stop arm camera violation is not paid or contested in accordance with Section

1	5 of this Act within sixty (60) days, the county may notify the Transportation
2	Cabinet of the nonpayment. Upon notice of nonpayment, the cabinet shall
3	suspend the registration of a motor vehicle until the civil penalty is paid.

Any 22 person who violates paragraph (c) of subsection (5) of KRS 189.390 shall be fined 23 not less than eleven dollars (\$11) nor more than thirty dollars (\$30). Neither court 24 costs nor fees shall be taxed against any person violating paragraph (c) of subsection (5) of KRS 189.390. 25
- 26 (2) (a) Any person who violates the weight provisions of KRS 189.212, 189.221, 189.222, 189.226, 189.230, 189.270, or 189.2713 shall be fined two cents

(\$0.02) per pound for each pound of excess load when the excess is five thousand (5,000) pounds or less. When the excess exceeds five thousand (5,000) pounds the fine shall be two cents (\$0.02) per pound for each pound of excess load, but the fine levied shall not be less than one hundred dollars (\$100) and shall not be more than five hundred dollars (\$500).

- (b) Any person who violates the provisions of KRS 189.271 and is operating on a route designated on the permit shall be fined one hundred dollars (\$100); otherwise, the penalties in paragraph (a) of this subsection shall apply.

  - 2. Any person who operates a vehicle with a permit under KRS 177.985 in excess of eighty thousand (80,000) pounds while operating on a route not designated in KRS 177.986 shall be fined one thousand dollars (\$1,000).
- (e) Nothing in this subsection or in KRS 189.221 to 189.228 shall be deemed to prejudice or affect the authority of the Department of Vehicle Regulation to suspend or revoke certificates of common carriers, permits of contract carriers, or drivers' or chauffeurs' licenses, for any violation of KRS 189.221 to 189.228 or any other act applicable to motor vehicles, as provided by law.
- 26 (3) (a) Any person who violates subsection (1) of KRS 189.190 shall be fined not more than fifteen dollars (\$15).

1	(b)	Any person who violates subsection (5) of KRS 189.190 shall be fined not
2		less than thirty-five dollars (\$35) nor more than two hundred dollars (\$200).

- 3 (4) Any person who violates subsection (1) of KRS 189.210 shall be fined not (a) 4 less than twenty-five dollars (\$25) nor more than one hundred dollars (\$100).
- 5 (b) Any peace officer who fails, when properly informed, to enforce KRS 189.210 6 shall be fined not less than twenty-five dollars (\$25) nor more than one 7 hundred dollars (\$100).

- All fines collected under this subsection, after payment of commissions to officers entitled thereto, shall go to the county road fund if the offense is committed in the county, or to the city street fund if committed in the city.
- (5) Any person who violates KRS 189.370 shall for the first offense be fined not less 12 than one hundred dollars (\$100) nor more than three[two] hundred dollars 13 (\$300)[(\\$200)] or imprisoned not less than thirty (30) days nor more than sixty (60) 14 days, or both. For each subsequent offense occurring within three (3) years, the 15 person shall be fined not less than three hundred dollars (\$300) nor more than five 16 hundred dollars (\$500) or imprisoned not less than sixty (60) days nor more than six 17 (6) months, or both. 12	(13)	Any person who violates any of the provisions of KRS 189.120 shall be fined not
13		less than twenty dollars (\$20) nor more than one hundred dollars (\$100) for each
14		offense.
15	(14)	Any person who violates any provision of KRS 189.575 shall be fined not less than
16		twenty dollars (\$20) nor more than twenty-five dollars (\$25).
17	(15)	Any person who violates subsection (2) of KRS 189.231 shall be fined not less than
18		twenty dollars (\$20) nor more than one hundred dollars (\$100) for each offense.

- 24 (17) (a) Any person who violates any of the provisions of KRS 189.565 shall be guilty of a Class B misdemeanor.
- 26 (b) In addition to the penalties prescribed in paragraph (a) of this subsection, in 27 case of violation by any person in whose name the vehicle used in the

5		three (3) consecutive days shall be fined not less than thirty-five dollars (\$35) nor

8	(19)	Every person violating KRS 189.393 shall be guilty of a Class B misdemeanor,

subsection (2) or (3) of KRS 189.459 shall be collected and disposed of in
accordance with KRS 24A.180. Once deposited into the State Treasury, ninety
percent (90%) of the fine collected under this subsection shall immediately be
forwarded to the personal care assistance program under KRS 205.900 to 205.920.
Ten percent (10%) of the fine collected under this subsection shall annually be
returned to the county where the violation occurred and distributed equally to all
law enforcement agencies within the county.

- 12 If any school or church bus used in the transportation of children is stopped upon a (1) 13 highway for the purpose of receiving or discharging passengers, with the stop arm 14 and signal lights activated, the operator of a vehicle approaching from any direction 15 shall bring his vehicle to a stop and shall not proceed until the bus has completed 16 receiving or discharging passengers and has been put into motion. The stop 17 requirement provided for in this section shall not apply to vehicles approaching a 18 stopped bus from the opposite direction upon a highway of four (4) or more lanes 19 divided by an elevated barrier or unpaved median.
- 20 (2) Subsection (1) of this section shall be applicable only when the bus displays the markings and equipment required by Kentucky minimum specifications for school buses.
  - (3) If any vehicle is witnessed to be in violation of subsection (1) of this section and the identity of the operator is not otherwise apparent, it shall be a rebuttable presumption that the person in whose name the vehicle is registered or leased was the operator of the vehicle at the time of the alleged violation and is subject to the penalties as provided for in KRS 189.990(5).
