6	<u>(1)</u>	(a) As used in this section, "durable medical equipment" means equipment,
7		including repair and replacement parts for that equipment, which:
8		1. Can withstand repeated use;
9		2. Is primarily and customarily used to serve a medical purpose;
10		3. Generally is not useful to a person in the absence of an illness or
11		injury; and
12		4. Is appropriate for use in the home.
13		(b) As used in this subsection, "repair and replacement parts" includes all
14		components or attachments used in connection with durable medical
15		equipment.
16	<u>(2)</u>	The Department for Medicaid Services shall reimburse a supplier of durable
17		medical equipment, prosthetics, orthotics, and supplies at no less than one
18		hundred percent (100%) of the state Medicaid program durable medical
19		equipment fee schedule and shall require Medicaid managed care organizations
20		to reimburse the same amount as the Department for Medicaid Services
21		reimburses for the same service or item of durable medical equipment,
22		prosthetics, orthotics, and supplies.
23	<u>(3)</u>	For any claims in which the department or Medicaid managed care organization
24		has given prior authorization, prepayment or postpayment review or recoupment
25		shall not include review for medical necessity for the previously approved
26		equipment, supplies, and services.
2.7	(4)	The department shall promulgate an administrative regulation to ensure that

1		once prior service authorization is granted by a Medicaid managed care
2		organization or fee for service plan, continued authorization of the equipment,
3		supplies, or services continues at a minimum for the same amount, duration, and
4		scope until the end of the authorization period as previously granted by either
5		another Medicaid managed care organization or fee for service plan.
6	<u>(5)</u>	The department shall require Medicaid managed care organizations to reimburse
7		suppliers of durable medical equipment, prosthetics, orthotics, and supplies for
8		manually priced items in the Medicaid program durable medical equipment fee
9		schedule at the manufacturer's suggested retail price minus fifteen percent (15%)
10		pricing where there is a manufacturer's suggested retail price, and at invoice
11		price plus twenty percent (20%) for miscellaneous Healthcare Common
12		Procedure Coding System codes where there is no manufacturer's suggested
13		retail price.
14	<u>(6)</u>	The department shall require Medicaid managed care organizations to cover, at a
15		minimum, the same Healthcare Common Procedure Coding System codes and
16		the same quantities of medical supplies, equipment, or services as are established
17		on the Kentucky Medicaid program durable medical equipment fee schedule or
18		Kentucky Medicaid medical policy.
19	<u>(7)</u>	The department shall ensure that the allowable timeframe for claim submissions
20		by suppliers of durable medical equipment, prosthetics, orthotics, and supplies
21		shall equal the timeframe allowed for any discrepancy during the Medicaid
22		managed care organization audit or recoupment process for that claim.
23	<u>(8)</u>	Medical necessity criteria shall be made available to suppliers of durable medical
24		equipment, prosthetics, orthotics, and supplies at no cost.
