

1 AN ACT relating to the Kentucky Economic Development Partnership and  
2 declaring an emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 154.10-050 is amended to read as follows:

- 5 (1) The secretary shall be the chief executive officer of the Cabinet for Economic  
6 Development and shall possess the professional qualifications appropriate for that  
7 office as determined by the board.
- 8 (2) The board shall set the salary of the secretary ***and up to two (2) additional***  
9 ***executive officers of the cabinet as determined by the board,*** which shall be  
10 exempt from state employee salary limitations as set forth in KRS 64.640. ***No***  
11 ***executive officer of the cabinet shall be paid a salary greater than that of the***  
12 ***secretary.***
- 13 (3) The secretary shall be responsible for the day-to-day operations of the cabinet and  
14 shall report and submit on an annual basis implementation plans to the board as  
15 provided in KRS 154.10-060; submit the strategic plan for economic development  
16 to the board in accordance with the provisions of KRS 154.10-120 and 154.10-125;  
17 submit program evaluation reports to the board in accordance with the provisions of  
18 KRS 154.10-140; carry out policy and program directives of the board; coordinate  
19 programs of the cabinet with all other agencies of state government having  
20 economic development responsibilities; hire all other personnel of the cabinet  
21 consistent with state law; and carry out all other duties and responsibilities assigned  
22 by state law.
- 23 (4) The secretary shall prepare and submit the proposed budget of the cabinet to the  
24 chairman who shall present it to the board for final approval. Upon approval, the  
25 board shall submit the proposed budget to the Governor's Office for Policy and  
26 Management.
- 27 (5) The secretary shall be reimbursed for all actual and necessary expenses incurred in

1 the performance of all assigned duties and responsibilities.

2 (6) The secretary shall give highest priority consideration in marketing, targeting, and  
3 recruiting new businesses, in expanding existing businesses, and in recommending  
4 state economic development loans, grants, and incentive programs administered by  
5 the authority, to Kentucky counties which have had an average countywide rate of  
6 unemployment of fifteen percent (15%) or greater in the most recent twelve (12)  
7 consecutive months for which unemployment figures are available, on the basis of  
8 the final unemployment figures calculated by the Office of Employment and  
9 Training within the Department of Workforce Investment within the Education and  
10 Workforce Development Cabinet.

11 ➔Section 2. Whereas it is critical to the economy and citizens of Kentucky to  
12 maintain appropriate staffing for the Cabinet for Economic Development at the executive  
13 level and to fill those positions as soon as possible in order to attract new business and  
14 investment to the Commonwealth, an emergency is declared to exist, and this Act takes  
15 effect upon its passage and approval by the Governor or upon its otherwise becoming  
16 law.
