

1 AN ACT relating to cancer detection in firefighters, and making an appropriation  
2 therefor.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 95A.262 is amended to read as follows:

5 (1) The Kentucky Fire Commission shall, in cooperation with the Cabinet for Health  
6 and Family Services, develop and implement a continuing program to inoculate  
7 every paid and volunteer firefighter in Kentucky against hepatitis A and B. The  
8 program shall be funded from revenues allocated to the Firefighters Foundation  
9 Program fund pursuant to KRS 136.392 and 42.190, not to exceed five hundred  
10 thousand dollars (\$500,000) per fiscal year.

11 (2) (a) Except as provided in subsection (3) of this section, the Kentucky Fire  
12 Commission shall allot on an annual basis a share of the funds accruing to and  
13 appropriated for volunteer fire department aid to volunteer fire departments in  
14 cities of all classes, fire protection districts organized pursuant to KRS  
15 Chapter 75, county districts established under authority of KRS 67.083, and  
16 volunteer fire departments created as nonprofit corporations pursuant to KRS  
17 Chapter 273.

18 (b) The commission shall allot eleven thousand dollars (\$11,000) annually to  
19 each qualifying department.

20 (c) Any qualifying department which fails to participate satisfactorily in the  
21 Kentucky fire incident reporting system as described in KRS 304.13-380 shall  
22 forfeit annually five hundred dollars (\$500) of its allotment.

23 (d) If two (2) or more qualified volunteer fire departments, as defined in KRS  
24 95A.500 to 95A.560, merge after January 1, 2000, then the allotment shall be  
25 in accordance with the provisions of KRS 95A.500 to 95A.560.

26 (e) Administrative regulations for determining qualifications shall be based on  
27 the number of both paid firefighters and volunteer firemen within a volunteer

1 fire department, the amount of equipment, housing facilities available, and  
2 any other matters or standards that will best effect the purposes of the  
3 volunteer fire department aid law. A qualifying department shall:

- 4 1. Include at least twelve (12) firefighters;
- 5 2. Have a chief;
- 6 3. Have at least one (1) operational fire apparatus or one (1) on order; and
- 7 4. Have at least fifty percent (50%) of its firefighters who have completed  
8 at least one-half (1/2) of one hundred fifty (150) training hours, or as  
9 otherwise established by the commission under KRS 95A.240(6),  
10 toward certification within the first six (6) months of the first year of the  
11 department's application for certification, and there shall be a plan to  
12 complete the one hundred fifty (150) training hours, or as otherwise  
13 established by the commission by KRS 95A.240(6), within the second  
14 year.

15 These personnel, equipment, and training requirements shall not be made  
16 more stringent by the promulgation of administrative regulations.

17 (f) No allotment shall exceed the total value of the funds, equipment, lands, and  
18 buildings made available to the local fire units from any source whatever for  
19 the year in which the allotment is made.

20 (g) A portion of the funds provided for above may be used to purchase group or  
21 blanket health insurance and shall be used to purchase workers' compensation  
22 insurance, and the remaining funds shall be distributed as provided in this  
23 section.

24 (3) There shall be allotted two hundred thousand dollars (\$200,000) of the insurance  
25 premium surcharge proceeds accruing to the Firefighters Foundation Program fund  
26 that shall be allocated each fiscal year of the biennium to the firefighters training  
27 center fund, which is hereby created and established, for the purposes of

- 1 constructing new or upgrading existing training centers for firefighters. If any  
2 moneys in the training center fund remain uncommitted, unobligated, or  
3 unexpended at the close of the first fiscal year of the biennium, then such moneys  
4 shall be carried forward to the second fiscal year of the biennium, and shall be  
5 reallocated to and for the use of the training center fund, in addition to the second  
6 fiscal year's allocation of two hundred thousand dollars (\$200,000). Prior to funding  
7 any project pursuant to this subsection, a proposed project shall be approved by the  
8 Kentucky Fire Commission as provided in subsection (4) of this section and shall  
9 comply with state laws applicable to capital construction projects.
- 10 (4) Applications for funding low-interest loans and firefighters' training centers shall be  
11 submitted to the Kentucky Fire Commission for their recommendation, approval,  
12 disapproval, or modification. The commission shall review applications  
13 periodically, and shall, subject to funds available, recommend which applications  
14 shall be funded and at what levels, together with any terms and conditions the  
15 commission deems necessary.
- 16 (5) Any department or entity eligible for and receiving funding pursuant to this section  
17 shall have a minimum of fifty percent (50%) of its personnel certified as recognized  
18 by the Kentucky Fire Commission.
- 19 (6) Upon the written request of any department, the Kentucky Fire Commission shall  
20 make available a certified training program in a county of which such department is  
21 located.
- 22 (7) The amount of reimbursement for any given year for costs incurred by the  
23 Kentucky Community and Technical College System for administering these funds,  
24 including but not limited to the expenses and costs of commission operations, shall  
25 be determined by the commission and shall not exceed five percent (5%) of the total  
26 amount of moneys accruing to the Firefighters Foundation Program fund which are  
27 allotted for the purposes specified in this section during any fiscal year.

- 1 (8) The commission shall withhold from the general distribution of funds under  
2 subsection (2) of this section an amount which it deems sufficient to reimburse  
3 volunteer fire departments for equipment lost or damaged beyond repair due to  
4 hazardous material incidents.
- 5 (9) Moneys withheld pursuant to subsection (8) of this section shall be distributed only  
6 under the following terms and conditions:
- 7 (a) A volunteer fire department has lost or damaged beyond repair items of  
8 personal protective clothing or equipment due to that equipment having been  
9 lost or damaged as a result of an incident in which a hazardous material (as  
10 defined in any state or federal statute or regulation) was the causative agent of  
11 the loss;
- 12 (b) The volunteer fire department has made application in writing to the  
13 commission for reimbursement in a manner approved by the commission and  
14 the loss and the circumstances thereof have been verified by the commission;
- 15 (c) The loss of or damage to the equipment has not been reimbursed by the  
16 person responsible for the hazardous materials incident or by any other  
17 person;
- 18 (d) The commission has determined that the volunteer fire department does not  
19 have the fiscal resources to replace the equipment;
- 20 (e) The commission has determined that the equipment sought to be replaced is  
21 immediately necessary to protect the lives of the volunteer firefighters of the  
22 fire department;
- 23 (f) The fire department has agreed in writing to subrogate all claims for and  
24 rights to reimbursement for the lost or damaged equipment to the  
25 Commonwealth to the extent that the Commonwealth provides reimbursement  
26 to the department; and
- 27 (g) The department has shown to the satisfaction of the commission that it has

1           made reasonable attempts to secure reimbursement for its losses from the  
2           person responsible for the hazardous materials incident and has been  
3           unsuccessful in the effort.

4 (10) If a volunteer fire department has met all of the requirements of subsection (9) of  
5       this section, the commission may authorize a reimbursement of equipment losses  
6       not exceeding ten thousand dollars (\$10,000) or the actual amount of the loss,  
7       whichever is less.

8 (11) Moneys which have been withheld during any fiscal year which remain unexpended  
9       at the end of the fiscal year shall be distributed in the normal manner required by  
10      subsection (2) of this section during the following fiscal year.

11 (12) No volunteer fire department may receive funding for equipment losses more than  
12      once during any fiscal year.

13 (13) The commission shall make reasonable efforts to secure reimbursement from the  
14      responsible party for any moneys awarded to a fire department pursuant to this  
15      section.

16 (14) The commission, in accordance with the procedures in subsection (4) of this  
17      section, may make low-interest loans, and the interest thereon shall not exceed three  
18      percent (3%) annually or the amount needed to sustain operating expenses of the  
19      loan fund, whichever is less, to volunteer fire departments for the purposes of major  
20      equipment purchases and facility construction. Loans shall be made to departments  
21      which achieve the training standards necessary to qualify for volunteer fire  
22      department aid allotted pursuant to subsection (2) of this section, and which do not  
23      have other sources of funds at rates which are favorable given their financial  
24      resources. The proceeds of loan payments shall be returned to the loan fund for the  
25      purpose of providing future loans. If a department does not make scheduled loan  
26      payments, the commission may withhold any grants payable to the department  
27      pursuant to subsection (2) of this section until the department is current on its

1 payments. Money in the low-interest loan fund shall be used only for the purposes  
2 specified in this subsection. Any funds remaining in the fund at the end of a fiscal  
3 year shall be carried forward to the next fiscal year for the purposes of the fund.

4 (15) Each fiscal year there shall be allotted one million dollars (\$1,000,000) from the  
5 fund established in KRS 95A.220 to be used by the commission to conduct training-  
6 related activities.

7 (16) If funding is available from the fund established in KRS 95A.220, the Kentucky  
8 Fire Commission may implement the following:

9 (a) A program to prepare emergency service personnel for handling potential  
10 man-made and non-man-made threats. The commission shall work in  
11 conjunction with the state fire marshal and other appropriate agencies and  
12 associations to identify and make maps of gas transmission and hazardous  
13 liquids pipelines in the state;

14 (b) A program to provide and maintain a mobile test facility in each training  
15 region established by the Kentucky Fire Commission with equipment to  
16 administer Comprehensive Physical Aptitude Tests (CPAT) to ascertain a  
17 firefighter's ability to perform the physical requirements necessary to be an  
18 effective and safe firefighter;

19 (c) A program to provide defensive driving training tactics to firefighters. The  
20 commission shall purchase, instruct in the use of, and maintain mobile  
21 equipment in each of the training regions, and fund expenses related to  
22 equipment replacement;

23 (d) A program to annually evaluate equipment adequacy and to provide for  
24 annual physical examinations for instructors, adequate protective clothing and  
25 personal equipment to meet NFPA guidelines, and to establish procedures for  
26 replacing this equipment as needed;

27 (e) A program to establish a rotational expansion and replacement program for

1 mobile fleet equipment currently used for training and recertification of fire  
2 departments;

3 (f) A program to expand and update current emergency medical services,  
4 emergency medical responder, emergency medical technician, advanced  
5 emergency medical technician, and paramedic training and certification  
6 instruction; ~~and~~

7 (g) A program to purchase thermal vision devices to comply with the provisions  
8 of KRS 95A.400 to 95A.440; and

9 (h) A program to reimburse firefighters for out-of-pocket expenses for cancer  
10 screenings. The commission may promulgate administrative regulations  
11 pursuant to KRS Chapter 13A to:

12 1. Establish a periodic cap and maximum on the reimbursement to the  
13 firefighter seeking reimbursement;

14 2. Establish which cancer screening tests are eligible for reimbursement,  
15 provided that only cancer screening tests approved by the United  
16 States Food and Drug Administration for cancer detection in humans  
17 may be reimbursed;

18 3. Determine eligibility requirements for participants, which in the  
19 discretion of the commission may also include retired firefighters; and

20 4. Establish any other policy to effect the purposes of this program.
