

1 AN ACT relating to removal of local school board members.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 156.132 is amended to read as follows:

4 As used in this section, except subsection (1), "public school officer" means a person who  
5 previously served as a superintendent of schools~~[or board member]~~ during which time  
6 charges were brought against him under this section.

7 (1) The chief state school officer shall recommend, by written charges to the proper  
8 school authorities having immediate jurisdiction, the removal of any superintendent  
9 of schools, principal, teacher, member of a school council, or other public school  
10 officer as to whom he has reason to believe is guilty of immorality, misconduct in  
11 office, incompetency, willful neglect of duty, or nonfeasance. In the case of a  
12 member of a school council, the written charges shall be provided to the local board  
13 of education.

14 (2) The chief state school officer shall recommend by written charges the suspension by  
15 the Kentucky Board of Education of any~~[district board member]~~ superintendent of  
16 schools~~[,]~~ or other public school officer whom he has reason to believe is guilty of  
17 immorality, misconduct in office, incompetency, willful neglect of duty, or  
18 nonfeasance. If the charges brought under this subsection represent an immediate  
19 threat to the public health, safety, or welfare, the Kentucky Board of Education shall  
20 summarily suspend the person against whom the charges are made. The action by  
21 the Kentucky Board of Education may be taken upon a recommendation of the chief  
22 state school officer, or the action may be taken by a majority vote of the Kentucky  
23 Board of Education without recommendation from the chief state school officer.

24 (3) The Kentucky Board of Education may suspend a district superintendent of schools  
25 or other public school officer under subsection (2) of this section or remove him  
26 pursuant to subsection (5) of this section only if, after thirty (30) days of receipt of  
27 the written charges specified in subsection (1) of this section, the proper school

1 authorities having immediate jurisdiction, either the superintendent or the district  
2 board of education, have refused to act, have acted in bad faith, arbitrarily, or  
3 capriciously, or if a recommendation to the district board would have been futile.

4 (4) Any officer suspended by the Kentucky Board of Education under subsection (2) of  
5 this section shall be furnished with an emergency order specifying in detail the  
6 reasons for suspension and notifying the officer of his right to appeal the action and  
7 have an emergency hearing pursuant to KRS 13B.125.

8 (5) As an alternative to first seeking suspension, the chief state school officer may  
9 recommend by written charges the removal by the Kentucky Board of Education of  
10 any~~[-district board member,]~~ superintendent of schools~~[,]~~ or other public school  
11 officer whom he has reason to believe is guilty of immorality, misconduct in office,  
12 incompetency, willful neglect of duty, or nonfeasance. The officer against whom the  
13 written charges are issued by the chief state school officer shall be furnished with  
14 the written charges and notice of procedural rights conferred under KRS Chapter  
15 13B. Within twenty (20) days after receipt of the charges, the officer may notify the  
16 Kentucky Board of Education of his intention to appear and answer the charges.  
17 Upon appeal, an administrative hearing shall be conducted in accordance with KRS  
18 Chapter 13B. If the officer fails to notify the board of his intention to appear and  
19 answer the charges, the Kentucky Board of Education may remove the officer by a  
20 majority vote, and the dismissal shall be final.

21 (6) The hearing shall be public or private at the discretion of the accused former or  
22 current superintendent and shall be public when testimony is taken for board  
23 members.

24 (7) The Kentucky Board of Education may meet in closed session to consider the  
25 evidence and may by a majority vote remove the officer. If the board votes to  
26 remove the officer, the board shall prepare final order specifying which charge or  
27 charges it found to be the basis for removal. If within ninety (90) days from the date

1 of suspension if applicable, the state board has not removed the officer, or has  
2 dismissed the charges, the suspended officer shall be reinstated and shall be paid his  
3 full salary for the period of suspension.

4 (8) The officer shall have a right to appeal on the record to the Circuit Court located in  
5 the county of the school district in accordance with KRS Chapter 13B. If the  
6 decision of the court is against removal, the officer shall be paid his full salary from  
7 the date of suspension. The payment shall be made from funds appropriated to the  
8 State Department of Education.

9 (9) If a superintendent of schools is removed from office or resigns while charges are  
10 pending pursuant to this section after July 15, 1994, any continuing contract  
11 pursuant to KRS 161.720 to 161.810 shall be terminated. If the removal is reversed  
12 upon appeal, the continuing contract shall be restored and he shall be paid his full  
13 salary for the period of suspension.

14 ➔Section 2. KRS 156.136 is amended to read as follows:

15 The Kentucky Board of Education, upon suspension of any officer~~[or district board of~~  
16 ~~education member]~~ under KRS 156.132, shall name a person to fill the vacancy caused by  
17 such suspension. Persons appointed by the Kentucky Board of Education to fill vacancies  
18 under KRS 156.132 and this section shall hold office only during the time an officer is  
19 suspended, not to exceed ninety (90) days from the date of suspension. At the expiration  
20 of such period, vacancies shall be filled in the manner provided by law for the office.  
21 Persons appointed by the Kentucky Board of Education to fill vacancies caused by  
22 suspension shall be paid from funds of the district board of education. Any person  
23 employed to fill the position of a superintendent who has been removed by the Kentucky  
24 Board of Education under KRS 156.132 shall be employed by the district board of  
25 education for periods not to exceed one (1) year if the superintendent has appealed to the  
26 courts and if the courts have not taken final action.

27 ➔Section 3. KRS 158.785 is amended to read as follows:

- 1 (1) The Kentucky Board of Education shall establish a program to improve specific  
2 aspects of the management of local school districts as described in KRS 158.780.
- 3 (2) The State Department of Education shall, pursuant to administrative regulations  
4 promulgated by the Kentucky Board of Education, collect and review data relative  
5 to the instructional and operational performance of local school districts. When a  
6 review of the data or of any other information, including site investigations of local  
7 management practices, indicates the presence of critically ineffective or inefficient  
8 management, the chief state school officer shall order a management audit of the  
9 governance and administration of the district. A local school board or  
10 superintendent may also request a management audit of the district.
- 11 (3) If a management audit, conducted for any of the reasons set forth in subsection (2)  
12 of this section, indicates that there is a pattern of a significant lack of efficiency and  
13 effectiveness in the governance or administration of a school district, the chief state  
14 school officer shall recommend the district to the Kentucky Board of Education  
15 either as a "state assisted district" or a "state managed district."
- 16 (4) The Kentucky Board of Education shall promulgate an administrative regulation  
17 establishing a procedure for considering the recommendation of the chief state  
18 school officer to declare a district a "state assisted district" or a "state managed  
19 district." This procedure shall fully comply with the procedures for administrative  
20 hearings established in KRS Chapter 13B.
- 21 (5) When the chief state school officer presents a recommendation to the state board for  
22 designation as a "state assisted district" or a "state managed district," he shall  
23 establish the following:
- 24 (a) Existence of a pattern of a significant lack of efficiency and effectiveness in  
25 the governance or administration of the school district;
- 26 (b) The pattern of a significant lack of efficiency and effectiveness in the  
27 governance or administration of the school district continues to exist; and

- 1 (c) State assistance or state management is necessary to correct the inefficiencies  
2 and ineffectiveness.
- 3 (6) When a district is designated a "state assisted district" under subsection (4) of this  
4 section, the following actions shall be required of the chief state school officer:
- 5 (a) Management assistance shall be provided to the district to develop and  
6 implement a plan to correct deficiencies found in the management audit.
- 7 (b) The Department of Education shall monitor the development and  
8 implementation of the correctional plan to improve the governance or  
9 administration of the school district. If the chief state school officer  
10 determines that the plan is being inadequately developed or implemented, he  
11 shall make a recommendation to the Kentucky Board of Education to declare  
12 the district a "state managed district."
- 13 (7) If the state board designates a district a "state managed district" under subsection (4)  
14 of this section, the following actions shall be required of the chief state school  
15 officer:
- 16 (a) All administrative, operational, financial, personnel, and instructional aspects  
17 of the management of the school district formerly exercised by the local  
18 school board and the superintendent shall be exercised by the chief state  
19 school officer or his designee.
- 20 (b) ~~The~~~~[Any local school board member or the]~~ local superintendent may be  
21 removed from office by the Kentucky Board of Education pursuant to KRS  
22 156.132.
- 23 (c) Notwithstanding any statute to the contrary, after thirty (30) days after a  
24 district becomes a "state managed district" any appointment to an  
25 administrative position may be revoked by the chief state school officer and  
26 the individual employee may be reassigned to any duty for which that person  
27 is qualified. The chief state school officer shall provide to the reassigned

1 employee written reasons for the reassignment. The individual shall not be  
2 dismissed from subsequent employment except as provided by KRS 156.132  
3 and 161.790.

4 (d) The chief state school officer shall make the administrative appointments as  
5 necessary to exercise full and complete control of all aspects of the  
6 management of the district. The chief state school officer, through the  
7 appointments, may make any and all decisions previously made by the local  
8 school board and the local superintendent. The chief state school officer shall  
9 retain clear supervisory and monitoring powers over the operation and  
10 management of the district.

11 (8) A school district shall be designated as a "state managed district" until the Kentucky  
12 Board of Education determines that the pattern of ineffective and inefficient  
13 governance or administration and the specific deficiencies determined by the  
14 management audit have been corrected. Each year following the school year in  
15 which the designation of a "state managed district" was made, the chief state school  
16 officer shall report the status of the corrective action being taken to the Kentucky  
17 Board of Education. No local school district shall remain in the status of a "state  
18 managed district" longer than three (3) consecutive school years unless the  
19 Kentucky Board of Education extends the time after a complete review of a new  
20 management audit. Any judicial review of actions taken by the chief state school  
21 officer or the board under KRS 158.780 or this section shall be in accordance with  
22 the provisions for conducting judicial review of administrative hearings outlined in  
23 KRS Chapter 13B.

24 ➔Section 4. KRS 160.345 is amended to read as follows:

25 (1) For the purpose of this section:

26 (a) "Minority" means American Indian; Alaskan native; African-American;  
27 Hispanic, including persons of Mexican, Puerto Rican, Cuban, and Central or

1 South American origin; Pacific islander; or other ethnic group  
2 underrepresented in the school;

3 (b) "School" means an elementary or secondary educational institution that is  
4 under the administrative control of a principal and is not a program or part of  
5 another school. The term "school" does not include district-operated schools  
6 that are:

7 1. Exclusively vocational-technical, special education, or preschool  
8 programs;

9 2. Instructional programs operated in institutions or schools outside of the  
10 district; or

11 3. Alternative schools designed to provide services to at-risk populations  
12 with unique needs;

13 (c) "Teacher" means any person for whom certification is required as a basis of  
14 employment in the public schools of the state, with the exception of principals  
15 and assistant principals; and

16 (d) "Parent" means:

17 1. A parent, stepparent, or foster parent of a student; or

18 2. A person who has legal custody of a student pursuant to a court order  
19 and with whom the student resides.

20 (2) Each local board of education shall adopt a policy for implementing school-based  
21 decision making in the district which shall include but not be limited to a  
22 description of how the district's policies, including those developed pursuant to  
23 KRS 160.340, have been amended to allow the professional staff members of a  
24 school to be involved in the decision-making process as they work to meet  
25 educational goals established in KRS 158.645 and 158.6451. The policy may  
26 include a requirement that each school council make an annual report at a public  
27 meeting of the board describing the school's progress in meeting the educational

1 goals set forth in KRS 158.6451 and district goals established by the board. The  
2 policy shall also address and comply with the following:

3 (a) Except as provided in paragraph (b)2. of this subsection, each participating  
4 school shall form a school council composed of two (2) parents, three (3)  
5 teachers, and the principal or administrator. The membership of the council  
6 may be increased, but it may only be increased proportionately. A parent  
7 representative on the council shall not be an employee or a relative of an  
8 employee of the school in which that parent serves, nor shall the parent  
9 representative be an employee or a relative of an employee in the district  
10 administrative offices. A parent representative shall not be a local board  
11 member or a board member's spouse. None of the members shall have a  
12 conflict of interest pursuant to KRS Chapter 45A, except the salary paid to  
13 district employees;

14 (b) 1. The teacher representatives shall be elected for one (1) year terms by a  
15 majority of the teachers. A teacher elected to a school council shall not  
16 be involuntarily transferred during his or her term of office. The parent  
17 representatives shall be elected for one (1) year terms. The parent  
18 members shall be elected by the parents of students preregistered to  
19 attend the school during the term of office in an election conducted by  
20 the parent and teacher organization of the school or, if none exists, the  
21 largest organization of parents formed for this purpose. A school  
22 council, once elected, may adopt a policy setting different terms of  
23 office for parent and teacher members subsequently elected. The  
24 principal shall be the chair of the school council.

25 2. School councils in schools having eight percent (8%) or more minority  
26 students enrolled, as determined by the enrollment on the preceding  
27 October 1, shall have at least one (1) minority member. If the council

1           formed under paragraph (a) of this subsection does not have a minority  
2           member, the principal, in a timely manner, shall be responsible for  
3           carrying out the following:

4           a.     Organizing a special election to elect an additional member. The  
5           principal shall call for nominations and shall notify the parents of  
6           the students of the date, time, and location of the election to elect a  
7           minority parent to the council by ballot; and

8           b.     Allowing the teachers in the building to select one (1) minority  
9           teacher to serve as a teacher member on the council. If there are no  
10          minority teachers who are members of the faculty, an additional  
11          teacher member shall be elected by a majority of all teachers. Term  
12          limitations shall not apply for a minority teacher member who is  
13          the only minority on faculty;

14          (c)    1.     The school council shall have the responsibility to set school policy  
15          consistent with district board policy which shall provide an environment  
16          to enhance the students' achievement and help the school meet the goals  
17          established by KRS 158.645 and 158.6451. The principal shall be the  
18          primary administrator and the instructional leader of the school, and  
19          with the assistance of the total school staff shall administer the policies  
20          established by the school council and the local board.

21          2.     If a school council establishes committees, it shall adopt a policy to  
22          facilitate the participation of interested persons, including, but not  
23          limited to, classified employees and parents. The policy shall include the  
24          number of committees, their jurisdiction, composition, and the process  
25          for membership selection;

26          (d)    The school council and each of its committees shall determine the frequency  
27          of and agenda for their meetings. Matters relating to formation of school

1 councils that are not provided for by this section shall be addressed by local  
2 board policy;

3 (e) The meetings of the school council shall be open to the public and all  
4 interested persons may attend. However, the exceptions to open meetings  
5 provided in KRS 61.810 shall apply;

6 (f) After receiving notification of the funds available for the school from the local  
7 board, the school council shall determine, within the parameters of the total  
8 available funds, the number of persons to be employed in each job  
9 classification at the school. The council may make personnel decisions on  
10 vacancies occurring after the school council is formed but shall not have the  
11 authority to recommend transfers or dismissals;

12 (g) The school council shall determine which textbooks, instructional materials,  
13 and student support services shall be provided in the school. Subject to  
14 available resources, the local board shall allocate an appropriation to each  
15 school that is adequate to meet the school's needs related to instructional  
16 materials and school-based student support services, as determined by the  
17 school council. The school council shall consult with the school media  
18 librarian on the maintenance of the school library media center, including the  
19 purchase of instructional materials, information technology, and equipment;

20 (h) Personnel decisions at the school level shall be as follows:

21 1. From a list of qualified applicants submitted by the local superintendent,  
22 the principal at the participating school shall select personnel to fill  
23 vacancies, after consultation with the school council, consistent with  
24 paragraph (i)11. of this subsection. The superintendent shall provide  
25 additional applicants to the principal upon request when qualified  
26 applicants are available. The superintendent may forward to the school  
27 council the names of qualified applicants who have pending certification

1 from the Education Professional Standards Board based on recent  
2 completion of preparation requirements, out-of-state preparation, or  
3 alternative routes to certification pursuant to KRS 161.028 and 161.048.  
4 Requests for transfer shall conform to any employer-employee bargained  
5 contract which is in effect;

6 2. a. i. If the vacancy to be filled is the position of principal, the  
7 outgoing principal shall not serve on the council during the  
8 principal selection process. The superintendent or the  
9 superintendent's designee shall serve as the chair of the  
10 council for the purpose of the hiring process and shall have  
11 voting rights during the selection process.

12 ii. Except as provided in subdivision b. of this subparagraph,  
13 the council shall have access to the applications of all  
14 persons certified for the position. The principal shall be  
15 elected on a majority vote of the membership of the council.  
16 The school council shall receive training in recruitment and  
17 interviewing techniques prior to carrying out the process of  
18 selecting a principal. The council shall select the trainer to  
19 deliver the training;

20 b. An alternative principal selection process may be used by the  
21 school council as follows:

22 i. Prior to a meeting called to select a principal, all school  
23 council members shall receive informational materials  
24 regarding Kentucky open records and open meetings laws  
25 and sign a nondisclosure agreement forbidding the sharing of  
26 information shared and discussions held in the closed  
27 session;

- 1                   ii. The superintendent shall convene the school council and  
2                   move into closed session as provided in KRS 61.810(1)(f) to  
3                   confidentially recommend a candidate;
- 4                   iii. The council shall have the option to interview the  
5                   recommended candidate while in closed session; and
- 6                   iv. After any discussion, at the conclusion of the closed session,  
7                   the council shall decide, in a public meeting by majority vote  
8                   of the membership of the council, whether to accept or reject  
9                   the recommended principal candidate;
- 10                  c. If the recommended candidate is selected, and the recommended  
11                  candidate accepts the offer, the name of the candidate shall be  
12                  made public during the next meeting in open session;
- 13                  d. i. If the recommended candidate is not accepted by the school  
14                  council under subdivision b. of this subparagraph, then the  
15                  process set forth in subdivision a. of this subparagraph shall  
16                  apply.
- 17                  ii. The confidentially recommended candidate's name and the  
18                  discussions of the closed session shall remain confidential  
19                  under KRS 61.810(1)(f), and any documents used or  
20                  generated during the closed meeting shall not be subject to an  
21                  open records request as provided in KRS 61.878(1)(i) and (j).
- 22                  iii. A recommended candidate who believes a violation of this  
23                  subdivision has occurred may file a written complaint with  
24                  the Kentucky Board of Education.
- 25                  iv. A school council member who is found to have disclosed  
26                  confidential information regarding the proceeding of the  
27                  closed session shall be subject to removal from the school

1 council by the Kentucky Board of Education under  
2 subsection (9)(e) of this section;

- 3 3. No principal who has been previously removed from a position in the  
4 district for cause may be considered for appointment as principal in that  
5 district;
- 6 4. Personnel decisions made at the school level under the authority of  
7 subparagraphs 1. and 2. of this paragraph shall be binding on the  
8 superintendent who completes the hiring process;
- 9 5. Applicants subsequently employed shall provide evidence that they are  
10 certified prior to assuming the duties of a position in accordance with  
11 KRS 161.020;
- 12 6. Notwithstanding other provisions of this paragraph, if the applicant is  
13 the spouse of the superintendent and the applicant meets the service  
14 requirements of KRS 160.380(3)(a), the applicant shall only be  
15 employed upon the recommendation of the principal and the approval of  
16 a majority vote of the school council; and
- 17 7. Beginning June 27, 2019, notwithstanding the requirement that a  
18 principal be elected on a majority vote of the council in subparagraph 2.  
19 of this paragraph, if the school council is in a county school district in a  
20 county with a consolidated local government adopted under KRS  
21 Chapter 67C, then the selection of a principal shall be subject to  
22 approval by the superintendent. If the superintendent does not approve  
23 the principal selected by the council, then the superintendent may select  
24 the principal;
- 25 (i) The school council shall adopt a policy to be implemented by the principal in  
26 the following additional areas:
- 27 1. Determination of curriculum, including needs assessment, curriculum

- 1 development and responsibilities under KRS 158.6453(19);
- 2 2. Assignment of all instructional and noninstructional staff time;
- 3 3. Assignment of students to classes and programs within the school;
- 4 4. Determination of the schedule of the school day and week, subject to the
- 5 beginning and ending times of the school day and school calendar year
- 6 as established by the local board;
- 7 5. Determination of use of school space during the school day related to
- 8 improving classroom teaching and learning;
- 9 6. Planning and resolution of issues regarding instructional practices;
- 10 7. Selection and implementation of discipline and classroom management
- 11 techniques as a part of a comprehensive school safety plan, including
- 12 responsibilities of the student, parent, teacher, counselor, and principal;
- 13 8. Selection of extracurricular programs and determination of policies
- 14 relating to student participation based on academic qualifications and
- 15 attendance requirements, program evaluation, and supervision;
- 16 9. Adoption of an emergency plan as required in KRS 158.162;
- 17 10. Procedures, consistent with local school board policy, for determining
- 18 alignment with state standards, technology utilization, and program
- 19 appraisal; and
- 20 11. Procedures to assist the council with consultation in the selection of
- 21 personnel by the principal, including but not limited to meetings,
- 22 timelines, interviews, review of written applications, and review of
- 23 references. Procedures shall address situations in which members of the
- 24 council are not available for consultation; and
- 25 (j) Each school council shall annually review data as shown on state and local
- 26 student assessments required under KRS 158.6453. The data shall include but
- 27 not be limited to information on performance levels of all students tested, and

1 information on the performance of students disaggregated by race, gender,  
2 disability, and participation in the federal free and reduced price lunch  
3 program. After completing the review of data, each school council, with the  
4 involvement of parents, faculty, and staff, shall develop and adopt a plan to  
5 ensure that each student makes progress toward meeting the goals set forth in  
6 KRS 158.645 and 158.6451(1)(b) by April 1 of each year and submit the plan  
7 to the superintendent and local board of education for review as described in  
8 KRS 160.340. The Kentucky Department of Education shall provide each  
9 school council the data needed to complete the review required by this  
10 paragraph no later than October 1 of each year. If a school does not have a  
11 council, the review shall be completed by the principal with the involvement  
12 of parents, faculty, and staff.

13 (3) The policies adopted by the local board to implement school-based decision making  
14 shall also address the following:

15 (a) School budget and administration, including: discretionary funds; activity and  
16 other school funds; funds for maintenance, supplies, and equipment; and  
17 procedures for authorizing reimbursement for training and other expenses;

18 (b) Assessment of individual student progress, including testing and reporting of  
19 student progress to students, parents, the school district, the community, and  
20 the state;

21 (c) School improvement plans, including the form and function of strategic  
22 planning and its relationship to district planning, as well as the school safety  
23 plan and requests for funding from the Center for School Safety under KRS  
24 158.446;

25 (d) Professional development plans developed pursuant to KRS 156.095;

26 (e) Parent, citizen, and community participation including the relationship of the  
27 council with other groups;

- 1 (f) Cooperation and collaboration within the district, with other districts, and with  
2 other public and private agencies;
- 3 (g) Requirements for waiver of district policies;
- 4 (h) Requirements for record keeping by the school council; and
- 5 (i) A process for appealing a decision made by a school council.
- 6 (4) In addition to the authority granted to the school council in this section, the local  
7 board may grant to the school council any other authority permitted by law. The  
8 board shall make available liability insurance coverage for the protection of all  
9 members of the school council from liability arising in the course of pursuing their  
10 duties as members of the council.
- 11 (5) All schools shall implement school-based decision making in accordance with this  
12 section and with the policy adopted by the local board pursuant to this section.  
13 Upon favorable vote of a majority of the faculty at the school and a majority of at  
14 least twenty-five (25) voting parents of students enrolled in the school, a school  
15 meeting its goal as determined by the Department of Education pursuant to KRS  
16 158.6455 may apply to the Kentucky Board of Education for exemption from the  
17 requirement to implement school-based decision making, and the state board shall  
18 grant the exemption. The voting by the parents on the matter of exemption from  
19 implementing school-based decision making shall be in an election conducted by  
20 the parent and teacher organization of the school or, if none exists, the largest  
21 organization of parents formed for this purpose. Notwithstanding the provisions of  
22 this section, a local school district shall not be required to implement school-based  
23 decision making if the local school district contains only one (1) school.
- 24 (6) The Department of Education shall provide professional development activities to  
25 assist schools in implementing school-based decision making. School council  
26 members elected for the first time shall complete a minimum of six (6) clock hours  
27 of training in the process of school-based decision making, no later than thirty (30)

1 days after the beginning of the service year for which they are elected to serve.  
2 School council members who have served on a school council at least one (1) year  
3 shall complete a minimum of three (3) clock hours of training in the process of  
4 school-based decision making no later than one hundred twenty (120) days after the  
5 beginning of the service year for which they are elected to serve. Experienced  
6 members may participate in the training for new members to fulfill their training  
7 requirement. School council training required under this subsection shall be  
8 conducted by trainers endorsed by the Department of Education. By November 1 of  
9 each year, the principal through the local superintendent shall forward to the  
10 Department of Education the names and addresses of each council member and  
11 verify that the required training has been completed. School council members  
12 elected to fill a vacancy shall complete the applicable training within thirty (30)  
13 days of their election.

14 (7) A school that chooses to have school-based decision making but would like to be  
15 exempt from the administrative structure set forth by this section may develop a  
16 model for implementing school-based decision making, including but not limited to  
17 a description of the membership, organization, duties, and responsibilities of a  
18 school council. The school shall submit the model through the local board of  
19 education to the commissioner of education and the Kentucky Board of Education,  
20 which shall have final authority for approval. The application for approval of the  
21 model shall show evidence that it has been developed by representatives of the  
22 parents, students, certified personnel, and the administrators of the school and that  
23 two-thirds (2/3) of the faculty have agreed to the model.
