

1 AN ACT relating to gubernatorial elections.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 118 IS CREATED TO
4 READ AS FOLLOWS:

5 *(1) Each candidate for the office of Governor shall designate a candidate for*
6 *Lieutenant Governor to serve as his or her running mate in a slate of candidates.*
7 *After the filing of the certificate or petition of nomination under KRS 118.365,*
8 *and not later than 4 p.m. on the second Tuesday in August preceding the regular*
9 *election for the office of Governor, the candidate shall designate his or her*
10 *running mate by filing with the Secretary of State the name and address of a*
11 *person qualified under the Constitution of Kentucky to serve as Lieutenant*
12 *Governor.*

13 *(2) A slate of candidates for Governor and Lieutenant Governor shall be elected*
14 *jointly at a regular election by the casting by each voter of a single vote applicable*
15 *to both offices. No candidate for Governor or Lieutenant Governor shall appear*
16 *individually on the ballot at a regular election for the office he or she is seeking.*

17 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 118 IS CREATED TO
18 READ AS FOLLOWS:

19 *(1) If a vacancy occurs in a candidacy for the office of Lieutenant Governor because*
20 *of death, disqualification to hold the office sought, or a severe disabling condition*
21 *that arose after the slate formed a campaign committee, the candidate for the*
22 *office of Governor on that slate may designate a replacement for the vacant*
23 *candidate.*

24 *(2) The designation of a replacement shall be on forms filed with the Secretary of*
25 *State, but only following certification to the candidate for the office of Governor*
26 *by the Secretary of State that a vacancy exists for a reason specified in subsection*
27 *(1) of this section.*

1 **(3) If a replacement candidate for a vacancy in candidacy for Lieutenant Governor is**
2 **made for a reason specified in subsection (1) of this section after the ballots are**
3 **printed for the regular election, notices informing the voters of the change in**
4 **composition of the slate shall be posted at each precinct polling place.**

5 ➔Section 3. KRS 117.275 is amended to read as follows:

6 (1) At the count of the votes in any precinct, any candidate or slate of candidates and
7 any representatives to witness and check the count of the votes therein, who are
8 authorized to be appointed as is provided in subsection (9) of this section, shall be
9 admitted and be permitted to be present and witness the count.

10 (2) As soon as the polls are closed, and the last voter has voted, the judges shall
11 immediately lock and seal the voting equipment so that the voting and counting
12 mechanism will be prevented from operation, and they shall sign a certificate
13 stating:

14 (a) That the voting equipment has been locked against voting and sealed;

15 (b) The number of voters, as shown on the public counters;

16 (c) The number registered on the protective or accumulative counter or device, if
17 any; and

18 (d) The number or other designation of the voting equipment, which certificate
19 shall be returned by the judges of election to the officials authorized by law to
20 receive it. The judges shall compare the number of voters, as shown by the
21 counter of the voting equipment, with the number of those who have voted as
22 shown by the protective or accumulative counter or device, if any.

23 (3) Where voting equipment is used which does not print the candidates' names along
24 with the total votes received on a general return sheet or record for that equipment,
25 the procedure to be followed shall be as follows:

26 (a) The judges, in the presence of the representatives mentioned in subsection (1)
27 of this section, if any, and of all other persons who may be lawfully within the

- 1 polling place, shall give full view of all the counter numbers;
- 2 (b) The judges shall enter, in ink, the total votes cast for each candidate, and slate
3 of candidates, and for and against each question on the return sheets; and
- 4 (c) Each precinct election officer shall sign the return sheets, and a copy of the
5 return sheets shall be posted on the precinct door.
- 6 (4) Where voting equipment is used that prints the candidates' names along with the
7 total votes received on a return sheet or record for that equipment, the precinct
8 election officers shall sign the return sheets or record for the voting equipment,
9 which shall be posted on the door of the precinct.
- 10 (5) If any officer shall decline to sign the return sheets, he or she shall state the reason
11 in writing, and a copy thereof, signed by the officer, shall be enclosed with the
12 return sheets.
- 13 (6) Each of the return sheets, if applicable, and the record of the voting equipment shall
14 be enclosed in an envelope. One (1) copy of the return sheets, if applicable, one (1)
15 copy of the record of the voting equipment, and the write-in roll, if any write-in
16 votes were cast in the precinct, shall be directed to the county board of elections of
17 the county in which the election is being held. One (1) copy of the return sheets or
18 record of the voting equipment shall be given to the county clerk of the county in
19 which the election is being held and to each of the local governing bodies of the two
20 (2) dominant political parties, but a local governing body of a dominant political
21 party may decline a copy of the precinct election return by filing a written
22 declination with the county board of elections prior to the election, and upon this
23 declination, a printed copy shall not be issued to the political party so declining. The
24 declination on file shall be effective for that election and any subsequent elections
25 until revoked by the local governing body of a dominant political party by filing a
26 written revocation with the county board of elections. The envelope shall have
27 endorsed thereon a certificate of the election officers, stating the number of the

- 1 machine, the precinct where it has been used, the number on the seal, and the
2 number on the protective or accumulative counter or device at the close of the polls.
- 3 (7) Following the tabulation of all votes cast in the election, including absentee votes
4 and write-in votes, the county board shall mail a copy of the precinct-by-precinct
5 summary of the tabulation sheets showing the results from each precinct to the State
6 Board of Elections and the county clerk shall mail or deliver the precinct signature
7 rosters from each precinct to the State Board of Elections during the period
8 established by KRS 117.355(3).
- 9 (8) As soon as possible after the completion of the count, the two (2) judges shall return
10 to the county board of elections the keys to the voting machine received and
11 receipted for by them, and the county clerk in which the precinct is located shall
12 have the voting machine properly boxed or securely covered and removed to a
13 proper and secure place of storage.
- 14 (9) In primaries, each candidate~~[, slate of candidates,]~~ or group of candidates may
15 designate to the county board of elections a representative to witness and check the
16 vote count. In regular elections, the governing authority of each political party, each
17 candidate for member of board of education, nonpartisan candidate, independent
18 candidate, or independent ticket may designate a representative to the county board
19 of elections to witness and check the vote count. The county board of elections shall
20 authorize representatives of the news media to witness the vote count.
- 21 (10) If supplemental paper ballots have been approved, as provided in KRS 118.215,
22 after the polls are closed, the two (2) judges shall return to the county clerk's office
23 the locked ballot box, all ballot stubs, spoiled ballots, and unvoted ballots at the
24 same time as the tabulation of votes from the voting machine is delivered. The
25 county clerk shall issue a receipt for the number of ballot stubs, unvoted ballots,
26 spoiled ballots and the ballot box.
- 27 (11) The county board of elections, or its designee, shall count and tally the paper ballots

1 manually or with the use of tabulating equipment which does not involve an
2 additional voting system. The results of the vote tally shall be certified by the
3 county board of elections to the county clerk and to the Secretary of State.

4 (12) The county board of elections shall authorize the candidates, slates of candidates, or
5 their representatives, and representatives of the news media to be present during the
6 counting of the paper ballots.

7 (13) Except as otherwise required in this chapter that certain records and papers relating
8 to specified elections be retained for twenty-two (22) months, the county clerk shall
9 retain the voted paper ballots for twenty-two (22) months and the unvoted paper
10 ballots for sixty (60) days after each election day, after which time they shall be
11 destroyed in a manner to render them unreadable by the county board of elections if
12 no contest or recount action has been filed.

13 ➔Section 4. KRS 118.025 is amended to read as follows:

14 (1) Except as otherwise provided by law, voting in all **primaries and** elections shall be
15 by secret ballot on voting machines.

16 (2) The general laws applying to **primaries, regular, and** special~~[, and primary]~~
17 elections shall apply to **primaries, regular, and special** elections conducted with the
18 use of voting machines, and all provisions of the general laws applying to the
19 custody of ballot boxes shall apply, as far as applicable, to the custody of the voting
20 machine.

21 (3) **Primaries**~~[Primary elections]~~ for the nomination of candidates~~[or slates of~~
22 ~~candidates]~~ to be voted for at the next regular election shall be held on the first
23 Tuesday after the third Monday in May of each year.

24 (4) The election of all officers of all governmental units shall be held on the first
25 Tuesday after the first Monday in November.

26 (5) If the law authorizes the calling of a special election on a day other than the day of
27 the regular election in November, the election shall be held on a Tuesday.

1 (6) If the law requires that a special election be held within a period of time during
 2 which the voting machines must be locked as required by KRS 117.295, the special
 3 election shall be held on the fourth Tuesday following the expiration of the period
 4 during which the voting machines are locked.

5 ➔Section 5. KRS 118.125 is amended to read as follows:

6 (1) Except as provided in KRS 118.155, any person who is qualified under the
 7 provisions of KRS 116.055 to vote in any primary for the candidates for nomination
 8 by the party at whose hands he or she seeks the nomination, shall have his or her
 9 name printed on the official ballot of his or her party for an office to which he is
 10 eligible in that primary, upon filing, with the Secretary of State or county clerk, as
 11 appropriate, at the proper time, a notification and declaration.

12 (2) The notification and declaration shall be in the form prescribed by the State Board
 13 of Elections. It shall be signed by the candidate and by not less than two (2)
 14 registered voters of the same party from the district or jurisdiction from which the
 15 candidate seeks nomination. Signatures for nomination papers shall not be affixed
 16 on the document to be filed prior to the first Wednesday after the first Monday in
 17 November of the year preceding the year in which the office will appear on the
 18 ballot.†

19 ~~(a) —]The notification and declaration for a candidate[for an office other than~~
 20 ~~Governor or Lieutenant Governor]~~ shall include the following oath:

21 "For the purpose of having my name placed on the official primary
 22 election ballot as a candidate for nomination by the ----- Party, I, ----- (name
 23 in full as desired on the ballot as provided in KRS 118.129), do solemnly
 24 swear that my residence address is ----- (street, route, highway, city if
 25 applicable, county, state, and zip code), that my mailing address, if different,
 26 is ----- (post office address), and that I am a registered ----- (party) voter in ---
 27 --- precinct; that I believe in the principles of the ----- Party, and intend to

1 support its principles and policies; that I meet all the statutory and
 2 constitutional qualifications for the office which I am seeking; that if
 3 nominated as a candidate of such party at the ensuing election I will accept the
 4 nomination and not withdraw for reasons other than those stated in KRS
 5 118.105(3); that I will not knowingly violate any election law or any law
 6 relating to corrupt and fraudulent practice in campaigns or elections in this
 7 state, and if finally elected I will qualify for the office."

8 The declaration shall be subscribed and sworn to before an officer authorized
 9 to administer an oath by the candidate and by the two (2) voters making the
 10 declaration and signing the candidate's petition for office.

11 ~~[(b) The notification and declaration for a slate of candidates for Governor and~~
 12 ~~Lieutenant Governor shall include the following oath:~~

13 ~~—————"For the purpose of having our names placed on the official primary~~
 14 ~~election ballot as a slate of candidates for Governor and Lieutenant Governor~~
 15 ~~for nomination by the ——— Party, I, ———, (name of candidate for Governor in~~
 16 ~~full as desired on the ballot as provided in KRS 118.129), do solemnly swear~~
 17 ~~that my residence address is ——— (street, route, highway, city if applicable,~~
 18 ~~county, state, and zip code), that my mailing address, if different, is ——— (post~~
 19 ~~office address), and that I am a registered ——— (party) voter in ——— precinct;~~
 20 ~~and I, ———, (name of candidate for Lieutenant Governor in full as desired on~~
 21 ~~the ballot as provided in KRS 118.129), do solemnly swear that my residence~~

 3 ~~fraudulent practice in campaigns or elections in this state, and if finally elected~~
 4 ~~we will qualify for our offices."~~

5 ~~—The declaration shall be subscribed and sworn to before an officer authorized~~
 6 ~~to administer an oath by the candidate and by the two (2) voters making the~~
 7 ~~declaration and signing the petition for office.]~~

8 (3) When the notice and declaration has been filed with the Secretary of State or county
 9 clerk, as appropriate, and certified according to KRS 118.165, the Secretary of State
 10 or county clerk, as appropriate, shall have the candidate's name printed on the ballot
 11 according to the provisions of this chapter, except as provided in KRS 118.185.

12 (4) Titles, ranks, or spurious phrases shall not be accepted on the filing papers and shall
 13 not be printed on the ballots as part of the candidate's name; however, nicknames,
 14 initials, and contractions of given names may be acceptable as the candidate's name.

15 ➔Section 6. KRS 118.245 is amended to read as follows:

16 (1) The candidate for office~~[, other than the offices of Governor and Lieutenant~~
 17 ~~Governor,]~~ receiving the highest number of votes in a primary~~[election]~~ for the
 18 office for which he ***or she*** is a candidate shall be the nominee of his ***or her*** party for
 19 that office and shall receive the certificate of nomination.

20 (2) ~~{The slate of candidates for Governor and Lieutenant Governor receiving the~~
 21 ~~highest number of votes in a primary shall be the nominees of that party for~~
 22 ~~Governor and Lieutenant Governor, and that slate of candidates shall receive the~~
 23 ~~certificate of nomination.~~

24 ~~(3) —~~If two (2) or more candidates~~[or slates of candidates]~~ in a primary~~[election]~~ are
 25 found to have received the highest and an equal number of votes for nomination to
 26 the same office, the election shall be determined by lot in the manner the board
 27 directs, in the presence of not less than three (3) other persons. This section does not

1 apply to presidential primaries.

2 ➔Section 7. KRS 120.055 is amended to read as follows:

3 Any candidate~~[or slate of candidates]~~ for nomination to office at a primary~~[election]~~
4 held under the provisions of KRS 118.015 to 118.035 and 118.105 to 118.255, or any
5 candidate for nomination to a city office at a primary~~[election]~~ for which the statutes do
6 not otherwise provide for determining contest elections, for whom a number of votes was
7 cast equal to not less than fifty percent (50%) of the votes cast for the successful
8 candidate~~[or slate of candidates]~~ for nomination to the office, may contest the right of the
9 successful candidate~~[or slate of candidates]~~, and of any other candidate~~[or slate of~~
10 ~~candidates]~~ for nomination to the office, to the nomination, by filing a petition in the
11 Circuit Court within ten (10) days from the day of the primary~~[election]~~, stating the
12 specific grounds relied upon for the contest, and causing a summons to be issued,
13 returnable in seven (7) days. In the case of candidates~~[or slates of candidates]~~ for offices
14 for the state at large, the petition shall be filed in the Franklin Circuit Court; in the case of
15 other candidates it shall be filed in the Circuit Court of the county in which the contestee
16 resides. The summons may be personally served on the contestee in any county, or it may
17 be served by leaving a copy at his ***or her*** home with a member of his ***or her*** family over
18 sixteen (16) years of age, or by posting a copy on the door of his ***or her*** residence. The
19 contestee shall file his ***or her*** answer within seven (7) days after service of summons. The
20 answer may contain grounds of contest in favor of the contestee and against the
21 contestant, but the grounds shall be specifically set out. Any candidate~~[or slate of~~
22 ~~candidates]~~ who would have been qualified to bring a contest action under this section,
23 who is a party to a recount proceeding brought under KRS 120.095, may, by filing an
24 answer in the recount proceeding within the time allowed by this section for filing
25 grounds of contest, set forth grounds of contest against the petitioner in the recount
26 proceeding. No ground of contest by either party shall be filed or made more definite by
27 amendment after the expiration of the time allowed by this section for filing the original

1 pleading. The contestant may file a reply within five (5) days after answer is filed, which
2 shall complete the pleading, and any affirmative matter in the reply shall be treated as
3 controverted. Upon return of the summons, properly executed, to the office of the circuit
4 clerk of the county in which the action is pending, the clerk shall immediately docket the
5 cause and notify the presiding judge of the court that the contest has been instituted, and
6 the judge shall proceed to a trial of the cause within five (5) days after the issue was
7 joined. In judicial circuits having more than one (1) Circuit Judge, the judge who shall
8 hear the cause shall be determined by lot.

9 →Section 8. KRS 120.095 is amended to read as follows:

10 (1) Any candidate~~[or slate of candidates]~~ voted for at a primary~~[election]~~ held under
11 KRS 118.015 to 118.035 and 118.105 to 118.255 may request a recount of the
12 ballots by filing a petition with the same court that contest petitions are required to
13 be filed with, within ten (10) days after the day of the primary~~[election]~~, or, if the
14 candidate~~[or slate of candidates]~~ is qualified to bring a contest proceeding under
15 KRS 120.055, by including a request for a recount in his ***or her*** petition instituting
16 the contest proceedings. Any candidate ***who***~~[or slate of candidates that]~~ is a
17 contestee in a contest proceeding under KRS 120.055 may request a recount in his
18 ***or her*** answer filed in the contest proceeding, but in that case the answer shall be
19 filed within five (5) days after the service of process on the petition. When a request
20 for a recount is made, the State Board of Elections or the county board of elections,
21 whichever would issue the certificate of nomination, shall be made a party
22 defendant. The party requesting the recount shall execute a bond with approved
23 surety for the costs of the recount, in an amount to be fixed by the Circuit Judge.
24 Upon the bond being filed, the clerk shall immediately notify the Circuit Judge of
25 the request and the filing of the bond, and the judge shall at once enter an order
26 directing custody of the voting machines, the ballots, boxes, and all papers
27 pertaining to the election to be transferred to the Circuit Court, and fix a day for the

1 recount proceedings to begin. A copy of the order shall be served upon the parties or
2 their counsel in the same manner as notices are required to be served, which shall be
3 deemed sufficient notice of the proceeding. On the day fixed, the court shall
4 proceed to recount the ballots if their integrity is satisfactorily shown and shall
5 complete the recount as soon as practicable, and file and enter of record the results
6 thereof, and direct the state board or county board, whichever would issue the
7 certificate of nomination, to issue a certificate to the party entitled thereto as shown
8 by the recount.

9 (2) Any party may appeal from the judgment to the Court of Appeals, in the same
10 manner as provided in KRS 120.075, all of the provisions of which statute shall be
11 applicable.

12 (3) If a proceeding for recount is asked and prosecuted in a contest proceeding, it shall
13 not await the preparation or trial of the contest in the Circuit Court or in the Court
14 of Appeals. The action of the courts shall be final, concluding the parties as to the
15 question of a recount of the ballots, and certificates shall then be issued to the
16 parties entitled thereto.

17 ➔Section 9. KRS 121.015 is amended to read as follows:

18 As used in this chapter:

19 (1) "Registry" means the Kentucky Registry of Election Finance;

20 (2) "Election" means any primary, regular, or special election to fill vacancies
21 regardless of whether a candidate or slate of candidates is opposed or unopposed in
22 an election. Each primary, regular, or special election shall be considered a separate
23 election;

24 (3) "Committee" includes the following:

25 (a) "Campaign committee," which means one (1) or more persons who receive
26 contributions and make expenditures to support or oppose one (1) or more
27 specific candidates or slates of candidates for nomination or election to any

1 state, county, city, or district office, but does not include an entity established
2 solely by a candidate which is managed solely by a candidate and a campaign
3 treasurer and whose name is generic in nature, such as "Friends of (the
4 candidate)," and does not reflect that other persons have structured themselves
5 as a committee, designated officers of the committee, and assigned
6 responsibilities and duties to each officer with the purpose of managing a
7 campaign to support or oppose a candidate in an election;

8 (b) "Caucus campaign committee," which means members of one (1) of the
9 following caucus groups who receive contributions and make expenditures to
10 support or oppose one (1) or more specific candidates or slates of candidates
11 for nomination or election, or a committee:

- 12 1. House Democratic caucus campaign committee;
- 13 2. House Republican caucus campaign committee;
- 14 3. Senate Democratic caucus campaign committee;
- 15 4. Senate Republican caucus campaign committee; or
- 16 5. Subdivisions of the state executive committee of a minor political party,
17 which serve the same function as the above-named committees, as
18 determined by regulations promulgated by the registry;

19 (c) "Political issues committee," which means three (3) or more persons joining
20 together to advocate or oppose a constitutional amendment or public question
21 which appears on the ballot if that committee receives or expends money in
22 excess of one thousand dollars (\$1,000);

23 (d) "Permanent committee," which means a group of individuals, including an
24 association, committee, or organization, other than a campaign committee,
25 political issues committee, inaugural committee, caucus campaign committee,
26 or party executive committee, which is established as, or intended to be, a
27 permanent organization having as a primary purpose expressly advocating the

1 election or defeat of one (1) or more clearly identified candidates, slates of
2 candidates, or political parties, which functions on a regular basis throughout
3 the year;

4 (e) An executive committee of a political party; and

5 (f) "Inaugural committee," which means one (1) or more persons who receive
6 contributions and make expenditures in support of inauguration activities for
7 any candidate or slate of candidates elected to any state, county, city, or
8 district office;

9 (4) "Contributing organization" means a group which merely contributes to candidates,
10 slates of candidates, campaign committees, caucus campaign committees, or
11 executive committees from time to time from funds derived solely from within the
12 group, and which does not solicit or receive funds from sources outside the group
13 itself. However, any contributions made by the groups in excess of one hundred
14 dollars (\$100) shall be reported to the registry;

15 (5) "Testimonial affair" means an affair held in honor of a person who holds or who is
16 or was a candidate for nomination or election to a political office in this state
17 designed to raise funds for any purpose not charitable, religious, or educational;

18 (6) "Contribution" means any:

19 (a) Payment, distribution, loan, deposit, or gift of money or other thing of value,
20 to a candidate, his or her agent, a slate of candidates, its authorized agent, a
21 committee, or contributing organization. As used in this subsection, "loan"
22 shall include a guarantee, endorsement, or other form of security where the
23 risk of nonpayment rests with the surety, guarantor, or endorser, as well as
24 with a committee, contributing organization, candidate, slate of candidates, or
25 other primary obligor. No person shall become liable as surety, endorser, or
26 guarantor for any sum in any one (1) election which, when combined with all
27 other contributions the individual makes to a candidate, his or her agent, a

1 slate of candidates, its agent, a committee, or a contributing organization,
2 exceeds the contribution limits provided in KRS 121.150;

3 (b) Payment by any person other than the candidate, his or her authorized
4 treasurer, a slate of candidates, its authorized treasurer, a committee, or a
5 contributing organization, of compensation for the personal services of
6 another person which are rendered to a candidate, slate of candidates,
7 committee, or contributing organization, or for inauguration activities;

8 (c) Goods, advertising, or services with a value of more than one hundred dollars
9 (\$100) in the aggregate in any one (1) election which are furnished to a
10 candidate, slate of candidates, committee, or contributing organization or for
11 inauguration activities without charge, or at a rate which is less than the rate
12 normally charged for the goods or services; or

13 (d) Payment by any person other than a candidate, his or her authorized treasurer,
14 a slate of candidates, its authorized treasurer, a committee, or contributing
15 organization for any goods or services with a value of more than one hundred
16 dollars (\$100) in the aggregate in any one (1) election which are utilized by a
17 candidate, slate of candidates, committee, or contributing organization, or for
18 inauguration activities;

19 (7) Notwithstanding the foregoing meanings of "contribution," the word shall not be
20 construed to include:

21 (a) Services provided without compensation by individuals volunteering a portion
22 or all of their time on behalf of a candidate, a slate of candidates, committee,
23 or contributing organization;

24 (b) A loan of money by any financial institution doing business in Kentucky made
25 in accordance with applicable banking laws and regulations and in the
26 ordinary course of business; or

27 (c) An independent expenditure by any individual or permanent committee;

1 (8) "Candidate" means any person who has received contributions or made
2 expenditures, has appointed a campaign treasurer, or has given his or her consent
3 for any other person to receive contributions or make expenditures with a view to
4 bringing about his or her nomination or election to public office, except federal
5 office;

6 (9) "Slate of candidates" means:

7 (a) Between the time a certificate or petition of nomination has been filed for a
8 candidate for the office of Governor under KRS 118.365 and the time the
9 candidate designates a running mate for the office of Lieutenant Governor
10 under Section 1 of this Act, a slate of candidates consists of the candidate
11 for the office of Governor; and

23 (10) "Knowingly" means, with respect to conduct or to a circumstance described by a
24 statute defining an offense, that a person is aware or should have been aware that
25 his or her conduct is of that nature or that the circumstance exists;

26 (11) "Fundraiser" means an individual who directly solicits and secures contributions on
27 behalf of a candidate or slate of candidates for a statewide-elected state office or an

- 3 (12) "Independent expenditure" means the expenditure of money or other things of value
4 for a communication which expressly advocates the election or defeat of a clearly

7 campaign committee, or any authorized person acting on behalf of any of them, and
8 which is not made in concert with, or at the request or suggestion of any candidate,

- 11 (13) "Electronic reporting" means the use of technology, having electrical, digital,
12 magnetic, wireless, optical, electromagnetic, or similar capabilities, by which an

14 to the registry, or by which the registry receives, stores, analyzes, or discloses the
15 reports;
- 16 (14) "Security procedure" means a procedure employed for the purpose of verifying that
17 an electronic signature, record, or performance is that of a specific person or for
18 detecting changes or errors in the information in an electronic record. The term
19 includes a procedure that requires the use of algorithms or other codes, identifying
20 words or numbers, encryption, or callback or other acknowledgment procedures;
- 21 (15) "Electronic signature" means an electronic sound, symbol, or process attached to or
22 logically associated with a record and executed or adopted by a person with the
23 intent to sign the record;
- 24 (16) "Filer" means any candidate, a slate of candidates, committee, or other individual or
25 entity required to submit financial disclosure reports to the registry; and
- 26 (17) "Filer-side software" means software provided to or used by the filer that enables
27 transmittal of financial reports to the registry.

- 2 (1) Any committee, except a federally registered out-of-state permanent committee,
3 organized under any provisions of this chapter shall register with the registry, by
4 filing official notice of intention at the time of organization, giving names,
5 addresses, and positions of the officers of the organization, identifying an official
6 contact person of the committee, and designating the candidate or candidates, slate

16 forms filed with the registry shall require the registrant to clearly identify the
17 specific purpose, sponsorship, and source from which the committee originates; and
