

1 AN ACT relating to elections.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 118 IS CREATED TO  
4 READ AS FOLLOWS:

5 *(1) Each candidate for the office of Governor shall designate a candidate for*  
6 *Lieutenant Governor to serve as his or her running mate in a slate of candidates.*  
7 *After the filing of the certificate or petition of nomination under KRS 118.365,*  
8 *and not later than 4 p.m. on the second Tuesday in August preceding the regular*  
9 *election for the office of Governor, the candidate shall designate his or her*  
10 *running mate by filing with the Secretary of State the name and address of a*  
11 *person qualified under the Constitution of Kentucky to serve as Lieutenant*  
12 *Governor.*

13 *(2) A slate of candidates for Governor and Lieutenant Governor shall be elected*  
14 *jointly at a regular election by the casting by each voter of a single vote applicable*  
15 *to both offices. No candidate for Governor or Lieutenant Governor shall appear*  
16 *individually on the ballot at a regular election for the office he or she is seeking.*

17 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 118 IS CREATED TO  
18 READ AS FOLLOWS:

19 *(1) If a vacancy occurs in a candidacy for the office of Lieutenant Governor because*  
20 *of death, disqualification to hold the office sought, or a severe disabling condition*  
21 *that arose after the slate formed a campaign committee, the candidate for the*  
22 *office of Governor on that slate may designate a replacement for the vacant*  
23 *candidate.*

24 *(2) The designation of a replacement shall be on forms filed with the Secretary of*  
25 *State, but only following certification to the candidate for the office of Governor*  
26 *by the Secretary of State that a vacancy exists for a reason specified in subsection*  
27 *(1) of this section.*

1 **(3) If a replacement candidate for a vacancy in candidacy for Lieutenant Governor is**  
2 **made for a reason specified in subsection (1) of this section after the ballots are**  
3 **printed for the regular election, notices informing the voters of the change in**  
4 **composition of the slate shall be posted at each precinct polling place.**

5 ➔Section 3. KRS 117.015 is amended to read as follows:

6 (1) There shall be a State Board of Elections that is an independent agency of state  
7 government, which shall administer the election laws of the state and supervise  
8 registration and purgation of voters within the state. The board:

9 (a) May promulgate administrative regulations necessary to properly carry out its  
10 duties; and

11 (b) Shall promulgate administrative regulations establishing a procedure for  
12 elections officials to follow when an election has been suspended or delayed  
13 as described in KRS 39A.100.

14 (2) The board shall consist of the following:

15 (a) The Secretary of State, who shall be an ex officio, nonvoting member, and  
16 who shall also serve as the chief election official for the Commonwealth;

17 (b) Two (2) members appointed by the Governor as provided in subsection (6) of  
18 this section;

19 (c) Six (6) voting members appointed by the Governor as provided in subsection  
20 (5) of this section; and

21 (d) An executive director appointed in accordance with KRS 117.025, who may  
22 vote only to break a tie regarding selection of the chair of the board.

23 (3) A chair of the board, who is a then-current voting member of the board, shall be  
24 elected as chair of the board by a majority of the voting members who serve on the  
25 board. The chair shall preside at the meetings of the board and vote on matters  
26 before the board.

27 (4) The members shall serve for a term of four (4) years or until their successors are

1 appointed. Members shall be at least twenty-five (25) years of age and qualified  
2 voters of this state. No appointed member shall be a candidate for public office or  
3 have been a candidate for public office for two (2) years prior to his or her  
4 appointment, except as provided in subsection (2)(b) of this section. No member of  
5 the board shall have been convicted of any election law offense.

6 (5) Two (2) members shall be appointed by the Governor from a separate list of at least  
7 five (5) names submitted by the state central executive committee of each of the two  
8 (2) political parties that polled the largest vote in the last preceding election for state  
9 officials. The list shall be submitted to the Governor by February 15 of 1992, and  
10 the appointments of the Governor shall be made by April 1 of the same year. Two  
11 (2) separate lists shall be submitted to the Governor by August 15 of 1990 and every  
12 four (4) years thereafter, and two (2) appointments shall be made from these lists by  
13 September 15 of each year in which the lists are received.

14 (6) Two (2) members shall be appointed by the Governor from a separate list of at least  
15 four (4) names submitted by the Kentucky County Clerk's Association of each of  
16 the two (2) political parties that polled the largest vote in the last preceding regular  
17 election for state officials. Each of the two (2) members appointed under this  
18 subsection shall be former county clerks and shall be voting members. The lists  
19 required under this subsection shall be submitted to the Governor by July 15, 2019,  
20 and every four (4) years thereafter. The appointments made by the Governor under  
21 this subsection shall be made by August 15, 2019, and every four (4) years  
22 thereafter.

23 (7) Vacancies shall be filled in the same manner as provided for original appointments,  
24 and the person appointed to fill the vacancy shall be of the same political party as  
25 his or her predecessor.

26 (8) The board shall meet as often as necessary to carry out its duties and shall keep a  
27 record of its acts, orders, findings, and proceedings. A majority of the board shall

1 constitute a quorum.

2 (9) The members of the board shall be paid a reasonable sum to be fixed by the  
3 secretary of the Personnel Cabinet, with the approval of the secretary of the Finance  
4 and Administration Cabinet, and in addition, their expenses in attending board  
5 meetings. The compensation shall be paid out of the State Treasury upon requisition  
6 signed by the chair of the board and approved by the secretary of the Finance and  
7 Administration Cabinet.

8 ➔Section 4. KRS 117.275 is amended to read as follows:

9 (1) At the count of the votes in any precinct, any candidate or slate of candidates and  
10 any representatives to witness and check the count of the votes therein, who are  
11 authorized to be appointed as is provided in subsection (9) of this section, shall be  
12 admitted and be permitted to be present and witness the count.

13 (2) As soon as the polls are closed, and the last voter has voted, the judges shall  
14 immediately lock and seal the voting equipment so that the voting and counting  
15 mechanism will be prevented from operation, and they shall sign a certificate  
16 stating:

17 (a) That the voting equipment has been locked against voting and sealed;

18 (b) The number of voters, as shown on the public counters;

19 (c) The number registered on the protective or accumulative counter or device, if  
20 any; and

21 (d) The number or other designation of the voting equipment, which certificate  
22 shall be returned by the judges of election to the officials authorized by law to  
23 receive it. The judges shall compare the number of voters, as shown by the  
24 counter of the voting equipment, with the number of those who have voted as  
25 shown by the protective or accumulative counter or device, if any.

26 (3) Where voting equipment is used which does not print the candidates' names along  
27 with the total votes received on a general return sheet or record for that equipment,

1 the procedure to be followed shall be as follows:

2 (a) The judges, in the presence of the representatives mentioned in subsection (1)  
3 of this section, if any, and of all other persons who may be lawfully within the  
4 polling place, shall give full view of all the counter numbers;

5 (b) The judges shall enter, in ink, the total votes cast for each candidate, and slate  
6 of candidates, and for and against each question on the return sheets; and

7 (c) Each precinct election officer shall sign the return sheets, and a copy of the  
8 return sheets shall be posted on the precinct door.

9 (4) Where voting equipment is used that prints the candidates' names along with the  
10 total votes received on a return sheet or record for that equipment, the precinct  
11 election officers shall sign the return sheets or record for the voting equipment,  
12 which shall be posted on the door of the precinct.

13 (5) If any officer shall decline to sign the return sheets, he or she shall state the reason  
14 in writing, and a copy thereof, signed by the officer, shall be enclosed with the  
15 return sheets.

16 (6) Each of the return sheets, if applicable, and the record of the voting equipment shall  
17 be enclosed in an envelope. One (1) copy of the return sheets, if applicable, one (1)  
18 copy of the record of the voting equipment, and the write-in roll, if any write-in  
19 votes were cast in the precinct, shall be directed to the county board of elections of  
20 the county in which the election is being held. One (1) copy of the return sheets or  
21 record of the voting equipment shall be given to the county clerk of the county in  
22 which the election is being held and to each of the local governing bodies of the two  
23 (2) dominant political parties, but a local governing body of a dominant political  
24 party may decline a copy of the precinct election return by filing a written  
25 declination with the county board of elections prior to the election, and upon this  
26 declination, a printed copy shall not be issued to the political party so declining. The  
27 declination on file shall be effective for that election and any subsequent elections

- 1 until revoked by the local governing body of a dominant political party by filing a  
2 written revocation with the county board of elections. The envelope shall have  
3 endorsed thereon a certificate of the election officers, stating the number of the  
4 machine, the precinct where it has been used, the number on the seal, and the  
5 number on the protective or accumulative counter or device at the close of the polls.
- 6 (7) Following the tabulation of all votes cast in the election, including absentee votes  
7 and write-in votes, the county board shall mail a copy of the precinct-by-precinct  
8 summary of the tabulation sheets showing the results from each precinct to the State  
9 Board of Elections and the county clerk shall mail or deliver the precinct signature  
10 rosters from each precinct to the State Board of Elections during the period  
11 established by KRS 117.355(3).
- 12 (8) As soon as possible after the completion of the count, the two (2) judges shall return  
13 to the county board of elections the keys to the voting machine received and  
14 receipted for by them, and the county clerk in which the precinct is located shall  
15 have the voting machine properly boxed or securely covered and removed to a  
16 proper and secure place of storage.
- 17 (9) In primaries, each candidate~~[, slate of candidates,]~~ or group of candidates may  
18 designate to the county board of elections a representative to witness and check the  
19 vote count. In regular elections, the governing authority of each political party, each  
20 candidate for member of board of education, nonpartisan candidate, independent  
21 candidate, or independent ticket may designate a representative to the county board  
22 of elections to witness and check the vote count. The county board of elections shall  
23 authorize representatives of the news media to witness the vote count.
- 24 (10) If supplemental paper ballots have been approved, as provided in KRS 118.215,  
25 after the polls are closed, the two (2) judges shall return to the county clerk's office  
26 the locked ballot box, all ballot stubs, spoiled ballots, and unvoted ballots at the  
27 same time as the tabulation of votes from the voting machine is delivered. The

1 county clerk shall issue a receipt for the number of ballot stubs, unvoted ballots,  
2 spoiled ballots and the ballot box.

3 (11) The county board of elections, or its designee, shall count and tally the paper ballots  
4 manually or with the use of tabulating equipment which does not involve an  
5 additional voting system. The results of the vote tally shall be certified by the  
6 county board of elections to the county clerk and to the Secretary of State.

7 (12) The county board of elections shall authorize the candidates, slates of candidates, or  
8 their representatives, and representatives of the news media to be present during the  
9 counting of the paper ballots.

10 (13) Except as otherwise required in this chapter that certain records and papers relating  
11 to specified elections be retained for twenty-two (22) months, the county clerk shall  
12 retain the voted paper ballots for twenty-two (22) months and the unvoted paper  
13 ballots for sixty (60) days after each election day, after which time they shall be  
14 destroyed in a manner to render them unreadable by the county board of elections if  
15 no contest or recount action has been filed.

16 ➔Section 5. KRS 118.025 is amended to read as follows:

17 (1) Except as otherwise provided by law, voting in all **primaries and** elections shall be  
18 by secret ballot on voting machines.

19 (2) The general laws applying to **primaries**, regular, ~~and~~ special ~~and primary~~  
20 elections shall apply to **primaries, regular, and special** elections conducted with the  
21 use of voting machines, and all provisions of the general laws applying to the  
22 custody of ballot boxes shall apply, as far as applicable, to the custody of the voting  
23 machine.

24 (3) **Primaries** ~~Primary elections~~ for the nomination of candidates ~~or slates of~~  
25 ~~candidates~~ to be voted for at the next regular election shall be held on the first  
26 Tuesday after the third Monday in May of each year.

27 (4) The election of all officers of all governmental units shall be held on the first

1 Tuesday after the first Monday in November.

2 (5) If the law authorizes the calling of a special election on a day other than the day of  
3 the regular election in November, the election shall be held on a Tuesday.

4 (6) If the law requires that a special election be held within a period of time during  
5 which the voting machines must be locked as required by KRS 117.295, the special  
6 election shall be held on the fourth Tuesday following the expiration of the period  
7 during which the voting machines are locked.

8 ➔Section 6. KRS 118.125 is amended to read as follows:

9 (1) Except as provided in KRS 118.155, any person who is qualified under the  
10 provisions of KRS 116.055 to vote in any primary for the candidates for nomination  
11 by the party at whose hands he or she seeks the nomination, shall have his or her  
12 name printed on the official ballot of his or her party for an office to which he is  
13 eligible in that primary, upon filing, with the Secretary of State or county clerk, as  
14 appropriate, at the proper time, a notification and declaration.

15 (2) The notification and declaration shall be in the form prescribed by the State Board  
16 of Elections. It shall be signed by the candidate and by not less than two (2)  
17 registered voters of the same party from the district or jurisdiction from which the  
18 candidate seeks nomination. Signatures for nomination papers shall not be affixed  
19 on the document to be filed prior to the first Wednesday after the first Monday in  
20 November of the year preceding the year in which the office will appear on the  
21 ballot.}

22 ~~(a) —}The notification and declaration for a candidate[ for an office other than~~  
23 ~~Governor or Lieutenant Governor]~~ shall include the following oath:

24 "For the purpose of having my name placed on the official primary  
25 election ballot as a candidate for nomination by the ----- Party, I, ----- (name  
26 in full as desired on the ballot as provided in KRS 118.129), do solemnly  
27 swear that my residence address is ----- (street, route, highway, city if



1 applicable, county, state, and zip code), that my mailing address, if different,  
 2 is ----- (post office address), and that I am a registered ----- (party) voter in ---  
 3 --- precinct; that I believe in the principles of the ----- Party, and intend to  
 4 support its principles and policies; that I meet all the statutory and  
 5 constitutional qualifications for the office which I am seeking; that if  
 6 nominated as a candidate of such party at the ensuing election I will accept the  
 7 nomination and not withdraw for reasons other than those stated in KRS  
 8 118.105(3); that I will not knowingly violate any election law or any law  
 9 relating to corrupt and fraudulent practice in campaigns or elections in this  
 10 state, and if finally elected I will qualify for the office."

11 The declaration shall be subscribed and sworn to before an officer authorized  
 12 to administer an oath by the candidate and by the two (2) voters making the  
 13 declaration and signing the candidate's petition for office.

14 ~~[(b) The notification and declaration for a slate of candidates for Governor and~~  
 15 ~~Lieutenant Governor shall include the following oath:~~

16 ~~----- "For the purpose of having our names placed on the official primary~~  
 17 ~~election ballot as a slate of candidates for Governor and Lieutenant Governor~~  
 18 ~~for nomination by the ----- Party, I, -----, (name of candidate for Governor in~~  
 19 ~~full as desired on the ballot as provided in KRS 118.129), do solemnly swear~~  
 20 ~~that my residence address is ----- (street, route, highway, city if applicable,~~  
 21 ~~county, state, and zip code), that my mailing address, if different, is ----- (post~~  
 22 ~~office address), and that I am a registered ----- (party) voter in ----- precinct;~~  
 23 ~~and I, -----, (name of candidate for Lieutenant Governor in full as desired on~~  
 24 ~~the ballot as provided in KRS 118.129), do solemnly swear that my residence~~  
 25 ~~address is ----- (street, route, highway, city if applicable, county, state, and zip~~

 3           offices which we are seeking; that we will accept the nomination and not  
 4           withdraw for reasons other than those stated in KRS 118.105(3); that we will  
 5           not knowingly violate any election law or any law relating to corrupt or  
 6           fraudulent practice in campaigns or elections in this state, and if finally elected  
 7           we will qualify for our offices."

8           ~~The declaration shall be subscribed and sworn to before an officer authorized~~  
 9           ~~to administer an oath by the candidate and by the two (2) voters making the~~  
 10           ~~declaration and signing the petition for office.]~~

11       (3) When the notice and declaration has been filed with the Secretary of State or county  
 12       clerk, as appropriate, and certified according to KRS 118.165, the Secretary of State  
 13       or county clerk, as appropriate, shall have the candidate's name printed on the ballot  
 14       according to the provisions of this chapter, except as provided in KRS 118.185.

15       (4) Titles, ranks, or spurious phrases shall not be accepted on the filing papers and shall  
 16       not be printed on the ballots as part of the candidate's name; however, nicknames,  
 17       initials, and contractions of given names may be acceptable as the candidate's name.

18       ➔Section 7. KRS 118.245 is amended to read as follows:

19       (1) The candidate for office~~[, other than the offices of Governor and Lieutenant~~  
 20       ~~Governor,]~~ receiving the highest number of votes in a primary~~[election]~~ for the  
 21       office for which he *or she* is a candidate shall be the nominee of his *or her* party for  
 22       that office and shall receive the certificate of nomination.

23       (2) ~~[The slate of candidates for Governor and Lieutenant Governor receiving the~~  
 24       ~~highest number of votes in a primary shall be the nominees of that party for~~  
 25       ~~Governor and Lieutenant Governor, and that slate of candidates shall receive the~~  
 26       ~~certificate of nomination.~~

27       ~~(3) ]If two (2) or more candidates[ or slates of candidates] in a primary[election] are~~

1 found to have received the highest and an equal number of votes for nomination to  
2 the same office, the election shall be determined by lot in the manner the board  
3 directs, in the presence of not less than three (3) other persons. This section does not  
4 apply to presidential primaries.

5 ➔Section 8. KRS 120.055 is amended to read as follows:

6 Any candidate~~[or slate of candidates]~~ for nomination to office at a primary~~[election]~~  
7 held under the provisions of KRS 118.015 to 118.035 and 118.105 to 118.255, or any  
8 candidate for nomination to a city office at a primary~~[election]~~ for which the statutes do  
9 not otherwise provide for determining contest elections, for whom a number of votes was  
10 cast equal to not less than fifty percent (50%) of the votes cast for the successful  
11 candidate~~[or slate of candidates]~~ for nomination to the office, may contest the right of the  
12 successful candidate~~[or slate of candidates]~~, and of any other candidate~~[or slate of~~  
13 ~~candidates]~~ for nomination to the office, to the nomination, by filing a petition in the  
14 Circuit Court within ten (10) days from the day of the primary~~[election]~~, stating the  
15 specific grounds relied upon for the contest, and causing a summons to be issued,  
16 returnable in seven (7) days. In the case of candidates~~[or slates of candidates]~~ for offices  
17 for the state at large, the petition shall be filed in the Franklin Circuit Court; in the case of  
18 other candidates it shall be filed in the Circuit Court of the county in which the contestee  
19 resides. The summons may be personally served on the contestee in any county, or it may  
20 be served by leaving a copy at his **or her** home with a member of his **or her** family over  
21 sixteen (16) years of age, or by posting a copy on the door of his **or her** residence. The  
22 contestee shall file his **or her** answer within seven (7) days after service of summons. The  
23 answer may contain grounds of contest in favor of the contestee and against the  
24 contestant, but the grounds shall be specifically set out. Any candidate~~[or slate of~~  
25 ~~candidates]~~ who would have been qualified to bring a contest action under this section,  
26 who is a party to a recount proceeding brought under KRS 120.095, may, by filing an  
27 answer in the recount proceeding within the time allowed by this section for filing

1 grounds of contest, set forth grounds of contest against the petitioner in the recount  
2 proceeding. No ground of contest by either party shall be filed or made more definite by  
3 amendment after the expiration of the time allowed by this section for filing the original  
4 pleading. The contestant may file a reply within five (5) days after answer is filed, which  
5 shall complete the pleading, and any affirmative matter in the reply shall be treated as  
6 controverted. Upon return of the summons, properly executed, to the office of the circuit  
7 clerk of the county in which the action is pending, the clerk shall immediately docket the  
8 cause and notify the presiding judge of the court that the contest has been instituted, and  
9 the judge shall proceed to a trial of the cause within five (5) days after the issue was  
10 joined. In judicial circuits having more than one (1) Circuit Judge, the judge who shall  
11 hear the cause shall be determined by lot.

12 ➔Section 9. KRS 120.095 is amended to read as follows:

13 (1) Any candidate~~[or slate of candidates]~~ voted for at a primary~~[election]~~ held under  
14 KRS 118.015 to 118.035 and 118.105 to 118.255 may request a recount of the  
15 ballots by filing a petition with the same court that contest petitions are required to  
16 be filed with, within ten (10) days after the day of the primary~~[election]~~, or, if the  
17 candidate~~[or slate of candidates]~~ is qualified to bring a contest proceeding under  
18 KRS 120.055, by including a request for a recount in his ***or her*** petition instituting  
19 the contest proceedings. Any candidate ***who***~~[or slate of candidates that]~~ is a  
20 contestee in a contest proceeding under KRS 120.055 may request a recount in his  
21 ***or her*** answer filed in the contest proceeding, but in that case the answer shall be  
22 filed within five (5) days after the service of process on the petition. When a request  
23 for a recount is made, the State Board of Elections or the county board of elections,  
24 whichever would issue the certificate of nomination, shall be made a party  
25 defendant. The party requesting the recount shall execute a bond with approved  
26 surety for the costs of the recount, in an amount to be fixed by the Circuit Judge.  
27 Upon the bond being filed, the clerk shall immediately notify the Circuit Judge of

1 the request and the filing of the bond, and the judge shall at once enter an order  
2 directing custody of the voting machines, the ballots, boxes, and all papers  
3 pertaining to the election to be transferred to the Circuit Court, and fix a day for the  
4 recount proceedings to begin. A copy of the order shall be served upon the parties or  
5 their counsel in the same manner as notices are required to be served, which shall be  
6 deemed sufficient notice of the proceeding. On the day fixed, the court shall  
7 proceed to recount the ballots if their integrity is satisfactorily shown and shall  
8 complete the recount as soon as practicable, and file and enter of record the results  
9 thereof, and direct the state board or county board, whichever would issue the  
10 certificate of nomination, to issue a certificate to the party entitled thereto as shown  
11 by the recount.

12 (2) Any party may appeal from the judgment to the Court of Appeals, in the same  
13 manner as provided in KRS 120.075, all of the provisions of which statute shall be  
14 applicable.

15 (3) If a proceeding for recount is asked and prosecuted in a contest proceeding, it shall  
16 not await the preparation or trial of the contest in the Circuit Court or in the Court  
17 of Appeals. The action of the courts shall be final, concluding the parties as to the  
18 question of a recount of the ballots, and certificates shall then be issued to the  
19 parties entitled thereto.

20 ➔Section 10. KRS 121.015 is amended to read as follows:

21 As used in this chapter:

22 (1) "Registry" means the Kentucky Registry of Election Finance;

23 (2) "Election" means any primary, regular, or special election to fill vacancies  
24 regardless of whether a candidate or slate of candidates is opposed or unopposed in  
25 an election. Each primary, regular, or special election shall be considered a separate  
26 election;

27 (3) "Committee" includes the following:

- 1 (a) "Campaign committee," which means one (1) or more persons who receive  
2 contributions and make expenditures to support or oppose one (1) or more  
3 specific candidates or slates of candidates for nomination or election to any  
4 state, county, city, or district office, but does not include an entity established  
5 solely by a candidate which is managed solely by a candidate and a campaign  
6 treasurer and whose name is generic in nature, such as "Friends of (the  
7 candidate)," and does not reflect that other persons have structured themselves  
8 as a committee, designated officers of the committee, and assigned  
9 responsibilities and duties to each officer with the purpose of managing a  
10 campaign to support or oppose a candidate in an election;
- 11 (b) "Caucus campaign committee," which means members of one (1) of the  
12 following caucus groups who receive contributions and make expenditures to  
13 support or oppose one (1) or more specific candidates or slates of candidates  
14 for nomination or election, or a committee:
- 15 1. House Democratic caucus campaign committee;
  - 16 2. House Republican caucus campaign committee;
  - 17 3. Senate Democratic caucus campaign committee;
  - 18 4. Senate Republican caucus campaign committee; or
  - 19 5. Subdivisions of the state executive committee of a minor political party,  
20 which serve the same function as the above-named committees, as  
21 determined by regulations promulgated by the registry;
- 22 (c) "Political issues committee," which means three (3) or more persons joining  
23 together to advocate or oppose a constitutional amendment or public question  
24 which appears on the ballot if that committee receives or expends money in  
25 excess of one thousand dollars (\$1,000);
- 26 (d) "Permanent committee," which means a group of individuals, including an  
27 association, committee, or organization, other than a campaign committee,

1 political issues committee, inaugural committee, caucus campaign committee,  
2 or party executive committee, which is established as, or intended to be, a  
3 permanent organization having as a primary purpose expressly advocating the  
4 election or defeat of one (1) or more clearly identified candidates, slates of  
5 candidates, or political parties, which functions on a regular basis throughout  
6 the year;

7 (e) An executive committee of a political party; and

8 (f) "Inaugural committee," which means one (1) or more persons who receive  
9 contributions and make expenditures in support of inauguration activities for  
10 any candidate or slate of candidates elected to any state, county, city, or  
11 district office;

12 (4) "Contributing organization" means a group which merely contributes to candidates,  
13 slates of candidates, campaign committees, caucus campaign committees, or  
14 executive committees from time to time from funds derived solely from within the  
15 group, and which does not solicit or receive funds from sources outside the group  
16 itself. However, any contributions made by the groups in excess of one hundred  
17 dollars (\$100) shall be reported to the registry;

18 (5) "Testimonial affair" means an affair held in honor of a person who holds or who is  
19 or was a candidate for nomination or election to a political office in this state  
20 designed to raise funds for any purpose not charitable, religious, or educational;

21 (6) "Contribution" means any:

22 (a) Payment, distribution, loan, deposit, or gift of money or other thing of value,  
23 to a candidate, his or her agent, a slate of candidates, its authorized agent, a  
24 committee, or contributing organization. As used in this subsection, "loan"  
25 shall include a guarantee, endorsement, or other form of security where the  
26 risk of nonpayment rests with the surety, guarantor, or endorser, as well as  
27 with a committee, contributing organization, candidate, slate of candidates, or

1 other primary obligor. No person shall become liable as surety, endorser, or  
2 guarantor for any sum in any one (1) election which, when combined with all  
3 other contributions the individual makes to a candidate, his or her agent, a  
4 slate of candidates, its agent, a committee, or a contributing organization,  
5 exceeds the contribution limits provided in KRS 121.150;

6 (b) Payment by any person other than the candidate, his or her authorized  
7 treasurer, a slate of candidates, its authorized treasurer, a committee, or a  
8 contributing organization, of compensation for the personal services of  
9 another person which are rendered to a candidate, slate of candidates,  
10 committee, or contributing organization, or for inauguration activities;

11 (c) Goods, advertising, or services with a value of more than one hundred dollars  
12 (\$100) in the aggregate in any one (1) election which are furnished to a  
13 candidate, slate of candidates, committee, or contributing organization or for  
14 inauguration activities without charge, or at a rate which is less than the rate  
15 normally charged for the goods or services; or

16 (d) Payment by any person other than a candidate, his or her authorized treasurer,  
17 a slate of candidates, its authorized treasurer, a committee, or contributing  
18 organization for any goods or services with a value of more than one hundred  
19 dollars (\$100) in the aggregate in any one (1) election which are utilized by a  
20 candidate, slate of candidates, committee, or contributing organization, or for  
21 inauguration activities;

22 (7) Notwithstanding the foregoing meanings of "contribution," the word shall not be  
23 construed to include:

24 (a) Services provided without compensation by individuals volunteering a portion  
25 or all of their time on behalf of a candidate, a slate of candidates, committee,  
26 or contributing organization;

27 (b) A loan of money by any financial institution doing business in Kentucky made



1 in accordance with applicable banking laws and regulations and in the  
 2 ordinary course of business; or

3 (c) An independent expenditure by any individual or permanent committee;

4 (8) "Candidate" means any person who has received contributions or made  
 5 expenditures, has appointed a campaign treasurer, or has given his or her consent  
 6 for any other person to receive contributions or make expenditures with a view to  
 7 bringing about his or her nomination or election to public office, except federal  
 8 office;

9 (9) "Slate of candidates" means:

10 (a) Between the time a certificate or petition of nomination has been filed for a  
 11 candidate for the office of Governor under KRS 118.365 and the time the  
 12 candidate designates a running mate for the office of Lieutenant Governor  
 13 under Section 1 of this Act, a slate of candidates consists of the candidate  
 14 for the office of Governor; and

15 (b) After that candidate has designated a running mate under Section 1 of this  
 16 Act, that same slate of candidates consists of that same candidate for the  
 17 office of Governor and the candidate's running mate for the office of  
 18 Lieutenant Governor~~[ any two (2) persons who have filed a joint notification~~  
 19 ~~and declaration pursuant to KRS 118.127, received contributions or made~~  
 20 ~~expenditures, appointed a campaign treasurer, designated a campaign~~  
 21 ~~depository, or given their consent for any other person to receive contributions~~  
 22 ~~or make expenditures with a view to bringing about their nomination for~~  
 23 ~~election to the offices of Governor and Lieutenant Governor].~~

24 Unless the context requires otherwise, any provision of law that applies to a  
 25 candidate shall also apply to a slate of candidates;

26 (10) "Knowingly" means, with respect to conduct or to a circumstance described by a  
 27 statute defining an offense, that a person is aware or should have been aware that

1 his or her conduct is of that nature or that the circumstance exists;

2 (11) "Fundraiser" means an individual who directly solicits and secures contributions on  
3 behalf of a candidate or slate of candidates for a statewide-elected state office or an  
4 office in a jurisdiction with a population in excess of two hundred thousand  
5 (200,000) residents;

6 (12) "Independent expenditure" means the expenditure of money or other things of value  
7 for a communication which expressly advocates the election or defeat of a clearly  
8 identified candidate or slate of candidates, and which is made without any  
9 coordination, consultation, or cooperation with any candidate, slate of candidates,  
10 campaign committee, or any authorized person acting on behalf of any of them, and  
11 which is not made in concert with, or at the request or suggestion of any candidate,  
12 slate of candidates, campaign committee, or any authorized person acting on behalf  
13 of any of them;

14 (13) "Electronic reporting" means the use of technology, having electrical, digital,  
15 magnetic, wireless, optical, electromagnetic, or similar capabilities, by which an  
16 individual or other entity submits, compiles, or transmits campaign finance reports  
17 to the registry, or by which the registry receives, stores, analyzes, or discloses the  
18 reports;

19 (14) "Security procedure" means a procedure employed for the purpose of verifying that  
20 an electronic signature, record, or performance is that of a specific person or for  
21 detecting changes or errors in the information in an electronic record. The term  
22 includes a procedure that requires the use of algorithms or other codes, identifying  
23 words or numbers, encryption, or callback or other acknowledgment procedures;

24 (15) "Electronic signature" means an electronic sound, symbol, or process attached to or  
25 logically associated with a record and executed or adopted by a person with the  
26 intent to sign the record;

27 (16) "Filer" means any candidate, a slate of candidates, committee, or other individual or

1 entity required to submit financial disclosure reports to the registry; and

2 (17) "Filer-side software" means software provided to or used by the filer that enables  
3 transmittal of financial reports to the registry.

4 ➔Section 11. KRS 121.170 is amended to read as follows:

5 (1) Any committee, except a federally registered out-of-state permanent committee,  
6 organized under any provisions of this chapter shall register with the registry, by  
7 filing official notice of intention at the time of organization, giving names,  
8 addresses, and positions of the officers of the organization, identifying an official  
9 contact person of the committee, and designating the candidate or candidates, slate  
10 of candidates, or question it is organized to support or oppose on forms prescribed  
11 by the registry; except that no campaign committee for a slate of candidates for  
12 Governor and Lieutenant Governor shall be registered prior to the filing of a

15 ~~KRS 118.125 and 118.127~~. No entity which is excluded from the definition of  
16 "campaign committee" established in KRS 121.015(3)(a) shall be required to

18 reasonably identify to the public the sponsorship and purpose of the committee. The  
19 forms filed with the registry shall require the registrant to clearly identify the  
20 specific purpose, sponsorship, and source from which the committee originates; and  
21 the registry shall refuse to allow filing by any committee until this requirement has  
22 been satisfied.

23 (2) Any person who acts as a fundraiser by directly soliciting contributions for an  
24 election campaign of a candidate or slate of candidates for statewide-elected state  
25 office or an office in a jurisdiction containing in excess of two hundred thousand

27 three thousand dollars (\$3,000) in any one (1) election for the campaign committee

4 prescribed by the registry. A registered fundraiser shall comply with the campaign  
5 finance reporting requirements of KRS 121.180(3), (4), and (5).

6 (3) All provisions of KRS 121.160 governing the duties and responsibilities of a  
7 candidate, slate of candidates, or campaign treasurer shall apply to a registered  
8 committee, except a federally registered out-of-state permanent committee, and a  
9 person acting as a campaign fundraiser. In case of the death, resignation, or removal  
10 of a campaign treasurer for a permanent committee or executive committee, the  
11 chairperson of the permanent committee or executive committee shall, within three  
12 (3) days after receiving notice of the vacancy by certified mail, appoint a successor  
13 as treasurer for the committee and file the name and address of the successor with  
14 the registry. The chairperson of the permanent committee or executive committee

24 report when a contribution is made to a Kentucky candidate or a slate of

26 (c) Contribute not more than the maximum amount permitted for a permanent  
27 committee to make under Kentucky law to any candidate or to any slate of

1 candidates for any office in this Commonwealth.

2 (6) Notwithstanding any provision of law to the contrary, a contribution made by a  
3 federally registered permanent committee to any candidate or to any slate of  
4 candidates for any office in this Commonwealth that complies with the provisions  
5 of 2 U.S.C. sec. 441b, 11 C.F.R. sec. 104.10, 11 C.F.R. sec. 106.6, and 11 C.F.R.  
6 sec. 114.1-114.12 regarding limitations on contributions by corporations shall be  
7 deemed to comply with the campaign finance laws of this Commonwealth  
8 prohibiting corporate contributions to candidates or slates of candidates.

9 (7) The organization, formation, or registration of a permanent committee by any  
10 member of the General Assembly shall be prohibited.

11 (8) The official contact person of a permanent committee shall not be a legislative agent  
12 as defined in KRS 6.611 or an executive agency lobbyist as defined in KRS  
13 11A.201.
