

1 AN ACT relating to personalized motor vehicles license plates.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 186.174 is amended to read as follows:

- 4 (1) For purposes of this section, "personalized license plate" means a license plate
5 manufactured by the cabinet upon an applicant's request with specific letters or
6 numbers or combinations of letters and numbers significant to the applicant.
- 7 (2) Any owner or lessee of a motor vehicle ***or recreational vehicle*** that is required to
8 be registered under the provisions of KRS 186.050(1), (3)(a), ~~for~~(4)(a), or ***(11), or***
9 any owner or lessee of a motorcycle required to be registered under the provisions
10 of KRS 186.050(2) may obtain a personalized license plate by submitting an
11 application through a Web site designated by the cabinet. The cabinet shall produce
12 the requested license plate upon approval and receipt of the fee required in
13 subsection (4) of this section for a special license plate, or the fee required in KRS
14 186.162 for a standard issue license plate.
- 15 (3) Personalized license plates shall expire on the last day of the birth month of the
16 person to whom the license plate is registered.
- 17 (4) (a) A personalized license plate shall be replaced on the same schedule as regular
18 issue license plates unless it is damaged or unreadable.
- 19 (b) A standard issued license plate may be personalized for a forty-three dollar
20 (\$43) fee as provided in KRS 186.162(2)(m), in addition to all other fees
21 established in this section and in KRS 186.050.
- 22 (c) Any special license plate may be combined with a personalized license plate
23 for a twenty-five dollar (\$25) state fee in addition to all other fees for the
24 particular special license plate established in this section and in KRS 186.164.
25 The twenty-five dollar (\$25) fee required under this paragraph shall be
26 divided between the cabinet and the county clerk of the county where the
27 applicant resides with the cabinet receiving twenty dollars (\$20) and the

1 county clerk receiving five dollars (\$5).

2 (5) (a) A personalized plate shall not be issued that would conflict with or duplicate
3 any current issued license plate.

4 (b) A personalized plate shall not be issued if the cabinet determines:

5 1. The message to be placed on the license plate, if created, discriminates
6 against a race, color, religion, sex, or national origin;

7 2. The plate message is the name of a trademarked or copyrighted product
8 or brand name; or

9 3. The plate's lettering or message is obscene or profane, as determined by
10 the cabinet.

11 (c) Once an applicant obtains a personalized plate, he or she will have first
12 priority on that plate for each of the following years that he or she makes
13 timely renewal payments.

14 ➔Section 2. KRS 186.162 is amended to read as follows:

15 (1) As used in this section and in KRS 186.043, 186.164, 186.166, 186.1722, and
16 186.174:

17 (a) "Special license plate" means a unique license plate issued under this chapter
18 to a group or organization that readily identifies the operator of the motor
19 vehicle or motorcycle bearing the plate as a member of a group or
20 organization, or a supporter of the work, goals, or mission of a group or
21 organization. The term shall not include regular license plates issued under
22 KRS 186.240;

23 (b) "Street rod" means a modernized private passenger motor vehicle
24 manufactured prior to the year 1949, or designed or manufactured to resemble
25 a vehicle manufactured prior to 1949;

26 (c) "SF" means the portion of an initial or renewal fee to obtain a special license
27 plate that is dedicated for use by the Transportation Cabinet;

1 (d) "CF" means the county clerk's fee for issuing a motor vehicle registration as
 2 established under KRS 186.040(1). If a CF amount is charged for a license
 3 plate listed in this section, the applicant for that plate shall also pay the fees
 4 identified in KRS 186.040(6). If a CF amount is not charged, the applicant
 5 shall not be required to pay those fees; and

6 (e) "EF" means the portion of an initial or renewal fee to obtain a special license
 7 plate that is mandated by this chapter to be dedicated for use by a particular
 8 group or organization.

9 (2) The initial purchase fee and renewal fee for a special license plate created under this
 10 chapter shall be as established in this subsection and includes the name of group or
 11 organization and the total initial and renewal fee required for the plate. The amount
 12 in parentheses indicates how the total fee is required to be divided:

13 (a) Disabled veterans who receive assistance to purchase a vehicle from the
 14 United States Department of Veterans' Affairs, veterans declared by the
 15 United States Department of Veterans' Affairs to be one hundred percent
 16 (100%) service-connected disabled, and recipients of the Congressional
 17 Medal of Honor:

- 18 1. Initial Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).
- 19 2. Renewal Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).

20 (b) Former prisoners of war and survivors of Pearl Harbor:

- 21 1. Initial Fee: \$23 (\$12 SF/\$6 CF/\$5 EF to the veterans'
 22 program trust fund established under KRS 40.460).
- 23 2. Renewal Fee: ~~\$11+\$6~~ (\$0 SF/\$6 CF/~~\$5+\$0~~ EF to the
 24 veterans' program trust fund established under KRS 40.460).

25 (c) Members of the Kentucky National Guard and recipients of the Purple Heart:

- 26 1. Initial Fee: \$23 (\$12 SF/\$6 CF/\$5 EF to the veterans'
 27 program trust fund established under KRS 40.460).

- 1 1. Initial Fee for two plates: \$56 (\$50 SF/\$6 CF/\$0 EF).
- 2 2. Renewal Fee: Do not renew annually.
- 3 (h) Members of Congress:
- 4 1. Initial Fee: \$43 (\$37 SF/\$6 CF/\$0 EF).
- 5 2. Renewal Fee: \$23 (\$12 SF/\$6 CF/\$5 EF to the veterans'
- 6 program trust fund established under KRS 40.460).
- 7 (i) Firefighters:
- 8 1. Initial Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the Kentucky
- 9 Firefighters Association).

- 12 (j) Emergency management:
- 13 1. Initial Fee: \$31 (\$25 SF/\$6 CF/\$0 EF).

- 16 1. Initial Fee: \$41 (\$25 SF/\$6 CF/\$10 EF to the Kentucky

- 19 FOP Death Benefit Fund).
- 20 (l) Law Enforcement Memorial:

- 27 (t) Collegiate plates:

- 1 1. Initial Fee: \$53 (\$37 SF/\$6 CF/\$10 EF to the general
2 scholarship fund of the university whose name will be borne on the
3 plate).
- 4 2. Renewal Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the general
5 scholarship fund of the university whose name will be borne on the
6 plate).
- 7 (u) Independent Colleges:
- 8 1. Initial Fee: \$41 (\$25 SF/\$6 CF/\$10 EF to the Association of
9 Independent Kentucky Colleges and Universities for distribution to the
10 general scholarship funds of the Association's members).
- 11 2. Renewal Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the Association of
12 Independent Kentucky Colleges and Universities for distribution to the
13 general scholarship funds of the Association's members).
- 14 (v) Child Victims:
- 15 1. Initial Fee: \$41 (\$25 SF/\$6 CF/\$10 EF to the child victims'
16 trust fund established under KRS 41.400).
- 17 2. Renewal Fee: ~~\$28~~~~[\$23]~~ (\$12 SF/\$6 CF/~~\$10~~~~[\$5]~~ EF to the
18 child victims' trust fund established under KRS 41.400).
- 19 (w) Kentucky Horse Council:

- 27 2. Renewal Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to Kentucky Ducks

1 Unlimited).

2 (y) Spay neuter:

3 1. Initial Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the animal control
4 and care fund established under KRS 258.119).

5 2. Renewal Fee: ~~\$28~~[\$23] (\$12 SF/\$6 CF/~~\$10~~[\$5] EF to the
6 animal control and care fund established under KRS 258.119).

7 (z) Gold Star Mothers, Gold Star Fathers, or Gold Star Spouses:

8 1. Initial Fee: \$0 (\$0 SF/\$0 CF/ \$0 EF).

9 2. Renewal Fee: \$0 (\$0 SF/\$0 CF/ \$0 EF).

10 3. A person may receive a maximum of two (2) plates under this paragraph
11 free of charge and may purchase additional plates for fees as established
12 in subsection (2)(d) of this section.

13 (aa) I Support Veterans:

14 1. Initial Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the Kentucky
15 Department of Veterans' Affairs).

16 2. Renewal Fee: ~~\$28~~[\$23] (\$12 SF/\$6 CF/~~\$10~~[\$5] EF to the
17 Kentucky Department of Veterans' Affairs).

18 (ab) Gold Star Siblings, Gold Star Sons, or Gold Star Daughters:

19 1. Initial Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the veterans'
20 program trust fund established under KRS 40.460).

21 2. Renewal Fee: ~~\$28~~[\$23] (\$12 SF/\$6 CF/~~\$10~~[\$5] EF to the
22 veterans' program trust fund established under KRS 40.460).

23 (ac) POW/MIA Awareness:

24 1. Initial Fee: \$41 (\$25 SF/\$6 CF/\$10 EF to the veterans'
25 program trust fund established under KRS 40.460).

26 2. Renewal Fee: \$28 (\$12 SF/\$6 CF/\$10 EF to the veterans'
27 program trust fund established under KRS 40.460).

1 (ad) Personalized plates for a recreational vehicle that is required to be
2 registered under the provisions of KRS 186.050(11):

3 1. Initial Fee: \$51 (\$45 SF/\$6 CF/\$0 EF).

4 2. Renewal Fee: \$51 (\$45 SF/\$6 CF/\$0 EF).

5 (ae) Special license plates established under KRS 186.164:

6 1. Initial Fee: \$41 (\$25 SF/\$6 CF/\$10 EF).

7 2. Renewal Fee: \$41 (\$25 SF/\$6 CF/\$10 EF).

8 (3) Any special license plate may be combined with a personalized license plate for a
9 twenty-five dollar (\$25) state fee in addition to all other fees for the particular
10 special license plate established in this section and in KRS 186.164(3). The twenty-
11 five dollar (\$25) fee required under this subsection shall be divided between the
12 cabinet and the county clerk of the county where the applicant is applying for the
13 license plate with the cabinet receiving twenty dollars (\$20) and the county clerk
14 receiving five dollars (\$5).

15 (4) (a) A sponsoring organization of any special license plate issued under this
16 section or any special license plate established under the provisions of KRS
17 186.164 may petition the cabinet for the production of that special license
18 plate for motorcycles.

19 (b) Owners and lessees of motorcycles registered under KRS 186.050(2) may be
20 eligible to receive special license plates approved by the cabinet under
21 paragraph (a) of this subsection. Applicants for a special license plate for a
22 motorcycle shall be required to pay the fee for a special plate as prescribed in
23 this section or in KRS 186.164. The fee paid for the special plate for a
24 motorcycle shall be in lieu of the registration fee required under KRS
25 186.050(2).
