

1 AN ACT relating to real property boards.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 324B IS CREATED TO
4 READ AS FOLLOWS:

5 *(1) (a) The Division of Real Property Boards is hereby created within the*
6 *Department of Professional Licensing and shall include the:*

7 *1. Kentucky Board of Home Inspectors, established under Section 6 of*
8 *this Act;*

9 *2. Real Estate Appraisers Board, established under Section 10 of this*
10 *Act; and*

11 *3. Board of Auctioneers, established under Section 17 of this Act.*

12 *(b) The Division of Real Property Boards shall be managed by a director, who*
13 *shall be appointed by the secretary of the Public Protection Cabinet with*
14 *prior written approval of the Governor. The director shall be exempted from*
15 *the classified service.*

16 *(c) The Division of Real Property Boards may:*

17 *1. Provide appropriate attorneys, personnel staffing, and administrative*
18 *support to the real property boards identified in paragraph (a) of this*
19 *subsection;*

20 *2. Establish and maintain an office, meeting space, office supplies,*
21 *furniture, storage space, and any other supplies that are necessary to*
22 *carry out the duties of the Division of Real Property Boards and the*
23 *real property boards identified in paragraph (a) of this subsection;*

24 *3. Make available for public inspection all decisions, opinions, and*
25 *interpretations formulated or used by the division and the real*
26 *property boards identified in paragraph (a) of this subsection in*
27 *discharging their functions;*

- 1 4. Publicize the functions and purposes of the Division of Real Property
2 Boards and the real property boards identified in paragraph (a) of this
3 subsection;
- 4 5. Employ administrative coordinators who shall carry out the
5 administrative functions and day-to-day operations of the real
6 property boards identified in paragraph (a) of this subsection. The
7 maximum number of administrative coordinators shall be one (1) for
8 each real property board. These administrative coordinators shall be
9 exempted from the classified service; and
- 10 6. Enter into agreements with any state agency, political subdivision of
11 the state, postsecondary education institution, or other person or entity
12 to assist with implementation of the duties and responsibilities of the
13 Division of Real Property Boards or, upon request, the real property
14 boards identified in paragraph (a) of this subsection.
- 15 (2) The director of the Division of Real Property Boards shall:
- 16 (a) Provide oversight of the Division of Real Property Boards;
- 17 (b) Review and provide feedback on any administrative regulation proposed by
18 any of the boards within the Division of Real Property Boards prior to the
19 promulgation of the administrative regulation;
- 20 (c) Review and provide feedback on the budgets and expenditures of the boards
21 within the Division of Real Property Boards;
- 22 (d) Submit written recommendations to the secretary of the Public Protection
23 Cabinet concerning sufficient staffing needs and relevant experience
24 necessary to assist in carrying out the mission and function of the Division
25 of Real Property Boards;
- 26 (e) Pursuant to KRS 13B.120(7), automatically hear and issue a final order
27 regarding any decision of a real property board that would otherwise be

1 subject to appeal. An aggrieved party may appeal a final order of the
 2 director pursuant to KRS Chapter 13B within thirty (30) days after the
 3 issuance of the order to the Circuit Court of the county where the party has
 4 his or her principal place of business or where the party resides;

5 (f) Make available for public inspection all decisions, opinions, and
 6 interpretations formulated or used by the director in discharging his or her
 7 functions;

8 (g) Carry out the applicable policy and program directives of the department;

9 (h) Prepare annual reports on the director's activities;

10 (i) Delegate any power to employees and contractors as needed;

11 (j) Have a minimum of seven (7) years of experience in the real estate industry
 12 within the last fifteen (15) years; and

13 (k) Perform all other duties assigned by law.

14 (3) The secretary of the Public Protection Cabinet shall:

15 (a) Consider the staffing recommendations and requests submitted by the
 16 director of the Division of Real Property Boards; and

17 (b) Provide the Division of Real Property Boards with documentation showing
 18 the income and expenditures of all license fees.

19 ➔Section 2. KRS 198B.724 is amended to read as follows:

20 The board shall promulgate administrative regulations in accordance with KRS Chapter
 21 13A concerning the continuing education required for the renewal of a home inspector
 22 license and shall:

23 (1) Establish procedures for approving organizations that provide continuing education;
 24 and

25 (2) Prescribe the content, duration, and organization of continuing education courses
 26 that contribute to the competence of home inspectors.

27 (3) (a) A licensee who has initiated continuing education courses prior to the date

1 *established through an administrative regulation promulgated by the board*
2 *in accordance with KRS Chapter 13A shall have five (5) days after the*
3 *established date to complete them.*

4 *(b) The board may not cancel a license for failure to complete continuing*
5 *education courses until ten (10) days after the date established by the board.*

6 ➔Section 3. KRS 324.085 is amended to read as follows:

- 7 (1) (a) All actively licensed agents, except those licensees exempt under KRS
8 324.046(5) and those licensees satisfying the educational requirement in
9 subsection (2) of this section, shall successfully complete twelve (12)
10 classroom or online hours of continuing education for the biennial license
11 period. Six (6) of the twelve (12) hours shall be completed in the first year of
12 the biennial license period or the license shall be automatically cancelled.
- 13 (b) Six (6) of the twelve (12) hours of continuing education shall be in real estate
14 law.
- 15 (c) A licensee may accumulate additional continuing education hours for the
16 biennial period in the first year of the biennial term.
- 17 (d) Six (6) of the twelve (12) hours of continuing education may be in real estate-
18 related courses approved by the commission and other real property boards
19 pursuant to KRS Chapters 324A and 330 and KRS 198B.700 to 198B.738.
- 20 (2) A licensee who is issued an initial sales associate license after January 1, 2016,
21 shall complete forty-eight (48) classroom or online hours of commission-approved
22 post-license education:
- 23 (a) Provided by one (1) or a combination of the following:
- 24 1. An accredited institution; or
- 25 2. A commission-approved:
- 26 a. Real estate school; or
- 27 b. Broker-affiliated training program; and

1 (b) Within two (2) years of receiving or activating his or her license unless
2 extended by the commission for good cause shown.

3 (3) The license held by any licensee failing to complete his or her sales associate post-
4 license education requirements in accordance with subsection (2) of this section
5 shall be automatically canceled, in accordance with administrative regulations
6 establishing compliance and delinquency procedures.

7 (4) The commission shall promulgate administrative regulations to establish procedures
8 for implementing the requirements in this section.

9 (5) In order to qualify to teach continuing education or post-license courses, all
10 continuing education and post-license instructors shall maintain a minimum rating
11 as prescribed by the commission by the promulgation of administrative regulations.

12 **(6) (a) A licensee who has initiated continuing education courses prior to the date**
13 **established through an administrative regulation promulgated by the**
14 **commission in accordance with KRS Chapter 13A shall have five (5) days**
15 **after the established date to complete them.**

16 **(b) The commission may not cancel a license for failure to complete continuing**
17 **education courses until ten (10) days after the date established by the**
18 **commission.**

19 ➔Section 4. KRS 324A.045 is amended to read as follows:

20 (1) The board shall issue to each qualified applicant a certificate or license in form and
21 size as shall be prescribed by the board.

22 (2) Every certificate and license shall be subject to annual renewal on the date or dates
23 determined by the board by administrative regulation. Each certificate and license
24 holder shall submit proof of compliance with the continuing education requirements
25 when appropriate and the annual renewal fee to the board on or before the last day
26 of the designated month. Failure to receive a renewal form shall not constitute an
27 adequate excuse for failure to renew on time.

1 (3) If the certificate or license holder fails to renew in a timely manner, the certificate
2 or license shall expire. Within six (6) months after the renewal date, the former
3 certificate or license holder shall be reinstated by complying with all appropriate
4 renewal requirements and paying a late fee not to exceed two hundred dollars
5 (\$200).

6 (4) If six (6) months or more elapse after the renewal date, the former certificate or
7 license holder shall be required to meet all current requirements as if applying for
8 initial certification or licensure.

9 **(5) (a) A licensee who has initiated continuing education courses prior to the date**
10 **established through an administrative regulation promulgated by the board**
11 **in accordance with KRS Chapter 13A shall have five (5) days after the**
12 **established date to complete them.**

13 **(b) The board may not cancel a license for failure to complete continuing**
14 **education courses until ten (10) days after the date established by the board.**

15 ➔Section 5. KRS 330.070 is amended to read as follows:

16 (1) An apprentice auctioneer applying for an auctioneer license shall, subject to the
17 provisions of KRS 330.060:

18 (a) Possess a current Kentucky apprentice auctioneer license;

19 (b) Serve an apprenticeship for a period of one (1) year as an apprentice
20 auctioneer in Kentucky;

21 (c) Submit a statement to the board, signed by the principal auctioneer, verifying
22 that the applicant has actively and materially participated in at least ten (10)
23 auctions prior to application; and

24 (d) Successfully complete at least eighty (80) hours of approved classroom
25 instruction from a board-approved auction education provider. The board may
26 waive the eighty (80) hours of approved classroom instruction requirement if
27 the applicant demonstrates sufficient previous auction experience and

- 1 competency by affidavit or other evidence as required by the board.
- 2 (2) An apprentice auctioneer with an original license issued prior to June 30, 2010, or
3 after July 1, 2015, shall be required to successfully complete the auctioneer
4 examination.
- 5 (3) If an applicant for an auctioneer license resides in a state which does not have a
6 current reciprocity agreement with the board, the board may waive the eighty (80)
7 hour education requirement or the apprenticeship requirement, or both, if the
8 applicant demonstrates sufficient previous auction experience and competency by
9 affidavit or by other evidence as required by the board.
- 10 (4) An applicant for an auctioneer license who has previously held an auctioneer
11 license which has been revoked, suspended, or which has expired without renewal
12 may request, and the board may grant, a waiver of the requirement of possession of
13 a current apprentice license.
- 14 (5) Every application for a license issued by the board shall be submitted on forms
15 prepared by the board. Each applicant shall furnish pertinent background data as
16 outlined on those forms.
- 17 (6) The board shall promulgate administrative regulations in accordance with KRS
18 Chapter 13A to establish an initial license fee and biennial renewal license fee. The
19 initial license fee shall not exceed one hundred fifty dollars (\$150) and the biennial
20 renewal fee shall not exceed three hundred dollars (\$300).
- 21 (a) All licenses shall expire on the thirtieth day of June of each even year.
- 22 (b) Each license shall be renewed on or before the expiration date.
- 23 (c) In addition to the renewal fee, a late fee shall be established by administrative
24 regulations promulgated by the board on each license renewed within six (6)
25 months after the expiration date.
- 26 (d) In the absence of any reason or condition which might warrant the refusal of
27 renewing a license, and upon timely receipt of the renewal form and the

1 biennial fee, the board shall issue a license for the remainder of the ensuing
2 biennial license period.

3 (7) (a) The board may require as a condition precedent to the renewal of any license,
4 that each licensee complete continuing education up to ten (10) hours per
5 license year. The board may impose different continuing education
6 requirements upon different classifications of licenses under this chapter. The
7 continuing education requirements in this subsection shall not apply to those
8 auctioneers licensed prior to January 1, 1980.

9 (b) A licensee who has not completed the required continuing education may,
10 within the time period set forth in subsection (6) and (12) of this section,
11 remit a fee established by administrative regulations promulgated by the board
12 with the applicable renewal fees, and the continuing education reporting
13 requirement shall be deferred to the next biennial renewal. If the licensee fails
14 to meet the continuing education requirement for the next biennial renewal,
15 the licensee shall successfully complete the examination before renewal of his
16 or her license.

17 (c) 1. The board may require all licensees to complete a six (6) hour board-
18 approved core course once every four (4) years, that includes the core
19 subjects of Kentucky auction statutes and regulations, ethics, and any
20 other subject matter deemed appropriate by the board.

21 2. Effective July 1, 2016, each licensee with at least twenty-five (25) years
22 of continuous licensure shall be exempt from the requirements of this
23 paragraph.

24 (8) (a) The board shall ensure that licensees may access a copy of their license
25 certificate via an electronic portal account.

26 (b) Auction house operators shall display their licenses conspicuously and at all
27 times in the auction house identified on the license.

1 (c) All licensees shall carry a copy of their license, or a digital facsimile thereof,
2 when performing auctioneering tasks, to be shown upon request.

3 (9) When an apprentice auctioneer is discharged or voluntarily terminates employment
4 with the auctioneer for any reason:

5 (a) It shall be the immediate duty of the principal auctioneer to deliver to the
6 board a written release of the apprentice auctioneer; and

7 (b) The apprentice auctioneer shall affiliate with a principal auctioneer within
8 thirty (30) days by submitting to the board an affiliation letter signed by the
9 new principal auctioneer and a fee established by administrative regulations
10 promulgated by the board in accordance with KRS Chapter 13A.

11 An apprentice auctioneer shall not perform any of the acts regulated by this chapter
12 until receiving a new license bearing a new principal auctioneer's name and address.

13 (10) (a) A licensee may place his or her license in escrow with the board if the
14 licensee does not engage in any board-regulated auctioneering activity and
15 continues to pay the biennial renewal license fee.

16 (b) For each year the license is in escrow, a licensee shall be exempt from the
17 contribution to the auctioneer's education, research, and recovery fund and the
18 continuing education requirement.

19 (c) To reactivate a license in escrow, the licensee shall complete the core course
20 and pay a reactivation fee and the biennial renewal recovery fee, both of
21 which shall be established by administrative regulations promulgated by the
22 board in accordance with KRS Chapter 13A.

23 (11) Notice in writing shall be given to the board by each licensee of any change of
24 principal business location or residence address within ten (10) days of the change,
25 and the board shall issue an updated license for the unexpired period. The board
26 may fine, suspend, or revoke the license of a licensee who does not notify the board
27 of a change of address within ten (10) days. Changing a business or a residence

1 address on its records shall entitle the board to collect a fee established by
2 administrative regulations promulgated by the board in accordance with KRS
3 Chapter 13A.

4 **(12) (a) A licensee who has initiated continuing education courses prior to the date**
5 **established through an administrative regulation promulgated by the board**
6 **in accordance with KRS Chapter 13A shall have five (5) days after the**
7 **established date to complete them.**

8 **(b) The board may not cancel a license for failure to complete continuing**
9 **education courses until ten (10) days after the date established by the board.**

10 ➔Section 6. KRS 198B.704 is amended to read as follows:

11 (1) (a) There is hereby created an independent agency of state government to be
12 known as the Kentucky Board of Home Inspectors, which shall be attached to
13 the Department of Professional Licensing for administrative purposes. The
14 board shall consist of five (5) members, each appointed by the Governor.
15 Each board member shall serve a term of three (3) years. The board shall
16 annually select one (1) of its members to serve as chair and one (1) of its
17 members to serve as vice chair to act in the chair's absence. The board shall
18 designate either a board member or a member of the board's administrative
19 staff to serve as secretary to the board.

20 (b) Any member appointed to fill a vacancy occurring other than by expiration of
21 a term shall be appointed for the remainder of the unexpired term.

22 (c) No more than three (3) members of the same political party shall serve on the
23 board at the same time.

24 (d) No member of the board shall reside in the same county as another member.
25 The members of the board shall be residents of Kentucky.

26 (e) 1. A majority of the board shall constitute a quorum for the transaction of
27 business. The affirmative vote of a majority of the members is necessary

- 1 for the board to take official action.
- 2 2. If the chair and vice chair are absent from a meeting of the board when a
3 quorum exists, the members who are present may elect a presiding
4 officer who shall serve as acting chair until the conclusion of the
5 meeting or until the arrival of the chair or vice chair.
- 6 (f) No member may serve on the board for more than six (6) consecutive years. A
7 member may serve on the board for six (6) consecutive years on more than
8 one (1) occasion if that person is not a member of the board for at least two
9 (2) years between periods of board service.
- 10 (2) The five (5) members of the board shall be chosen as follows:
- 11 (a) Three (3) members shall:
- 12 1. Have been actively engaged in performing home inspections in
13 Kentucky for at least five (5) years immediately before the member's
14 appointment to the board, or have completed no less than one hundred
15 (100) fee-paid inspections per year over the last five (5) years; and
- 16 2. Be licensed by the board as a home inspector;
- 17 (b) One (1) member shall represent the public at large and shall not be associated
18 with the home inspection, home building, or real estate business other than as
19 a consumer; and
- 20 (c) One (1) member shall be a real estate professional licensed under KRS
21 Chapter 324 who has been actively engaged in selling, trading, exchanging,
22 optioning, leasing, renting, managing, or listing residential real estate in
23 Kentucky for at least five (5) years immediately before the member's
24 appointment to the board. This member shall be selected from a list of three
25 (3) names submitted to the Governor from the Kentucky Association of
26 Realtors. When a vacancy occurs in this member position, the Kentucky
27 Association of Realtors shall have sixty (60) days after the vacancy occurs to

1 submit a list of three (3) names to the Governor to fill the vacancy. The
2 Governor may reject the list of three (3) names and request that the Kentucky
3 Association of Realtors submit a new list of three (3) names within sixty (60)
4 days of the Governor's request. If the Kentucky Association of Realtors fails
5 to timely submit this list to the Governor, the Governor may immediately
6 appoint a qualified person to fill this vacancy.

- 7 (3) A board member shall be automatically removed from the board and a vacancy
8 shall occur when the board member:
- 9 (a) Ceases to be a resident of the Commonwealth of Kentucky;
 - 10 (b) Displays incompetence, neglect of duty, or unprofessional conduct;
 - 11 (c) Fails to adhere to a duly adopted code of ethics of the board. Failure to adhere
12 to this code shall be determined by official action of the board;
 - 13 (d) Enters a plea of guilty to, or has been found guilty of, a felony and the time
14 for appeal has passed or the judgment of conviction has been finally affirmed
15 on appeal; or
 - 16 (e) Misses three (3) consecutive meetings or misses more than twenty-five
17 percent (25%) of the meetings held over the previous twelve (12) month
18 period.
- 19 (4) Voting members of the board shall be compensated no more than three hundred
20 dollars (\$300) per day for official business, subject to an annual maximum of six
21 thousand dollars (\$6,000). Members shall be reimbursed for all expenses paid and
22 incurred in the discharge of official business consistent with the reimbursement
23 policy for state employees. With the approval of the director of the Division of
24 Real Property Boards within the Department of Professional Licensing~~executive~~
25 ~~director of the Kentucky Real Estate Authority within the Department of~~
26 ~~Professional Licensing~~, board members and board staff may attend and travel to
27 and from meetings and events relevant to the board or the industry the board

1 represents.

2 (5) The board shall meet at least quarterly each calendar year upon the call of the chair
3 or the written request of a majority of the members of the board.

4 (6) (a) 1. The chair shall establish the date, time, and place for each meeting; and
5 2. Submit written recommendations to the secretary of the Public
6 Protection Cabinet concerning staffing needs and relevant experience
7 necessary to assist in carrying out the mission and function of the
8 Division of Real Property Boards.

9 (b) The secretary of the Public Protection Cabinet shall:

10 1. Consider the staffing recommendations and requests submitted by the
11 chair; and
12 2. Provide the board with documentation showing the income and
13 expenditures of all license fees.

14 ➔Section 7. KRS 198B.706 is amended to read as follows:

15 The board shall:

16 (1) Through the promulgation of administrative regulations:

17 (a) Determine the requirements for and prescribe the form of licenses,
18 applications, and other documents that are required by KRS 198B.700 to
19 198B.738; and

20 (b) Require that a home inspection report include a statement that the home
21 inspection report does not address environmental hazards and list all other
22 exclusions with specificity;

23 (2) Grant, deny, suspend, and revoke approval of examinations and courses of study
24 regarding home inspections;

25 (3) Issue or deny applications for licensure and renewals;

26 (4) Investigate complaints concerning licensees, or persons the board has reason to
27 believe should be licensees, including complaints concerning failure to comply with

- 1 KRS 198B.700 to 198B.738 or administrative regulations promulgated under KRS
2 198B.700 to 198B.738, and, when appropriate, take action in accordance with KRS
3 198B.728 and 198B.730;
- 4 (5) Bring actions in the name of the state in an appropriate court in order to enforce
5 compliance with KRS 198B.700 to 198B.738 or the administrative regulations
6 promulgated under KRS 198B.700 to 198B.738;
- 7 (6) Establish license fees in an amount not to exceed two hundred fifty dollars (\$250)
8 annually;
- 9 (7) Inspect the records of a licensee in accordance with administrative regulations
10 promulgated by the board;
- 11 (8) Conduct or designate a member or other representative to conduct public hearings
12 on any matter for which a hearing is required under KRS 198B.728 and 198B.730;
- 13 (9) Adopt a seal containing the words "Kentucky Board of Home Inspectors" and,
14 through the board's secretary, certify copies and authenticate all acts of the board;
- 15 (10) Use counsel, consultants, and other persons, enter into contracts, and authorize
16 expenditures that are reasonably necessary or appropriate to administer and enforce
17 KRS 198B.700 to 198B.738 and administrative regulations promulgated
18 thereunder;
- 19 (11) Establish continuing education requirements for licensed home inspectors in
20 accordance with KRS 198B.722 and 198B.724;
- 21 (12) Conduct disciplinary actions against licensees to include:
- 22 (a) Suspension, probation, or permanent revocation of a license;
- 23 (b) Requiring a licensee to obtain additional continuing education; and
- 24 (c) Issuance of a written reprimand;
- 25 (13) Require all fee-paid home inspections to be conducted in accordance with the
26 standards of practice of:
- 27 (a) The American Society of Home Inspectors;

- 1 (b) The International Association of Certified Home Inspectors; or
 2 (c) Any other approved standards of practice that are equal to the standards of
 3 practice of the organizations in paragraphs (a) and (b) of this subsection as
 4 determined by the board.

5 The board may establish standards of practice for home inspectors licensed in
 6 Kentucky at a later date, which will supersede any other standards of practice
 7 previously adopted by the board and, if adopted by regulation, the standards in
 8 paragraphs (a) and (b) of this subsection;

9 (14) Exercise all other powers specifically conferred on the board under KRS 198B.700
 10 to 198B.738; and

11 (15) Promulgate administrative regulations *in accordance with KRS Chapter 13A* to
 12 carry out the effective administration and the requirements of KRS 198B.700 to
 13 198B.738, *following review by the director of the Division of Real Property*
 14 *Boards* ~~[with the approval of the executive director of the Kentucky Real Estate~~
 15 ~~Authority].~~

16 ➔Section 8. KRS 198B.728 is amended to read as follows:

17 (1) The board shall take disciplinary actions against or impose sanctions on a licensee
 18 for failing to comply with any provision of KRS 198B.700 to 198B.738 or any
 19 administrative regulations promulgated to carry out KRS 198B.700 to 198B.738.

20 (2) Pursuant to KRS 13B.120(7), the *director of the Division of Real Property Boards*
 21 *within the Department of Professional Licensing* ~~[executive director of the~~
 22 ~~Kentucky Real Estate Authority within the Department of Professional Licensing]~~
 23 shall hear and issue a final order regarding any decision of the board. An aggrieved
 24 party may appeal a final order of the ~~[executive]~~ director pursuant to KRS Chapter
 25 13B within thirty (30) days after the issuance of the order to the Circuit Court of the
 26 county where the licensee has his or her principal place of business or where the
 27 license applicant resides.

1 ➔Section 9. KRS 324.281 is amended to read as follows:

- 2 (1) There is hereby created the Kentucky Real Estate Commission. The Governor shall
3 appoint seven (7) persons, at least six (6) of whom, immediately prior to the date of
4 their appointment have been residents of the state for ten (10) years and whose
5 vocation for a period of at least ten (10) years shall have been that of an active real
6 estate licensee. One (1) member shall be a citizen at large who is not associated
7 with or financially interested in the practice or business regulated. The term of the
8 members of the commission shall be for three (3) years and until their successors
9 are appointed and qualify, except as provided in subsections (2) and (3) of this
10 section. A majority of the commission shall constitute a quorum for the transaction
11 of business.
- 12 (2) All appointments shall be for the specified three (3) year term. No person appointed
13 after July 14, 2000, shall serve more than two (2) consecutive terms.
- 14 (3) For each appointment or vacancy, the Kentucky Association of Realtors shall
15 within sixty (60) days supply a list of not less than three (3) names of licensees to
16 the Governor each year from which the broker or sales associate appointments shall
17 be made. The Governor may reject the list of three (3) names and request that the
18 Kentucky Association of Realtors submit a new list of three (3) names within sixty
19 (60) days of the Governor's request. If the Kentucky Association of Realtors fails to
20 timely submit this list to the Governor, the Governor may immediately appoint a
21 qualified person to fill this vacancy. The Governor may otherwise fill vacancies
22 arising in the middle of the year from those remaining on the list or from a new list
23 supplied by the association.
