1	AN ACT relating to the rural hospital tax credit.
2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 141 IS CREATED TO
4	READ AS FOLLOWS:
5	(1) As used in this section:
6	(a) "Rural county" means a county within the Commonwealth having a
7	population of less than fifty thousand (50,000) according to the most recent
8	United States decennial census, except that for counties which contain a
9	military base or installation, the military personnel and their dependents
10	living in that county shall be excluded from the total population of the
11	county for purposes of this definition; and
12	(b) "Rural hospital organization" means an acute care hospital as defined in
13	KRS 205.639, if that hospital:
14	1. Provides inpatient hospital services at a facility located in a rural
15	<u>county;</u>
16	2. Participates in both Medicaid and Medicare and accepts both
17	Medicaid and Medicare patients;
18	3. Provides health care services to indigent patients;
19	4. Has at least ten percent (10%) of its annual net revenue categorized as
20	indigent care, charity care, or bad debt;
21	5. Has been designated as a tax-exempt organization under Section
22	501(c)(3) of the Internal Revenue Code; and
23	6. Does not have a margin above expenses of greater than fifteen percent
24	<u>(15%).</u>
25	(2) (a) For taxable years beginning on or after January 1, 2021, but before
26	January 1, 2025, a taxpayer shall be allowed a nonrefundable,
27	nontransferable rural hospital donation tax credit against the taxes imposed

1		in KRS 141.020 or 141.040 and 141.0401, with the ordering of the credits
2		under Section 2 of this Act.
3	<u>(b)</u>	The tax credit shall be equal to the amount of donation made to a rural
4		hospital organization, except:
5		<b><u>1.</u></b> The maximum credit awarded to:
6		a. A taxpayer other than a corporation in a calendar year shall not
7		exceed five thousand dollars (\$5,000); and
8		b. A corporation in a calendar year shall not exceed ten thousand
9		<u>dollars (\$10,000); and</u>
10		2. The aggregate total of tax credits awarded in a calendar year shall not
11		exceed twenty million dollars (\$20,000,000).
12	<u>(c)</u>	The maximum amount of credit that may be claimed in a taxable year shall
13		not exceed seventy-five percent (75%) of the total income tax liability, which
14		would be otherwise due for that taxable year.
15	<u>(d)</u>	Any unused tax credit shall be allowed against the succeeding five (5) years
16		<u>of tax liability.</u>
17	<u>(3) (a)</u>	By December 1, 2020, and by December 1 of each year thereafter as long as
18		the credit is available, a hospital wishing to accept donations during the
19		immediately succeeding calendar year shall certify to the department that
20		the hospital qualifies as a rural hospital organization.
21	<u>(b)</u>	Upon certification that a hospital qualifies as a rural hospital organization,
22		the department shall publish a list of qualified rural hospital organizations
23		for that calendar year.
24	<u>(4) (a)</u>	Any taxpayer wishing to make a donation to a rural hospital organization
25		shall apply to the department with an intent to make a donation.
26	<u>(b)</u>	Within thirty (30) days of applying to the department with an intent to make
27		a donation, the taxpayer shall:

1	<b><u>1.</u></b> Remit the donation to the rural hospital organization; and
2	2. Certify to the department that the donation has been made.
3	(5) The department may promulgate administrative regulations related to the
4	administration of this tax credit.
5	(6) The purpose of this tax credit is to create a revenue source for rural hospital
6	organizations, the intent of which is to assist with the actual costs that are
7	incurred by the rural hospital organization but are not covered by Medicaid
8	patients.
9	(7) (a) In order for the General Assembly to evaluate the fulfillment of the purpose
10	stated in subsection (6) of this section, the department shall provide the
11	following information on a cumulative basis for each taxable year to
12	provide a historical impact of the tax credit to the Commonwealth:
13	<u>1. The name and address for each taxpayer claiming the tax credit;</u>
14	2. The entity type of that taxpayer;
15	3. The name of the rural hospital organization which received the
16	donation related to the tax credit claimed by that taxpayer;
17	4. The amount of the donation made;
18	5. The amount of tax credit claimed by that taxpayer;
19	6. The amount of credit that the taxpayer has available for carry forward
20	<u>to a future year;</u>
21	7. Related to that calendar year, the amount of carry forward from a
22	prior year that is utilized by that taxpayer;
23	8. In the case of all taxpayers other than corporations, based on ranges
24	of adjusted gross income of no larger than five thousand dollars
25	(\$5,000) for the taxable year, the total amount of tax credits claimed
26	and the number of returns claiming a tax credit for each adjusted
27	gross income range; and

1		9. In the case of all corporations, based on ranges of net income no
2		larger than fifty thousand dollars (\$50,000) for the taxable year, the
3		total amount of tax credit claimed and the number of returns claiming
4		a tax credit for each net income range.
5	<u>(b)</u>	The report required by paragraph (a) of this subsection shall be submitted
6		to the Interim Joint Committee on Appropriations and Revenue beginning
7		no later than November 1, 2022, and no later than each November 1
8		thereafter, as long as the credit is claimed on any return processed by the
9		<u>department.</u>

2	(3)	After the application of the nonrefundable credits provided for in subsection (2) of
3		this section, the refundable credits against the tax imposed by KRS 141.020 shall be
4		taken in the following order:
5		(a) The individual withholding tax credit permitted by KRS 141.350;
6		(b) The individual estimated tax payment credit permitted by KRS 141.305;
7		(c) The certified rehabilitation credit permitted by KRS 171.3961 and
8		171.397(1)(b); and
9		(d) The film industry tax credit permitted by KRS 141.383 for applications
10		approved prior to April 27, 2018.
11	(4)	The nonrefundable credit permitted by KRS 141.0401 shall be applied against the
12		tax imposed by KRS 141.040.
13	(5)	The following nonrefundable credits shall be applied against the sum of the tax
14		imposed by KRS 141.040 after subtracting the credit provided for in subsection (4)
15		of this section, and the tax imposed by KRS 141.0401 in the following order:
16		(a) The economic development credits computed under KRS 141.347, 141.381,

24	(6)	Afte	r the application of the nonrefundable credits in subsection (5) of this section,
25		the r	efundable credits shall be taken in the following order:
26		(a)	The corporation estimated tax payment credit permitted by KRS 141.044;
27		(b)	The certified rehabilitation credit permitted by KRS 171.3961 and

1			171.397(1)(b); and
2		(c)	The film industry tax credit permitted by KRS 141.383 for applications
3			approved prior to April 27, 2018.
4		⇒s	ection 3. KRS 131.190 is amended to read as follows:
5	(1)	No	present or former commissioner or employee of the department, present or
6		form	her member of a county board of assessment appeals, present or former property
7		valu	ation administrator or employee, present or former secretary or employee of the
8		Fina	nce and Administration Cabinet, former secretary or employee of the Revenue
9		Cabi	net, or any other person, shall intentionally and without authorization inspect or
10		divu	lge any information acquired by him of the affairs of any person, or information
11		rega	rding the tax schedules, returns, or reports required to be filed with the
12		depa	artment or other proper officer, or any information produced by a hearing or
13		inve	stigation, insofar as the information may have to do with the affairs of the
14		perso	on's business.
15	(2)	The	prohibition established by subsection (1) of this section shall not extend to:
16		(a)	Information required in prosecutions for making false reports or returns of
17			property for taxation, or any other infraction of the tax laws;
18		(b)	Any matter properly entered upon any assessment record, or in any way made
19			a matter of public record;
20		(c)	Furnishing any taxpayer or his properly authorized agent with information
21			respecting his own return;
22		(d)	Testimony provided by the commissioner or any employee of the department
23			in any court, or the introduction as evidence of returns or reports filed with the
24			department, in an action for violation of state or federal tax laws or in any
25			action challenging state or federal tax laws;
26		(e)	Providing an owner of unmined coal, oil or gas reserves, and other mineral or
27			energy resources assessed under KRS 132.820, or owners of surface land

under which the unmined minerals lie, factual information about the owner's
property derived from third-party returns filed for that owner's property, under
the provisions of KRS 132.820, that is used to determine the owner's
assessment. This information shall be provided to the owner on a confidential
basis, and the owner shall be subject to the penalties provided in KRS
131.990(2). The third-party filer shall be given prior notice of any disclosure
of information to the owner that was provided by the third-party filer;

8 (f) Providing to a third-party purchaser pursuant to an order entered in a 9 foreclosure action filed in a court of competent jurisdiction, factual 10 information related to the owner or lessee of coal, oil, gas reserves, or any 11 other mineral resources assessed under KRS 132.820. The department may 12 promulgate an administrative regulation establishing a fee schedule for the 13 provision of the information described in this paragraph. Any fee imposed 14 shall not exceed the greater of the actual cost of providing the information or 15 ten dollars (\$10);

- KRS 139.519 for purposes of the sales and use tax refund on building
   materials used for disaster recovery;

1		2. KRS 141.436 for purposes of the energy efficiency products credits;
2		3. KRS 141.437 for purposes of the ENERGY STAR home and the
3		ENERGY STAR manufactured home credits;
4		4. KRS 148.544 for purposes of the film industry incentives;
5		5. KRS 154.26-095 for purposes of the Kentucky industrial revitalization
6		tax credits and the job assessment fees;
7		6. KRS 141.068 for purposes of the Kentucky investment fund;
8		7. KRS 141.396 for purposes of the angel investor tax credit;
9		8. KRS 141.389 for purposes of the distilled spirits credit;
10		9. KRS 141.408 for purposes of the inventory credit; [ and]

14	(3)	The commissioner shall make available any information for official use only and on
15		a confidential basis to the proper officer, agency, board or commission of this state,
16		any Kentucky county, any Kentucky city, any other state, or the federal government,
17		under reciprocal agreements whereby the department shall receive similar or useful
18		information in return.
19	(4)	Access to and inspection of information received from the Internal Revenue Service
20		is for department use only, and is restricted to tax administration purposes.
21		Information received from the Internal Revenue Service shall not be made available
22		to any other agency of state government, or any county, city, or other state, and shall
23		not be inspected intentionally and without authorization by any present secretary or
24		employee of the Finance and Administration Cabinet, commissioner or employee of
25		the department, or any other person.

4	(6)	Notwithstanding any provision of law to the contrary, beginning with mine-map
5		submissions for the 1989 tax year, the department may make public or divulge only
6		those portions of mine maps submitted by taxpayers to the department pursuant to
7		KRS Chapter 132 for ad valorem tax purposes that depict the boundaries of mined-
8		out parcel areas. These electronic maps shall not be relied upon to determine actual
9		boundaries of mined-out parcel areas. Property boundaries contained in mine maps
10		required under KRS Chapters 350 and 352 shall not be construed to constitute land
11		surveying or boundary surveys as defined by KRS 322.010 and any administrative
12		regulations promulgated thereto.
