- 5 (1) An administrative body may use an administrative regulation management
- 6 application developed and maintained by the Legislative Research Commission, if
- 7 available, to satisfy the following requirements of this chapter:

- 9 (b) Notifications to the regulations compiler.
- 10 (2) If the filing and notification requirements of this chapter are not available in the
- 11 administrative regulation management application, the administrative body shall
- 12 <u>use the paper-based process established by this chapter.</u>
- 13 (3) Paper-based shall include any procedure in this chapter that requires an
- 14 <u>administrative body to file or submit a hard copy to the compiler.</u>
- Section 2. KRS 13A.040 is amended to read as follows:
- 16 The director of the Legislative Research Commission shall appoint an administrative
- 17 regulations compiler who shall:
- 18 (1) Receive administrative regulations, and other documents required to be filed by the
- 19 provisions of this chapter, tendered for filing;
- 20 (2) Stamp administrative regulations tendered for filing with the time and date of
- 21 receipt;
- 22 (3) Provide administrative and support services to the subcommittee;
- 23 (4) Maintain a file of administrative regulations and other documents required to be
- 24 filed by this chapter, for public inspection, with suitable indexes;
- 25 (5) Maintain a file of ineffective administrative regulations;
- 26 (6) Maintain a file of material incorporated by reference, including superseded or
- ineffective material incorporated by reference;

7	(1)	If an administrative body does not want an administrative regulation to expire under
8		KRS 13A.3102, the administrative body shall, in the twelve (12) months prior to
9		the expiration date:
10		(a) Review the administrative regulation in its entirety for compliance with
11		current law governing the subject matter of the administrative regulation;
12		(b) [Prior to the expiration date,]File a certification letter with the regulations
13		compiler stating whether the administrative regulation:
14		<u>1.</u> Shall be amended <u>because it is not in compliance with current</u>
15		governing law or otherwise needs amendment; [or]
16		2. Shall remain in effect without amendment because it is in compliance
17		with current governing law; or
18		3. Is in need of amendment and a proposed amendment has already been
19		<u>filed</u> ; and
20		(c) Not be required to consider KRS Chapter 13A drafting and formatting
21		requirements as part of its review.
22	(2)	The certification letter shall be on the administrative body's official letterhead, in
23		the format prescribed by the regulations compiler, and include the following
24		information:
25		(a) The name of the administrative body;
26		(b) The number of the administrative regulation;
27		(c) The title of the administrative regulation;

1		(d)	<u>The[A]</u> statement <u>required by subsection (1)(b) of this section</u> [that:
2			1. The administrative body shall be amending the administrative
3			regulation; or
4			2. The administrative regulation shall remain in effect without
5			amendment];[and]
6		(e)	A brief statement in support of the decision; and
7		<u>(f)</u>	The authorizing signature of the administrative body.

25		Regulation Review Subcommittee under KRS Chapter 13A, except as otherwise
26		authorized by subsection (2) of this section.
27	<i>(</i> 2 <i>)</i>	(a) If the subcommittee places an administrative regulation on its agenda for

2		conduct the review, the administrative regulation shall be deferred for up to

6		administrative regulation shall be considered reviewed by the subcommittee

24	(5)	Following the meeting and before the next regularly scheduled meeting of the

26		Commission its findings, recommendations, or other comments it deems

20	to consider an administrative regulation, shall hold a public meeting during which
21	the regulation shall be reviewed. If the thirtieth day of the assignment falls on a
22	Saturday, Sunday, or holiday, the deadline for review shall be the workday
23	following the Saturday, Sunday, or holiday. The committee may also review an
24	existing administrative regulation and make a determination as provided by KRS
25	13A.030(2), (3), and (4). Notice of the time, date, and place of the meeting shall be
26	placed in the legislative calendar.
27	(8) The Department of Education shall comply with subsection (4) of this section.

1	(9) The Education Committee shall be empowered to make the same nonbinding
2	determinations and to exercise the same authority as the Administrative Regulation
3	Review Subcommittee.
4	(10) (a) Upon adjournment of the meeting at which the Education Committee has
5	considered an administrative regulation pursuant to subsection (7) of this
6	section, the committee shall inform the regulations compiler of its findings,
7	recommendations, or other action taken on the administrative regulation.
8	(b) Following the meeting and before the next regularly scheduled meeting of the
9	Commission, the committee shall forward to the Commission its findings,
10	recommendations, or other comments it deems appropriate in writing. One (1)
11	copy shall be sent to the Department of Education. The committee's findings
12	shall be published in The Administrative Register].
