

1 AN ACT relating to school bus safety.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
4 READ AS FOLLOWS:

5 *As used in Sections 1 to 6 of this Act:*

6 *(1) "Camera monitoring system" means a system with one (1) or more camera*  
7 *sensors and computers installed and operated on a school bus that:*

8 *(a) Produces recorded images; and*

9 *(b) Records the activation status of the stop arm and time, date, and location of*  
10 *the motor vehicle when the recorded image or video is captured;*

11 *(2) "County" means a county, urban-county, consolidated local government, unified*  
12 *local government, or charter county;*

13 *(3) "Owner" has the same meaning as in KRS 186.010;*

14 *(4) "Recorded images" means two (2) or more photographic images or a segment of*  
15 *any video medium recorded by a camera monitoring system which show on at*  
16 *least one (1) image or portion of video the registration plate number of a motor*  
17 *vehicle being operated in violation of Section 8 of this Act; and*

18 *(5) "Stop arm camera violation" means a violation of Section 8 of this Act recorded*  
19 *by a camera monitoring system and enforced in accordance with Section 2 of this*  
20 *Act.*

21 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
22 READ AS FOLLOWS:

23 *(1) Each school district may install and maintain a camera monitoring system on*  
24 *each school bus operated by the school district for the enforcement of a civil*  
25 *penalty against the owner of a motor vehicle for a stop arm camera violation.*

26 *(2) A stop arm camera violation shall be enforced by a law enforcement authority*  
27 *upon review of the recorded images produced by a camera monitoring system.*

1 (3) A camera monitoring system installed and maintained in accordance with this  
2 section shall display a warning sign notifying the public of the camera  
3 monitoring system.

4 (4) Recorded images and other records related to a specific stop arm camera  
5 violation are private information and shall only be accessible to authorized  
6 personnel for the purpose of issuing and enforcing stop arm camera violations.

7 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
8 READ AS FOLLOWS:

9 (1) The amount of a civil penalty for a stop arm camera violation shall be:

10 (a) Five hundred dollars (\$500) for the first civil penalty; and

11 (b) One thousand dollars (\$1,000) for each subsequent civil penalty issued to  
12 an owner within a three (3) year period.

13 (2) All revenue generated from a civil penalty for stop arm camera violations shall be  
14 retained by the county, unless the fine is collected as a result of action taken in  
15 the Court of Justice in which court costs may be deducted from the amount paid  
16 to the county.

17 (3) A stop arm camera violation shall not result in points being assessed against the  
18 driving record of the owner or operator of the vehicle in violation.

19 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
20 READ AS FOLLOWS:

21 (1) The following documents shall be sent by certified mail to the owner of a motor  
22 vehicle within thirty (30) days of a stop arm camera violation:

23 (a) The stop arm camera violation notice form as described in subsection (2) of  
24 this section;

25 (b) A copy of the recorded images for the stop arm camera violation; and

26 (c) A signed, sworn statement from a law enforcement officer that, based on  
27 inspection of recorded images, the motor vehicle was being operated in

1 violation of Section 8 of this Act. This statement may be admissible in any  
2 proceeding challenging a stop arm camera violation.

3 (2) The stop arm camera violation notice form shall contain in substance the  
4 following information:

5 (a) The name and address of the registered owner of the vehicle;

6 (b) A statement that the notice represents a determination that a stop arm  
7 camera violation has been committed by the owner of the vehicle and that  
8 the determination shall be final unless contested in accordance with Section  
9 5 of this Act;

10 (c) The date and time of the violation;

11 (d) The location of the violation;

12 (e) The amount of the civil penalty imposed and the date by which the civil  
13 penalty shall be paid;

14 (f) Instructions on how to pay the civil penalty;

15 (g) Information advising the owner as to the manner and time in which the  
16 uniform civil citation may be contested; and

17 (h) A warning that failure to pay the civil penalty imposed or to contest the  
18 matter in a timely manner is an admission of liability and shall result in the  
19 suspension of the motor vehicle's registration.

20 (3) A recorded image produced by a camera monitoring system shall be destroyed:

21 (a) No later than thirty-one (31) days from the date the recorded image is  
22 captured if the recorded image does not result in a stop arm camera  
23 violation issued pursuant to this section; or

24 (b) Upon final disposition of the stop arm camera violation if the recorded  
25 image results in a stop arm camera violation issued pursuant to this section.

26 ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
27 READ AS FOLLOWS:

- 1 (1) A recorded image produced by a camera monitoring system shall be sufficient  
2 evidence of a violation of Section 8 of this Act and shall be admitted without  
3 further authentication for the purposes of enforcement but shall not be  
4 admissible for any other purpose unless it involves an accident or criminal  
5 proceeding.
- 6 (2) In a contest to a stop arm camera violation, it shall be a defense that:
- 7 (a) The motor vehicle or the motor vehicle registration plates were stolen before  
8 the violation occurred and were not under the control or possession of the  
9 owner at the time of the violation;
- 10 (b) The violation is not enforceable because at the time and place of the  
11 violation the stop arm was not extended or the signal lights were not  
12 activated so as to be seen by an ordinarily observant individual;
- 13 (c) The owner was not operating the vehicle at the time of the violation. An  
14 owner who uses this defense shall identify who was operating the vehicle at  
15 the time of the violation, including, at a minimum, the operator's name and  
16 address;
- 17 (d) The person operating the motor vehicle received a citation from a law  
18 enforcement officer for a violation of Section 8 of this Act at the date and  
19 approximate time listed on the stop arm camera violation form;
- 20 (e) The violation was necessary to allow the passage of an emergency vehicle;
- 21 (f) The violation was necessary to avoid injuring the person or property of  
22 another;
- 23 (g) The violation was incurred while participating in a funeral procession; or
- 24 (h) The violation was necessary in order for the operator to comply with any  
25 other general statute or regulation concerning the operation of a motor  
26 vehicle.
- 27 (3) A contest to a stop arm camera violation shall be heard by the District Court, and

1                   *the legislative body of the county shall direct the county attorney to defend*  
2                   *the stop arm camera violation in accordance with KRS 69.210(1).*

3           ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 67 IS CREATED TO  
4 READ AS FOLLOWS:

5           *(1) If a stop arm camera violation is not paid or contested in accordance with Section*  
6           *5 of this Act within sixty (60) days, the county may notify the Transportation*  
7           *Cabinet of the nonpayment. Upon notice of nonpayment, the cabinet shall*  
8           *suspend the registration of a motor vehicle until the civil penalty is paid.*  
9           *(2) A county shall notify the cabinet of the need to release a suspension levied in*  
10           *accordance with this section within one (1) business day of collecting the funds to*  
11           *satisfy the civil penalty.*

12           ➔Section 7. KRS 189.990 is amended to read as follows:

13           (1) Any person who violates any of the provisions of KRS 189.020 to 189.040,  
14           subsection (1) or (4) of KRS 189.050, KRS 189.060 to 189.080, subsections (1) to  
15           (3) of KRS 189.090, KRS 189.100, 189.110, 189.130 to 189.160, subsections (2) to  
16           (4) of KRS 189.190, KRS 189.200, 189.285, 189.290, 189.300 to 189.360, KRS  
17           189.380, KRS 189.400 to 189.430, KRS 189.450 to 189.458, KRS 189.4595 to  
18           189.480, subsection (1) of KRS 189.520, KRS 189.540, KRS 189.570 to 189.590,  
19           except subsection (1)(b) or (6)(b) of KRS 189.580, KRS 189.345, subsection (6) of  
20           KRS 189.456, and 189.960 shall be fined not less than twenty dollars (\$20) nor  
21           more than one hundred dollars (\$100) for each offense. Any person who violates  
22           subsection (1)(a) of KRS 189.580 shall be fined not less than twenty dollars (\$20)  
23           nor more than two thousand dollars (\$2,000) or imprisoned in the county jail for not  
24           more than one (1) year, or both, unless the accident involved death or serious  
25           physical injury and the person knew or should have known of the death or serious  
26           physical injury, in which case the person shall be guilty of a Class D felony. Any  
27           person who violates paragraph (c) of subsection (5) of KRS 189.390 shall be fined

1 not less than eleven dollars (\$11) nor more than thirty dollars (\$30). Neither court  
2 costs nor fees shall be taxed against any person violating paragraph (c) of  
3 subsection (5) of KRS 189.390.

4 (2) (a) 1. Except as provided in subparagraph 2. of this paragraph, any person  
5 who violates the weight provisions of KRS 189.212, 189.221, 189.222,  
6 189.226, 189.230, 189.270, or 189.2713 shall be fined two cents (\$0.02)  
7 per pound for each pound of excess load when the excess is five  
8 thousand (5,000) pounds or less. When the excess exceeds five thousand  
9 (5,000) pounds the fine shall be two cents (\$0.02) per pound for each  
10 pound of excess load, but the fine levied shall not be less than one  
11 hundred dollars (\$100) and shall not be more than five hundred dollars  
12 (\$500).

13 2. Any person who violates a posted bridge weight limit on a state-  
14 maintained bridge that is more than seventy-five (75) years old shall be  
15 fined:

16 a. Five hundred dollars (\$500) for the first offense;

17 b. One thousand dollars (\$1,000) for the second offense within a one  
18 (1) year period; and

19 c. Two thousand dollars (\$2,000) for any subsequent offense within a  
20 one (1) year period.

21 The Transportation Cabinet shall erect signs warning drivers of the  
22 increased fines in this subparagraph. Signs erected under this  
23 subparagraph shall be placed in such a manner that drivers are given  
24 adequate warning in order to exit the road prior to crossing the bridge. If  
25 warning signs are not erected in accordance with this subparagraph, the  
26 fines in this subparagraph shall not apply and violators shall be fined  
27 under subparagraph 1. of this paragraph.

- 1 (b) Any person who violates the provisions of KRS 189.271 and is operating on a  
2 route designated on the permit shall be fined one hundred dollars (\$100);  
3 otherwise, the penalties in paragraph (a) of this subsection shall apply.
- 4 (c) Any person who violates any provision of subsection (2) or (3) of KRS  
5 189.050, subsection (4) of KRS 189.090, KRS 189.221 to 189.230, 189.270,  
6 189.2713, 189.280, or the dimension provisions of KRS 189.212, for which  
7 another penalty is not specifically provided shall be fined not less than ten  
8 dollars (\$10) nor more than five hundred dollars (\$500).
- 9 (d) 1. Any person who violates the provisions of KRS 177.985 while operating  
10 on a route designated in KRS 177.986 shall be fined one hundred dollars  
11 (\$100).
- 12 2. Any person who operates a vehicle with a permit under KRS 177.985 in  
13 excess of eighty thousand (80,000) pounds while operating on a route  
14 not designated in KRS 177.986 shall be fined one thousand dollars  
15 (\$1,000).
- 16 (e) Nothing in this subsection or in KRS 189.221 to 189.228 shall be deemed to  
17 prejudice or affect the authority of the Department of Vehicle Regulation to  
18 suspend or revoke certificates of common carriers, permits of contract  
19 carriers, or drivers' or chauffeurs' licenses, for any violation of KRS 189.221  
20 to 189.228 or any other act applicable to motor vehicles, as provided by law.
- 21 (3) (a) Any person who violates subsection (1) of KRS 189.190 shall be fined not  
22 more than fifteen dollars (\$15).
- 23 (b) Any person who violates subsection (5) of KRS 189.190 shall be fined not  
24 less than thirty-five dollars (\$35) nor more than two hundred dollars (\$200).
- 25 (4) (a) Any person who violates subsection (1) of KRS 189.210 shall be fined not  
26 less than twenty-five dollars (\$25) nor more than one hundred dollars (\$100).
- 27 (b) Any peace officer who fails, when properly informed, to enforce KRS

- 1           189.210 shall be fined not less than twenty-five dollars (\$25) nor more than  
2           one hundred dollars (\$100).
- 3           (c) All fines collected under this subsection, after payment of commissions to  
4           officers entitled thereto, shall go to the county road fund if the offense is  
5           committed in the county, or to the city street fund if committed in the city.
- 6           (5) Any person who violates KRS 189.370 shall for the first offense be fined not less  
7           than one hundred dollars (\$100) nor more than ~~five~~<sup>two</sup> hundred dollars  
8           ~~(\$500)~~<sup>(\$200)</sup> or imprisoned not less than thirty (30) days nor more than sixty (60)  
9           days, or both. For each subsequent offense occurring within three (3) years, the  
10          person shall be fined not less than ~~five~~<sup>three</sup> hundred dollars ~~(\$500)~~<sup>(\$300)</sup> nor  
11          more than ~~one thousand~~<sup>five hundred</sup> dollars ~~(\$1,000)~~<sup>(\$500)</sup> or imprisoned not  
12          less than sixty (60) days nor more than six (6) months, or both. The minimum fine  
13          for this violation shall not be subject to suspension. A minimum of six (6) points  
14          shall be assessed against the driving record of any person convicted.
- 15          (6) Any person who violates KRS 189.500 shall be fined not more than fifteen dollars  
16          (\$15) in excess of the cost of the repair of the road.
- 17          (7) Any person who violates KRS 189.510 or KRS 189.515 shall be fined not less than  
18          twenty dollars (\$20) nor more than fifty dollars (\$50).
- 19          (8) Any peace officer who violates subsection (2) of KRS 189.520 shall be fined not  
20          less than thirty-five dollars (\$35) nor more than one hundred dollars (\$100).
- 21          (9) (a) Any person who violates KRS 189.530(1) shall be fined not less than thirty-  
22          five dollars (\$35) nor more than one hundred dollars (\$100), or imprisoned  
23          not less than thirty (30) days nor more than twelve (12) months, or both.
- 24          (b) Any person who violates KRS 189.530(2) shall be fined not less than thirty-  
25          five dollars (\$35) nor more than one hundred dollars (\$100).
- 26          (10) Any person who violates any of the provisions of KRS 189.550 shall be guilty of a  
27          Class B misdemeanor.



- 1 (11) Any person who violates subsection (3) of KRS 189.560 shall be fined not less than  
2 thirty dollars (\$30) nor more than one hundred dollars (\$100) for each offense.
- 3 (12) The fines imposed by paragraph (a) of subsection (3) and subsections (6) and (7) of  
4 this section shall, in the case of a public highway, be paid into the county road fund,  
5 and, in the case of a privately owned road or bridge, be paid to the owner. These  
6 fines shall not bar an action for damages for breach of contract.
- 7 (13) Any person who violates any of the provisions of KRS 189.120 shall be fined not  
8 less than twenty dollars (\$20) nor more than one hundred dollars (\$100) for each  
9 offense.
- 10 (14) Any person who violates any provision of KRS 189.575 shall be fined not less than  
11 twenty dollars (\$20) nor more than twenty-five dollars (\$25).
- 12 (15) Any person who violates subsection (2) of KRS 189.231 shall be fined not less than  
13 twenty dollars (\$20) nor more than one hundred dollars (\$100) for each offense.
- 14 (16) Any person who violates restrictions or regulations established by the secretary of  
15 transportation pursuant to subsection (3) of KRS 189.231 shall, upon first offense,  
16 be fined one hundred dollars (\$100) and, upon subsequent convictions, be fined not  
17 less than one hundred dollars (\$100) nor more than five hundred dollars (\$500) or  
18 imprisoned for thirty (30) days, or both.
- 19 (17) (a) Any person who violates any of the provisions of KRS 189.565 shall be guilty  
20 of a Class B misdemeanor.
- 21 (b) In addition to the penalties prescribed in paragraph (a) of this subsection, in  
22 case of violation by any person in whose name the vehicle used in the  
23 transportation of inflammable liquids or explosives is licensed, the person  
24 shall be fined not less than one hundred dollars (\$100) nor more than five  
25 hundred dollars (\$500). Each violation shall constitute a separate offense.
- 26 (18) Any person who abandons a vehicle upon the right-of-way of a state highway for  
27 three (3) consecutive days shall be fined not less than thirty-five dollars (\$35) nor

- 1 more than one hundred dollars (\$100), or imprisoned for not less than ten (10) days  
2 nor more than thirty (30) days.
- 3 (19) Every person violating KRS 189.393 shall be guilty of a Class B misdemeanor,  
4 unless the offense is being committed by a defendant fleeing the commission of a  
5 felony offense which the defendant was also charged with violating and was  
6 subsequently convicted of that felony, in which case it is a Class A misdemeanor.
- 7 (20) Any law enforcement agency which fails or refuses to forward the reports required  
8 by KRS 189.635 shall be subject to the penalties prescribed in KRS 17.157.
- 9 (21) A person who operates a bicycle in violation of the administrative regulations  
10 promulgated pursuant to KRS 189.287 shall be fined not less than ten dollars (\$10)  
11 nor more than one hundred dollars (\$100).
- 12 (22) Any person who violates KRS 189.860 shall be fined not more than five hundred  
13 dollars (\$500) or imprisoned for not more than six (6) months, or both.
- 14 (23) Any person who violates KRS 189.754 shall be fined not less than twenty-five  
15 dollars (\$25) nor more than three hundred dollars (\$300).
- 16 (24) Any person who violates the provisions of KRS 189.125(3)(a) shall be fined fifty  
17 dollars (\$50). This fine shall be subject to prepayment. A fine imposed under this  
18 subsection shall not be subject to court costs pursuant to KRS 24A.175, additional  
19 court costs pursuant to KRS 24A.176, the fee imposed pursuant to KRS 24A.1765,  
20 or any other additional fees or costs.
- 21 (25) Any person who violates the provisions of KRS 189.125(3)(b) ~~shall not be issued a~~  
22 ~~uniform citation, but shall instead receive a courtesy warning up until July 1, 2009.~~  
23 ~~For a violation on or after July 1, 2009, the person~~ shall be fined thirty dollars  
24 (\$30). This fine shall be subject to prepayment. A fine imposed under this  
25 subsection shall not be subject to court costs pursuant to KRS 24A.175, additional  
26 court costs pursuant to KRS 24A.176, a fee imposed pursuant to KRS 24A.1765, or  
27 any other additional fees or costs. A person who has not been previously charged

- 1 with a violation of KRS 189.125(3)(b) may elect to acquire a booster seat meeting  
2 the requirements of KRS 189.125. Upon presentation of sufficient proof of the  
3 acquisition, the charge shall be dismissed and no fees or costs shall be imposed.
- 4 (26) Any person who violates the provisions of KRS 189.125(6) shall be fined an  
5 amount not to exceed twenty-five dollars (\$25). This fine shall be subject to  
6 prepayment. A fine imposed under this subsection shall not be subject to court costs  
7 pursuant to KRS 24A.175, additional court costs pursuant to KRS 24A.176, the fee  
8 imposed pursuant to KRS 24A.1765, or any other additional fees or costs.
- 9 (27) Fines levied pursuant to this chapter shall be assessed in the manner required by  
10 KRS 534.020, in amounts consistent with this chapter. Nonpayment of fines shall  
11 be governed by KRS 534.020 and 534.060.
- 12 (28) A licensed driver under the age of eighteen (18) charged with a moving violation  
13 pursuant to this chapter as the driver of a motor vehicle may be referred, prior to  
14 trial, by the court to a diversionary program. The diversionary program under this  
15 subsection shall consist of one (1) or both of the following:
- 16 (a) Execution of a diversion agreement which prohibits the driver from operating  
17 a vehicle for a period not to exceed forty-five (45) days and which allows the  
18 court to retain the driver's operator's license during this period; and
- 19 (b) Attendance at a driver improvement clinic established pursuant to KRS  
20 186.574. If the person completes the terms of this diversionary program  
21 satisfactorily the violation shall be dismissed.
- 22 (29) A person who violates the provisions of subsection (2) or (3) of KRS 189.459 shall  
23 be fined two hundred fifty dollars (\$250). The fines and costs for a violation of  
24 subsection (2) or (3) of KRS 189.459 shall be collected and disposed of in  
25 accordance with KRS 24A.180. Once deposited into the State Treasury, ninety  
26 percent (90%) of the fine collected under this subsection shall immediately be  
27 forwarded to the personal care assistance program under KRS 205.900 to 205.920.

1 Ten percent (10%) of the fine collected under this subsection shall annually be  
2 returned to the county where the violation occurred and distributed equally to all  
3 law enforcement agencies within the county.

4 (30) Any person who violates KRS 189.292 or 189.294 shall be fined twenty-five dollars  
5 (\$25) for the first offense and fifty dollars (\$50) for each subsequent offense.

6 (31) Any person who violates KRS 189.281(5) or (7)(b) shall be subject to a fine of two  
7 hundred fifty dollars (\$250). This fine shall be subject to prepayment. A fine  
8 imposed under this subsection shall not be subject to court costs pursuant to KRS  
9 24A.175, additional costs pursuant to KRS 24A.176, the fee imposed pursuant to  
10 KRS 24A.1765, or any other additional fees or costs.

11 ➔Section 8. KRS 189.370 is amended to read as follows:

12 (1) If any school or church bus used in the transportation of children is stopped upon a  
13 highway for the purpose of receiving or discharging passengers, with the stop arm  
14 and signal lights activated, the operator of a vehicle approaching from any direction  
15 shall bring his vehicle to a stop and shall not proceed until the bus has completed  
16 receiving or discharging passengers and has been put into motion. The stop  
17 requirement provided for in this section shall not apply to vehicles approaching a  
18 stopped bus from the opposite direction upon a highway of four (4) or more lanes  
19 **divided by an elevated barrier or unpaved median.**

20 (2) ~~[Subsection (1) of ]~~This section shall be applicable only when the bus displays the  
21 markings and equipment required by Kentucky minimum specifications for school  
22 buses.

23 (3) If any vehicle is witnessed to be in violation of ~~[subsection (1) of ]~~ this section and  
24 the identity of the operator is not otherwise apparent, it shall be a rebuttable  
25 presumption that the person in whose name the vehicle is registered or leased was  
26 the operator of the vehicle at the time of the alleged violation and is subject to the  
27 penalties as provided for in KRS 189.990(5).

1        ➔Section 9. KRS 64.090 is amended to read as follows:

2        (1) Sheriffs may charge and collect the following fees from the Commonwealth and  
3        any of its agencies, including the Department of Kentucky State Police, when the  
4        source of payment is not otherwise specified, if the Commonwealth, any of its  
5        agencies, or the Department of Kentucky State Police makes a request that the  
6        sheriff perform any of the following:

7        (a) Executing and returning process..... \$20.00;

8        (b) Serving an order of court and return ..... 3.00;

9        (c) Summoning or subpoenaing each witness, fee to be paid by requester  
10        to sheriff before service ..... 10.00;

11        (d) Summoning an appraiser or reviewer ..... 2.00;

12        (e) Attending a surveyor, when ordered by a  
13        court, per deputy or sheriff assigned ..... 20.00;

14        (f) Taking any bond that he is authorized or  
15        required to take in any action ..... 5.00;

16        (g) Collecting money under execution or distress warrant, if the debt is paid or the  
17        property sold, or a delivery bond given and not complied with, six percent  
18        (6%) on the first three hundred dollars (\$300) and three percent (3%) on the  
19        residue; when he or she levies an execution or distress warrant, and the  
20        defendant replevies the debt, or the writ is stayed by legal proceedings or by  
21        the order of the plaintiff, half of the above commissions, to be charged to the  
22        plaintiff and collected as costs in the case;

23        (h) Taking a recognizance of a witness ..... 3.00;

24        (i) Levying an attachment ..... 5.00;

25        (j) When property attached is sold by an officer other than the officer levying the  
26        attachment, the court shall, in the judgment, make the officer an additional  
27        and reasonable allowance for levying the attachment, and the fee of the officer

- 1 selling the property shall be lessened by that sum. Reasonable charges for  
 2 removing and taking care of attached property shall be allowed by order of  
 3 court;
- 4 (k) Summoning a garnishee ..... 3.00;
- 5 (l) Summoning a jury in a misdemeanor case, attending the trial, and  
 6 conducting the defendant to jail, to be paid by the party  
 7 convicted ..... 8.00;
- 8 (m) Serving process or arresting the party in  
 9 misdemeanor cases, to be paid by the plaintiff ..... 30.00;
- 10 (n) Serving an order or process of revivor ..... 3.00;
- 11 (o) Executing a writ of possession against each tenant or defendant ..... 7.00;
- 12 (p) Executing a capias ad satisfaciendum, the same commission as collecting

 25 roads, to be paid out of the county levy ..... 5.00;
- 26 (x) Serving each summons or order of court in applications concerning  
 27 roads, to be paid out of the county levy if the road is established,
