

1 AN ACT relating to reorganization.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 12.020 is amended to read as follows:

4 Departments, program cabinets and their departments, and the respective major
5 administrative bodies that they include are enumerated in this section. It is not intended
6 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
7 bureau, interstate compact, commission, committee, conference, council, office, or any
8 other form of organization shall be included in or attached to the department or program
9 cabinet in which they are included or to which they are attached by statute or statutorily
10 authorized executive order; except in the case of the Personnel Board and where the
11 attached department or administrative body is headed by a constitutionally elected officer,
12 the attachment shall be solely for the purpose of dissemination of information and
13 coordination of activities and shall not include any authority over the functions,
14 personnel, funds, equipment, facilities, or records of the department or administrative
15 body.

8 ➔Section 2. KRS 12.252 is amended to read as follows:

- 9 (1) There is established within the Public Protection Cabinet a Department of Financial
10 Institutions, a Department of Insurance, a Department of Housing, Buildings and
11 Construction, a Department of Charitable Gaming, a Department of Professional
12 Licensing, and a Department of Alcoholic Beverage Control. Each department shall
13 be headed by a commissioner appointed by the Governor as required by KRS
14 12.040 and, where appropriate, by KRS 238.510, 241.015, and 304.2-020.
15 Commissioners shall be directly responsible to the secretary and shall perform the
16 functions, powers, and duties provided by law and prescribed by the secretary.
- 17 (2) The secretary of the Public Protection Cabinet shall be appointed by the Governor
18 in accordance with KRS 12.255. The Office of the Secretary shall contain the
19 following entities:
 - 20 (a) The Office of Communications and Public Outreach, which shall be headed
21 by an executive director appointed by the secretary with the approval of the
22 Governor in accordance with KRS 12.050;
 - 23 (b) The Office of Legal Services, which shall be headed by an executive director
24 appointed by the secretary with the approval of the Governor in accordance
25 with KRS 12.050 and 12.210;
 - 26 (c) The Office of Administrative Hearings, which shall be headed by an executive
27 director appointed by the secretary with the approval of the Governor in

1 accordance with KRS 12.050 and 12.210;~~and~~

2 (d) The Office of Administrative Services, which shall be headed by an executive
3 director appointed by the secretary with the approval of the Governor in
4 accordance with KRS 12.050; and

5 *(e) The Office of Information Technology, which shall be headed by an*
6 *executive director appointed by the secretary with the approval of the*
7 *Governor in accordance with KRS 12.050.*

8 (3) There is established within the Public Protection Cabinet the Kentucky Claims
9 Commission pursuant to KRS 49.010.

10 (4) The Kentucky Horse Racing Commission is attached to the Public Protection
11 Cabinet for administrative purposes only, except as provided in KRS 131.330.

12 (5) There is established within the Public Protection Cabinet the Kentucky Boxing and
13 Wrestling Commission, which shall be headed by an executive director appointed
14 by the secretary with the approval of the Governor as required by KRS 12.050. The
15 executive director shall be directly responsible to the secretary and shall perform the
16 functions, powers, and duties provided by law and prescribed by the secretary.

17 ➔Section 3. KRS 304.2-020 is amended to read as follows:

18 (1) The commissioner is the head of the Department of Insurance.

19 (2) The commissioner shall be appointed by the Governor with the consent of the
20 Senate, for a term not to exceed four (4) years on the basis of his or her merit and
21 fitness to perform the duties of the office as provided in KRS 12.040. If the Senate
22 is not in session when a term expires or a vacancy occurs, the Governor shall make
23 the appointment to take effect at once, subject to the approval of the Senate when
24 convened. Nothing contained in this subsection shall prohibit the commissioner of
25 the Department of Insurance from being reappointed.

26 (3) The following divisions are established within the Department of Insurance and
27 shall be headed by directors appointed by the secretary of the Public Protection

10 Executive Order 2020-821, dated September 25, 2020, and Executive Order 2020-1028,
11 dated December 11, 2020, to the extent they are not otherwise confirmed or superseded
12 by this Act.
