

1 AN ACT relating to controlled substances.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 218A.010 is amended to read as follows:

4 As used in this chapter:

- 5 (1) "Administer" means the direct application of a controlled substance, whether by
6 injection, inhalation, ingestion, or any other means, to the body of a patient or
7 research subject by:
- 8 (a) A practitioner or by his or her authorized agent under his or her immediate
9 supervision and pursuant to his or her order; or
- 10 (b) The patient or research subject at the direction and in the presence of the
11 practitioner;
- 12 (2) "Anabolic steroid" means any drug or hormonal substance chemically and
13 pharmacologically related to testosterone that promotes muscle growth and includes
14 those substances listed in KRS 218A.090(5) but does not include estrogens,
15 progestins, and anticosteroids;
- 16 (3) "Cabinet" means the Cabinet for Health and Family Services;
- 17 (4) "Child" means any person under the age of majority as specified in KRS 2.015;
- 18 (5) "Cocaine" means a substance containing any quantity of cocaine, its salts, optical
19 and geometric isomers, and salts of isomers;
- 20 (6) "Controlled substance" means methamphetamine, or a drug, substance, or
21 immediate precursor in Schedules I through V and includes a controlled substance
22 analogue;
- 23 (7) (a) "Controlled substance analogue," except as provided in paragraph (b) of this
24 subsection, means a substance:
- 25 1. The chemical structure of which is substantially similar to the structure
26 of a controlled substance in Schedule I or II; and
- 27 2. Which has a stimulant, depressant, or hallucinogenic effect on the

1 central nervous system that is substantially similar to or greater than the
2 stimulant, depressant, or hallucinogenic effect on the central nervous
3 system of a controlled substance in Schedule I or II; or

4 3. With respect to a particular person, which such person represents or
5 intends to have a stimulant, depressant, or hallucinogenic effect on the
6 central nervous system that is substantially similar to or greater than the
7 stimulant, depressant, or hallucinogenic effect on the central nervous
8 system of a controlled substance in Schedule I or II.

9 (b) Such term does not include:

10 1. Any substance for which there is an approved new drug application;
11 2. With respect to a particular person, any substance if an exemption is in
12 effect for investigational use for that person pursuant to federal law to
13 the extent conduct with respect to such substance is pursuant to such
14 exemption; or

15 3. Any substance to the extent not intended for human consumption before
16 the exemption described in subparagraph 2. of this paragraph takes
17 effect with respect to that substance;

18 (8) "Counterfeit substance" means a controlled substance which, or the container or
19 labeling of which, without authorization, bears the trademark, trade name, or other
20 identifying mark, imprint, number, or device, or any likeness thereof, of a
21 manufacturer, distributor, or dispenser other than the person who in fact
22 manufactured, distributed, or dispensed the substance;

23 (9) "Dispense" means to deliver a controlled substance to an ultimate user or research
24 subject by or pursuant to the lawful order of a practitioner, including the packaging,
25 labeling, or compounding necessary to prepare the substance for that delivery;

26 (10) "Dispenser" means a person who lawfully dispenses a Schedule II, III, IV, or V
27 controlled substance to or for the use of an ultimate user;

- 1 (11) "Distribute" means to deliver other than by administering or dispensing a controlled
2 substance;
- 3 (12) "Dosage unit" means a single pill, capsule, ampule, liquid, or other form of
4 administration available as a single unit;
- 5 (13) "Drug" means:
- 6 (a) Substances recognized as drugs in the official United States Pharmacopoeia,
7 official Homeopathic Pharmacopoeia of the United States, or official National
8 Formulary, or any supplement to any of them;
- 9 (b) Substances intended for use in the diagnosis, care, mitigation, treatment, or
10 prevention of disease in man or animals;
- 11 (c) Substances (other than food) intended to affect the structure or any function of
12 the body of man or animals; and
- 13 (d) Substances intended for use as a component of any article specified in this
14 subsection.

15 It does not include devices or their components, parts, or accessories;

- 16 (14) "Fentanyl" means a substance containing any quantity of fentanyl, or any of its
17 analogues or derivatives;
- 18 (15) "Fentanyl derivative" means any of the following fentanyl derivatives including
19 their isomers, esters, ethers, salts, salts of isomers, esters, and ethers:
- 20 (a) Immediate precursors of fentanyl;
- 21 (b) Acetyl-alpha-methyl fentanyl, N-1-(1-methyl-2-phenethyl)-4-piperidinyl -N-
22 phenylacetamide;
- 23 (c) Alfentanil;
- 24 (d) Alpha-methylfentanyl, N-1-(alpha-methyl-beta-phenyl) ethyl-4-piperidyl
25 propionanilide, 1-(1-methyl-2-phenylethyl)-4-(N-propanilido) piperidine;
- 26 (e) Alpha-methylthiofentanyl, N-1-methyl-2-(2-thienyl) ethyl-4-piperidinyl-N-
27 phenylpropanamide;

- 1 (f) Benzylfentanyl, N-1-benzyl-4-piperidyl-N-phenylpropanamide;
 2 (g) Beta-hydroxyfentanyl, N-1-(2-hydroxy-2-phenethyl)-4-piperidinyl-N-
 3 phenylpropanamide;
 4 (h) Beta-hydroxy-3-methylfentanyl, N-1-(2-hydroxy-2phenethyl)-3-methyl-4-
 5 piperidinyl-N-phenylpropanamide;
 6 (i) Carfentanil;
 7 (j) Fentanyl;
 8 (k) 3-Methylfentanyl, N-3-methyl-1-(2-phenylethyl)-4-piperidyl-N-
 9 phenylpropanamide;
 10 (l) 3-methylthiofentanyl N-3-methyl-1-(2-thienyl) ethyl-4-piperidinyl-N-
 11 phenylpropanamide;
 12 (m) 1-methyl-4-phenyl-4-propionoxypiperidine (MPPP);
 13 (n) Para-fluorofentanyl, N-(4-fluorophenyl)-N-(1-(2-phenethyl)-4-
 14 piperidinyl)propanamide;
 15 (o) 1-(2-phenethyl)-4-phenyl-4-acetoxypiperidine (PEPAP);
 16 (p) Remifentanil;
 17 (q) Sufentanil;
 18 (r) Thenylfentanyl, N-1-(2-thienyl) methyl-4-piperidyl-N-phenyl-propanamide;
 19 and
 20 (s) Thiofentanyl, N-phenyl-N-1-(2-thienyl)ethyl-4-piperidinylpropan-amide;

21 **(16)** "Good faith prior examination," as used in KRS Chapter 218A and for criminal
 22 prosecution only, means an in-person medical examination of the patient conducted
 23 by the prescribing practitioner or other health-care professional routinely relied
 24 upon in the ordinary course of his or her practice, at which time the patient is
 25 physically examined and a medical history of the patient is obtained. "In-person"
 26 includes telehealth examinations. This subsection shall not be applicable to hospice
 27 providers licensed pursuant to KRS Chapter 216B;

1 ~~(17)~~~~(15)~~ "Hazardous chemical substance" includes any chemical substance used or
2 intended for use in the illegal manufacture of a controlled substance as defined in
3 this section or the illegal manufacture of methamphetamine as defined in KRS
4 218A.1431, which:

- 5 (a) Poses an explosion hazard;
- 6 (b) Poses a fire hazard; or
- 7 (c) Is poisonous or injurious if handled, swallowed, or inhaled;

8 ~~(18)~~~~(16)~~ "Heroin" means a substance containing any quantity of heroin, or any of its
9 salts, isomers, or salts of isomers;

10 ~~(19)~~~~(17)~~ "Hydrocodone combination product" means a drug with:

- 11 (a) Not more than three hundred (300) milligrams of dihydrocodeinone, or any of
12 its salts, per one hundred (100) milliliters or not more than fifteen (15)
13 milligrams per dosage unit, with a fourfold or greater quantity of an
14 isoquinoline alkaloid of opium; or
- 15 (b) Not more than three hundred (300) milligrams of dihydrocodeinone, or any of
16 its salts, per one hundred (100) milliliters or not more than fifteen (15)
17 milligrams per dosage unit, with one (1) or more active, nonnarcotic
18 ingredients in recognized therapeutic amounts;

19 ~~(20)~~~~(18)~~ "Immediate precursor" means a substance which is the principal compound
20 commonly used or produced primarily for use, and which is an immediate chemical
21 intermediary used or likely to be used in the manufacture of a controlled substance
22 or methamphetamine, the control of which is necessary to prevent, curtail, or limit
23 manufacture;

24 ~~(21)~~~~(19)~~ "Intent to manufacture" means any evidence which demonstrates a person's
25 conscious objective to manufacture a controlled substance or methamphetamine.
26 Such evidence includes but is not limited to statements and a chemical substance's
27 usage, quantity, manner of storage, or proximity to other chemical substances or

1 equipment used to manufacture a controlled substance or methamphetamine;

2 ~~(22)~~~~(20)~~ "Isomer" means the optical isomer, except as used in KRS 218A.050(3) and
3 218A.070(1)(d). As used in KRS 218A.050(3), the term "isomer" means the optical,
4 positional, or geometric isomer. As used in KRS 218A.070(1)(d), the term "isomer"
5 means the optical or geometric isomer;

6 ~~(23)~~~~(21)~~ "Manufacture," except as provided in KRS 218A.1431, means the production,
7 preparation, propagation, compounding, conversion, or processing of a controlled
8 substance, either directly or indirectly by extraction from substances of natural
9 origin or independently by means of chemical synthesis, or by a combination of
10 extraction and chemical synthesis, and includes any packaging or repackaging of the
11 substance or labeling or relabeling of its container except that this term does not
12 include activities:

13 (a) By a practitioner as an incident to his or her administering or dispensing of a
14 controlled substance in the course of his or her professional practice;

15 (b) By a practitioner, or by his or her authorized agent under his supervision, for
16 the purpose of, or as an incident to, research, teaching, or chemical analysis
17 and not for sale; or

18 (c) By a pharmacist as an incident to his or her dispensing of a controlled
19 substance in the course of his or her professional practice;

20 ~~(24)~~~~(22)~~ "Marijuana" means all parts of the plant *Cannabis* sp., whether growing or
21 not; the seeds thereof; the resin extracted from any part of the plant; and every
22 compound, manufacture, salt, derivative, mixture, or preparation of the plant, its
23 seeds or resin or any compound, mixture, or preparation which contains any
24 quantity of these substances. The term "marijuana" does not include:

25 (a) Industrial hemp as defined in KRS 260.850;

26 (b) The substance cannabidiol, when transferred, dispensed, or administered
27 pursuant to the written order of a physician practicing at a hospital or

1 associated clinic affiliated with a Kentucky public university having a college
2 or school of medicine; or

3 (c) For persons participating in a clinical trial or in an expanded access program,
4 a drug or substance approved for the use of those participants by the United
5 States Food and Drug Administration;

6 ~~(25)~~~~(23)~~ "Medical history," as used in KRS Chapter 218A and for criminal prosecution
7 only, means an accounting of a patient's medical background, including but not
8 limited to prior medical conditions, prescriptions, and family background;

9 ~~(26)~~~~(24)~~ "Medical order," as used in KRS Chapter 218A and for criminal prosecution
10 only, means a lawful order of a specifically identified practitioner for a specifically
11 identified patient for the patient's health-care needs. "Medical order" may or may
12 not include a prescription drug order;

13 ~~(27)~~~~(25)~~ "Medical record," as used in KRS Chapter 218A and for criminal prosecution
14 only, means a record, other than for financial or billing purposes, relating to a
15 patient, kept by a practitioner as a result of the practitioner-patient relationship;

16 ~~(28)~~~~(26)~~ "Methamphetamine" means any substance that contains any quantity of
17 methamphetamine, or any of its salts, isomers, or salts of isomers;

18 ~~(29)~~~~(27)~~ "Narcotic drug" means any of the following, whether produced directly or
19 indirectly by extraction from substances of vegetable origin, or independently by
20 means of chemical synthesis, or by a combination of extraction and chemical
21 synthesis:

22 (a) Opium and opiate, and any salt, compound, derivative, or preparation of
23 opium or opiate;

24 (b) Any salt, compound, isomer, derivative, or preparation thereof which is
25 chemically equivalent or identical with any of the substances referred to in
26 paragraph (a) of this subsection, but not including the isoquinoline alkaloids
27 of opium;

- 1 (c) Opium poppy and poppy straw;
- 2 (d) Coca leaves, except coca leaves and extracts of coca leaves from which
3 cocaine, ecgonine, and derivatives of ecgonine or their salts have been
4 removed;
- 5 (e) Cocaine, its salts, optical and geometric isomers, and salts of isomers;
- 6 (f) Ecgonine, its derivatives, their salts, isomers, and salts of isomers; and
- 7 (g) Any compound, mixture, or preparation which contains any quantity of any of
8 the substances referred to in paragraphs (a) to (f) of this subsection;
- 9 (30)~~[(28)]~~ "Opiate" means any substance having an addiction-forming or addiction-
10 sustaining liability similar to morphine or being capable of conversion into a drug
11 having addiction-forming or addiction-sustaining liability. It does not include,
12 unless specifically designated as controlled under KRS 218A.030, the
13 dextrorotatory isomer of 3-methoxy-n-methylmorphinan and its salts
14 (dextromethorphan). It does include its racemic and levorotatory forms;
- 15 (31)~~[(29)]~~ "Opium poppy" means the plant of the species papaver somniferum L., except
16 its seeds;
- 17 (32)~~[(30)]~~ "Person" means individual, corporation, government or governmental
18 subdivision or agency, business trust, estate, trust, partnership or association, or any
19 other legal entity;
- 20 (33)~~[(31)]~~ "Physical injury" has the same meaning it has in KRS 500.080;
- 21 (34)~~[(32)]~~ "Poppy straw" means all parts, except the seeds, of the opium poppy, after
22 mowing;
- 23 (35)~~[(33)]~~ "Pharmacist" means a natural person licensed by this state to engage in the
24 practice of the profession of pharmacy;
- 25 (36)~~[(34)]~~ "Practitioner" means a physician, dentist, podiatrist, veterinarian, scientific
26 investigator, optometrist as authorized in KRS 320.240, advanced practice
27 registered nurse as authorized under KRS 314.011, or other person licensed,

1 registered, or otherwise permitted by state or federal law to acquire, distribute,
2 dispense, conduct research with respect to, or to administer a controlled substance
3 in the course of professional practice or research in this state. "Practitioner" also
4 includes a physician, dentist, podiatrist, veterinarian, or advanced practice registered
5 nurse authorized under KRS 314.011 who is a resident of and actively practicing in
6 a state other than Kentucky and who is licensed and has prescriptive authority for
7 controlled substances under the professional licensing laws of another state, unless
8 the person's Kentucky license has been revoked, suspended, restricted, or probated,
9 in which case the terms of the Kentucky license shall prevail;

10 ~~(37)~~~~(35)~~ "Practitioner-patient relationship," as used in KRS Chapter 218A and for
11 criminal prosecution only, means a medical relationship that exists between a
12 patient and a practitioner or the practitioner's designee, after the practitioner or his
13 or her designee has conducted at least one (1) good faith prior examination;

14 ~~(38)~~~~(36)~~ "Prescription" means a written, electronic, or oral order for a drug or
15 medicine, or combination or mixture of drugs or medicines, or proprietary
16 preparation, signed or given or authorized by a medical, dental, chiropody,
17 veterinarian, optometric practitioner, or advanced practice registered nurse, and
18 intended for use in the diagnosis, cure, mitigation, treatment, or prevention of
19 disease in man or other animals;

20 ~~(39)~~~~(37)~~ "Prescription blank," with reference to a controlled substance, means a
21 document that meets the requirements of KRS 218A.204 and 217.216;

22 ~~(40)~~~~(38)~~ "Presumptive probation" means a sentence of probation not to exceed the
23 maximum term specified for the offense, subject to conditions otherwise authorized
24 by law, that is presumed to be the appropriate sentence for certain offenses
25 designated in this chapter, notwithstanding contrary provisions of KRS Chapter
26 533. That presumption shall only be overcome by a finding on the record by the
27 sentencing court of substantial and compelling reasons why the defendant cannot be

1 safely and effectively supervised in the community, is not amenable to community-
2 based treatment, or poses a significant risk to public safety;

3 ~~(41)~~~~(39)~~ "Production" includes the manufacture, planting, cultivation, growing, or
4 harvesting of a controlled substance;

5 ~~(42)~~~~(40)~~ "Recovery program" means an evidence-based, nonclinical service that assists
6 individuals and families working toward sustained recovery from substance use and
7 other criminal risk factors. This can be done through an array of support programs
8 and services that are delivered through residential and nonresidential means;

9 ~~(43)~~~~(41)~~ "Salvia" means *Salvia divinorum* or Salvinorin A and includes all parts of the
10 plant presently classified botanically as *Salvia divinorum*, whether growing or not,
11 the seeds thereof, any extract from any part of that plant, and every compound,
12 manufacture, derivative, mixture, or preparation of that plant, its seeds, or its
13 extracts, including salts, isomers, and salts of isomers whenever the existence of
14 such salts, isomers, and salts of isomers is possible within the specific chemical
15 designation of that plant, its seeds, or extracts. The term shall not include any other
16 species in the genus *salvia*;

17 ~~(44)~~~~(42)~~ "Second or subsequent offense" means that for the purposes of this chapter an
18 offense is considered as a second or subsequent offense, if, prior to his or her
19 conviction of the offense, the offender has at any time been convicted under this
20 chapter, or under any statute of the United States, or of any state relating to
21 substances classified as controlled substances or counterfeit substances, except that
22 a prior conviction for a nontrafficking offense shall be treated as a prior offense
23 only when the subsequent offense is a nontrafficking offense. For the purposes of
24 this section, a conviction voided under KRS 218A.275 or 218A.276 shall not
25 constitute a conviction under this chapter;

26 ~~(45)~~~~(43)~~ "Sell" means to dispose of a controlled substance to another person for
27 consideration or in furtherance of commercial distribution;

1 ~~(46)~~~~[(44)]~~ "Serious physical injury" has the same meaning it has in KRS 500.080;

2 ~~(47)~~~~[(45)]~~ "Synthetic cannabinoids or piperazines" means any chemical compound which
3 is not approved by the United States Food and Drug Administration or, if approved,
4 which is not dispensed or possessed in accordance with state and federal law, that
5 contains Benzylpiperazine (BZP); Trifluoromethylphenylpiperazine (TFMPP); 1,1-
6 Dimethylheptyl-11-hydroxytetrahydrocannabinol (HU-210); 1-Butyl-3-(1-
7 naphthoyl)indole; 1-Pentyl-3-(1-naphthoyl)indole; dexanabinol (HU-211); or any
8 compound in the following structural classes:

9 (a) Naphthoylindoles: Any compound containing a 3-(1-naphthoyl)indole
10 structure with substitution at the nitrogen atom of the indole ring by an alkyl,
11 haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-methyl-2-
12 piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group, whether or not further
13 substituted in the indole ring to any extent and whether or not substituted in
14 the naphthyl ring to any extent. Examples of this structural class include but
15 are not limited to JWH-015, JWH-018, JWH-019, JWH-073, JWH-081,
16 JWH-122, JWH-200, and AM-2201;

17 (b) Phenylacetylindoles: Any compound containing a 3-phenylacetylindole
18 structure with substitution at the nitrogen atom of the indole ring by an alkyl,
19 haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-methyl-2-
20 piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group whether or not further
21 substituted in the indole ring to any extent and whether or not substituted in
22 the phenyl ring to any extent. Examples of this structural class include but are
23 not limited to JWH-167, JWH-250, JWH-251, and RCS-8;

24 (c) Benzoylindoles: Any compound containing a 3-(benzoyl)indole structure with
25 substitution at the nitrogen atom of the indole ring by an alkyl, haloalkyl,
26 alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-methyl-2-piperidinyl)methyl,
27 or 2-(4-morpholinyl)ethyl group whether or not further substituted in the

- 1 indole ring to any extent and whether or not substituted in the phenyl ring to
2 any extent. Examples of this structural class include but are not limited to
3 AM-630, AM-2233, AM-694, Pravadoline (WIN 48,098), and RCS-4;
- 4 (d) Cyclohexylphenols: Any compound containing a 2-(3-
5 hydroxycyclohexyl)phenol structure with substitution at the 5-position of the
6 phenolic ring by an alkyl, haloalkyl, alkenyl, cycloalkylmethyl,
7 cycloalkylethyl, 1-(N-methyl-2-piperidinyl)methyl, or 2-(4-morpholinyl)ethyl
8 group whether or not substituted in the cyclohexyl ring to any extent.
9 Examples of this structural class include but are not limited to CP 47,497 and
10 its C8 homologue (cannabicyclohexanol);
- 11 (e) Naphthylmethylindeles: Any compound containing a 1H-indol-3-yl-(1-
12 naphthyl)methane structure with substitution at the nitrogen atom of the indole
13 ring by an alkyl, haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-
14 methyl-2-piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group whether or not
15 further substituted in the indole ring to any extent and whether or not
16 substituted in the naphthyl ring to any extent. Examples of this structural class
17 include but are not limited to JWH-175, JWH-184, and JWH-185;
- 18 (f) Naphthoypyrroles: Any compound containing a 3-(1-naphthoypyrrole
19 structure with substitution at the nitrogen atom of the pyrrole ring by an alkyl,
20 haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-methyl-2-
21 piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group whether or not further
22 substituted in the pyrrole ring to any extent and whether or not substituted in
23 the naphthyl ring to any extent. Examples of this structural class include but
24 are not limited to JWH-030, JWH-145, JWH-146, JWH-307, and JWH-368;
- 25 (g) Naphthylmethylindenes: Any compound containing a 1-(1-
26 naphthylmethyl)indene structure with substitution at the 3-position of the
27 indene ring by an alkyl, haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl,

1 1-(N-methyl-2-piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group whether
2 or not further substituted in the indene ring to any extent and whether or not
3 substituted in the naphthyl ring to any extent. Examples of this structural class
4 include but are not limited to JWH-176;

5 (h) Tetramethylcyclopropanoylindoles: Any compound containing a 3-(1-
6 tetramethylcyclopropoyl)indole structure with substitution at the nitrogen
7 atom of the indole ring by an alkyl, haloalkyl, cycloalkylmethyl,
8 cycloalkylethyl, 1-(N-methyl-2-piperidinyl)methyl, or 2-(4-morpholinyl)ethyl
9 group, whether or not further substituted in the indole ring to any extent and
10 whether or not further substituted in the tetramethylcyclopropyl ring to any
11 extent. Examples of this structural class include but are not limited to UR-144
12 and XLR-11;

13 (i) Adamantoylindoles: Any compound containing a 3-(1-adamantoyl)indole
14 structure with substitution at the nitrogen atom of the indole ring by an alkyl,
15 haloalkyl, alkenyl, cycloalkylmethyl, cycloalkylethyl, 1-(N-methyl-2-
16 piperidinyl)methyl, or 2-(4-morpholinyl)ethyl group, whether or not further
17 substituted in the indole ring to any extent and whether or not substituted in
18 the adamantyl ring system to any extent. Examples of this structural class
19 include but are not limited to AB-001 and AM-1248; or

20 (j) Any other synthetic cannabinoid or piperazine which is not approved by the
21 United States Food and Drug Administration or, if approved, which is not
22 dispensed or possessed in accordance with state and federal law;

23 ~~(48)~~~~(46)~~ "Synthetic cathinones" means any chemical compound which is not approved
24 by the United States Food and Drug Administration or, if approved, which is not
25 dispensed or possessed in accordance with state and federal law (not including
26 bupropion or compounds listed under a different schedule) structurally derived from
27 2-aminopropan-1-one by substitution at the 1-position with either phenyl, naphthyl,

1 or thiophene ring systems, whether or not the compound is further modified in one
2 (1) or more of the following ways:

3 (a) By substitution in the ring system to any extent with alkyl, alkylendioxy,
4 alkoxy, haloalkyl, hydroxyl, or halide substituents, whether or not further
