

1 AN ACT relating to the Office of Claims and Appeals.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 11A.010 (Effective April 1, 2021) is amended to read as
4 follows:

5 As used in this chapter, unless the context otherwise requires:

- 6 (1) "Business" means any corporation, limited liability company, partnership, limited
7 partnership, sole proprietorship, firm, enterprise, franchise, association,
8 organization, self-employed individual, holding company, joint stock company,
9 receivership, trust, or any legal entity through which business is conducted, whether
10 or not for profit;
- 11 (2) "Commission" means the Executive Branch Ethics Commission;
- 12 (3) "Compensation" means any money, thing of value, or economic benefit conferred
13 on, or received by, any person in return for services rendered, or to be rendered, by
14 himself or herself or another;
- 15 (4) "Family" means spouse and children, as well as a person who is related to a public
16 servant as any of the following, whether by blood or adoption: parent, brother,
17 sister, grandparent, grandchild, father-in-law, mother-in-law, brother-in-law, sister-
18 in-law, son-in-law, daughter-in-law, stepfather, stepmother, stepson, stepdaughter,
19 stepbrother, stepsister, half brother, half sister;
- 20 (5) "Gift" means a payment, loan, subscription, advance, deposit of money, services, or
21 anything of value, unless consideration of equal or greater value is received; "gift"
22 does not include gifts from family members, campaign contributions, the waiver of
23 a registration fee for a presenter at a conference or training described in KRS
24 45A.097(5), or door prizes available to the public;
- 25 (6) "Income" means any money or thing of value received or to be received as a claim
26 on future services, whether in the form of a fee, salary, expense allowance,
27 forbearance, forgiveness, interest, dividend, royalty, rent, capital gain, or any other

1 form of compensation or any combination thereof;

2 (7) "Officer" means:

3 (a) All major management personnel in the executive branch of state government,
 4 including the secretary of the cabinet, the Governor's chief executive officers,
 5 cabinet secretaries, deputy cabinet secretaries, general counsels,
 6 commissioners, deputy commissioners, executive directors, executive
 7 assistants, policy advisors, special assistants, administrative coordinators,
 8 executive advisors, staff assistants, and division directors;

9 (b) Members and full-time chief administrative officers of:

2 employment arrangement with an agency, performs on a full-time,
3 nonseasonal basis a function of any major management position listed in this
4 subsection;
- 5 (8) "Official duty" means any responsibility imposed on a public servant by virtue of
6 his or her position in the state service;
- 7 (9) "Public servant" means:
- 8 (a) The Governor;
- 9 (b) The Lieutenant Governor;
- 10 (c) The Secretary of State;
- 11 (d) The Attorney General;
- 12 (e) The Treasurer;
- 13 (f) The Commissioner of Agriculture;
- 14 (g) The Auditor of Public Accounts;
- 15 (h) All employees in the executive branch including officers as defined in
16 subsection (7) of this section and merit employees; and
- 17 (i) Any person who, through any contractual arrangement with an agency, is
18 employed to perform a function of a position within an executive branch
19 agency on a full-time, nonseasonal basis;
- 20 (10) "Agency" means every state office, cabinet, department, board, commission, public
21 corporation, or authority in the executive branch of state government. A public
22 servant is employed by the agency by which his or her appointing authority is
23 employed, unless his or her agency is attached to the appointing authority's agency
24 for administrative purposes only, or unless the agency's characteristics are of a
25 separate independent nature distinct from the appointing authority and it is
26 considered an agency on its own, such as an independent department;
- 27 (11) "Lobbyist" means any person employed as a legislative agent as defined in KRS

- 1 6.611(23) or any person employed as an executive agency lobbyist as defined in
2 KRS 11A.201(9);
- 3 (12) "Lobbyist's principal" means the entity in whose behalf the lobbyist promotes,
4 opposes, or acts;
- 5 (13) "Candidate" means those persons who have officially filed candidacy papers or who
6 have been nominated by their political party pursuant to KRS 118.105, 118.115,
7 118.325, or 118.760 for any of the offices enumerated in subsections (9)(a) to (g) of
8 this section;
- 9 (14) "Does business with" or "doing business with" means contracting, entering into an
10 agreement, leasing, or otherwise exchanging services or goods with a state agency
11 in return for payment by the state, including accepting a grant, but not including
12 accepting a state entitlement fund disbursement;
- 13 (15) "Public agency" means any governmental entity;
- 14 (16) "Appointing authority" means the agency head or any person whom he or she has
15 authorized by law to act on behalf of the agency with respect to employee
16 appointments;
- 17 (17) "Represent" means to attend an agency proceeding, write a letter, or communicate
18 with an employee of an agency on behalf of someone else;
- 19 (18) "Directly involved" means to work on personally or to supervise someone who
20 works on personally;
- 21 (19) "Sporting event" means any professional or amateur sport, athletic game, contest,
22 event, or race involving machines, persons, or animals, for which admission tickets
23 are offered for sale and that is viewed by the public;
- 24 (20) "Person" means an individual, proprietorship, firm, partnership, limited partnership,
25 joint venture, joint stock company, syndicate, business or statutory trust, donative
26 trust, estate, company, corporation, limited liability company, association, club,
27 committee, organization, or group of persons acting in concert; and

1 (21) "Salaried" means receiving a fixed compensation or benefit reserved for full-time
2 employees, which is paid on a regular basis without regard to the actual number of
3 hours worked.

4 ➔Section 2. KRS 12.020 is amended to read as follows:

5 Departments, program cabinets and their departments, and the respective major
6 administrative bodies that they include are enumerated in this section. It is not intended
7 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
8 bureau, interstate compact, commission, committee, conference, council, office, or any
9 other form of organization shall be included in or attached to the department or program
10 cabinet in which they are included or to which they are attached by statute or statutorily
11 authorized executive order; except in the case of the Personnel Board and where the
12 attached department or administrative body is headed by a constitutionally elected officer,
13 the attachment shall be solely for the purpose of dissemination of information and
14 coordination of activities and shall not include any authority over the functions,
15 personnel, funds, equipment, facilities, or records of the department or administrative
16 body.

6 department to any person or be intentionally and without authorization inspected by
7 any present or former commissioner or employee of the Department of Revenue,
8 member of a county board of assessment appeals, property valuation administrator
9 or employee, or any other person.

11 (3) If any taxpayer fails or refuses to make and file a report or return or furnish any
12 information requested in writing by the department, the department may make an
13 estimate of the tax due from any information in its possession, assess the tax at not
14 more than twice the amount estimated to be due, and add a penalty equal to five
15 percent (5%) of the tax assessed for each thirty (30) days or fraction thereof that the
16 return or report is not filed. The total penalty levied pursuant to this subsection shall
17 not exceed fifty percent (50%) of the tax assessed; however, the penalty shall not be
18 less than one hundred dollars (\$100) unless the taxpayer demonstrates that the
19 failure to file was due to reasonable cause as defined in KRS 131.010(9). This
20 penalty shall be applicable whether or not any tax is determined to be due on a
21 subsequently filed return or if the subsequently filed return results in a refund.

18 (2) (a) Each resident wholesaler shall secure a separate license for each place of
19 business at which cigarette tax evidence is affixed or at which cigarettes on
20 which the Kentucky cigarette tax has not been paid are received.

21 (b) Each nonresident wholesaler shall secure a separate license for each place of
22 business at which evidence of Kentucky cigarette tax is affixed or from where
23 Kentucky cigarette tax is reported and paid.

24 (c) Each license shall be secured on or before July 1 of each year.

25 (d) Each licensee shall pay the sum of five hundred dollars (\$500) for each year,
26 or portion thereof, for which each license is secured.

27 (3) (a) Each sub-jobber shall secure a separate license for each place of business from

1 which cigarettes, upon which the cigarette tax has been paid, are made
2 available to retailers, whether the place of business is located within or
3 without this state.

4 (b) Each license shall be secured on or before July 1 of each year.

5 (c) Each licensee shall pay the sum of five hundred dollars (\$500) for each year,

- 7 (7) (a) 1. Each distributor shall secure a license for the privilege of selling tobacco
- 8 products or vapor products in this state. Each license shall be secured on
- 9 or before July 1 of each year, and each licensee shall pay the sum of five
- 10 hundred dollars (\$500) for each year, or portion thereof, for which the
- 11 license is secured.

6 the consent of the victim, or upon the request of the victim, examine such person for
7 the purposes of providing basic medical care relating to the incident and gathering
8 samples that may be used as physical evidence. This examination shall include but
9 not be limited to:

- 10 (a) Basic treatment and sample gathering services; and
11 (b) Laboratory tests, as appropriate.

12 (5) Each victim shall be informed of available services for treatment of sexually
13 transmitted infections, pregnancy, and other medical and psychiatric problems.
14 Pregnancy counseling shall not include abortion counseling or referral information.

15 (6) Each victim shall be informed of available crisis intervention or other mental health
16 services provided by regional rape crisis centers providing services to victims of
17 sexual assault.

18 (7) Notwithstanding any other provision of law, a minor may consent to examination
19 under this section. This consent is not subject to disaffirmance because of minority,
20 and consent of the parents or guardians of the minor is not required for the
21 examination.

22 (8) (a) The examinations provided in accordance with this section shall be paid for by
23 the *Crime Victims Compensation Board*~~[Kentucky Claims Commission]~~ at a
24 rate to be determined by the administrative regulation promulgated by the
25 board after consultation with the Sexual Assault Response Team Advisory
26 Committee as defined in KRS 403.707.

27 (b) Upon receipt of a completed claim form supplied by the board and an

1 itemized billing for a forensic sexual assault examination or related services
2 that are within the scope of practice of the respective provider and were

25 District Court, or in any other Circuit Court or District Court having venue:

26 (1) Actions to collect the revenue and all other claims, demands and penalties due the
27 Commonwealth, or to have satisfaction made of judgments in favor of the

1 Commonwealth, except those actions which are prosecuted by an appeal to the
2 **Board of Tax Appeals**~~[Kentucky Claims Commission]~~ under the provisions of KRS
3 49.220 and 131.110.

4 (2) Actions against persons required to collect money due the Commonwealth, to pay
5 money into the State Treasury, or to do any other act connected with the payment of
6 money into the State Treasury after it has been collected, and against the sureties,
7 heirs, devisees or representatives of such persons.

8 (3) Actions to surcharge and correct fee bills, accounts and settlements, with their
9 debits and credits, and all claims against the Treasury allowed and approved by any
10 court in the Commonwealth to any person.

11 (4) Actions to recover any fraudulent, erroneous or illegal account, fee bill, charge,
12 credit or claim approved and allowed or paid out of the Treasury to any person.

13 (5) The defendant in any action brought in Franklin Circuit Court or Franklin District
14 Court under the provisions of subsection (1) of this section for the collection of
15 taxes assessed under KRS Chapter 141 shall at any time prior to the submission for
16 judgment upon proper motion have a change of venue to the county in which he
17 resides or his principal office or place of business is located at no cost to the
18 defendant in Franklin Circuit Court or Franklin District Court.

19 ➔Section 88. KRS 532.162 is amended to read as follows:

20 (1) If the criminal garnishment is made upon the convicted person's earnings, the order
21 of garnishment shall be a lien upon the earnings from the date of service on the
22 garnishee until an order discontinuing the lien is entered. A convicted person may
23 challenge the garnishment by filing a challenge to the garnishment with the
24 sentencing court. The challenge shall be heard within ten (10) days of its filing or
25 the nearest court date thereafter. Before the hearing, garnishment shall continue.
26 Any moneys which the court determines were improperly garnished shall be repaid
27 to the garnishee not later than thirty (30) days after the determination.

1 (2) The circuit clerk's office shall disburse all collected reimbursement, restitution, and
2 fees to the victim, the Crime Victims Compensation Board~~[Kentucky Claims~~
3 ~~Commission]~~, or the local government, whichever is appropriate. The clerk shall be
4 entitled to collect a fee of two dollars and fifty cents (\$2.50) from each account for
5 which a disbursement is made at the time of disbursement. In the event of challenge
6 to a garnishment, the appropriate clerk's office shall not disburse those sums
7 associated with the challenged garnishment until determination by the sentencing
8 court regarding the propriety of the garnishment.

9 ➔Section 89. KRS 533.030 is amended to read as follows:

10 (1) The conditions of probation and conditional discharge shall be such as the court, in
11 its discretion, deems reasonably necessary to insure that the defendant will lead a
12 law-abiding life or to assist him to do so. The court shall provide as an explicit
13 condition of every sentence to probation or conditional discharge that the defendant
14 not commit another offense during the period for which the sentence remains
15 subject to revocation.

16 (2) When imposing a sentence of probation or conditional discharge, the court may, in
17 addition to any other reasonable condition, require that the defendant:

- 18 (a) Avoid injurious or vicious habits;
- 19 (b) Avoid persons or places of disreputable or harmful character;
- 20 (c) Work faithfully at suitable employment as far as possible;
- 21 (d) Undergo available medical or psychiatric treatment and remain in a specific
22 institution as required for that purpose;
- 23 (e) Post a bond, without surety, conditioned on performance of any of the
24 prescribed conditions;
- 25 (f) Support his dependents and meet other family responsibilities;
- 26 (g) Pay the cost of the proceeding as set by the court;
- 27 (h) Remain within a specified area;

- 1 (i) Report to the probation officer as directed;
- 2 (j) Permit the probation officer to visit him at his home or elsewhere;
- 3 (k) Answer all reasonable inquiries by the probation officer and promptly notify
4 the probation officer of any change in address or employment;
- 5 (l) Submit to periodic testing for the use of controlled substances or alcohol, if
6 the defendant's record indicates a controlled substance or alcohol problem,
7 and to pay a reasonable fee, as determined by the court, which fee shall not
8 exceed the actual cost of the test and analysis and shall be paid directly to the
9 agency or agencies responsible for testing and analysis as compensation for
10 the cost of the testing and analysis, as specified by written order of the court,
11 performed under this subsection. For good cause shown, the testing fee may
12 be waived by the court;
- 13 (m) Use an alcohol monitoring device, as defined in KRS 431.068. All costs
14 associated with the device, including administrative and operating costs, shall
15 be paid by the defendant. If the court determines that the defendant is indigent,
16 and a person, county, or other organization has not agreed to pay the costs for
17 the defendant in an attempt to reduce incarceration expenses and increase
18 public safety, the court shall consider other conditions of probation or
19 conditional discharge provided for in this section; or
- 20 (n) During all or part of the period of probation or conditional discharge,
21 participate in a global positioning monitoring system program operated by a
22 county pursuant to KRS 67.372 and 67.374 under the same terms and
23 conditions as provided in KRS 431.517.
- 24 (3) When imposing a sentence of probation or conditional discharge in a case where a
25 victim of a crime has suffered monetary damage as a result of the crime due to his
26 property having been converted, stolen, or unlawfully obtained, or its value
27 substantially decreased as a result of the crime, or where the victim suffered actual

1 medical expenses, direct out-of-pocket losses, or loss of earning as a direct result of
2 the crime, or where the victim incurred expenses in relocating for the purpose of the
3 victim's safety or the safety of a member of the victim's household, or if as a direct
4 result of the crime the victim incurred medical expenses that were paid by the
5 Cabinet for Health and Family Services, the *Crime Victims Compensation*
6 *Board*~~[Kentucky Claims Commission]~~, or any other governmental entity, the court
7 shall order the defendant to make restitution in addition to any other penalty
8 provided for the commission of the offense. Payment of restitution to the victim
9 shall have priority over payment of restitution to any government agency.
10 Restitution shall be ordered in the full amount of the damages, unless the damages
11 exceed one hundred thousand dollars (\$100,000) or twice the amount of the gain
12 from the commission of the offense, whichever is greater, in which case the higher
13 of these two (2) amounts shall be awarded. The court may, in lieu of ordering
14 monetary restitution, order the defendant to make restitution by working for or on
15 behalf of the victim. The court shall determine the number of hours of work
16 necessary by applying the then-prevailing federal minimum wage to the total
17 amount of monetary damage caused by or incidental to the commission of the
18 crime. The court may, with the consent of the agency, order the defendant to work
19 as specified in KRS 533.070. Any work ordered pursuant to this section shall not be
20 deemed employment for any purpose, nor shall the person performing the work be
21 deemed an employee for any purpose. Where there is more than one (1) defendant
22 or more than one (1) victim, restitution may be apportioned. Restitution shall be
23 subject to the following additional terms and conditions:

- 24 (a) Where property which is unlawfully in the possession of the defendant is in
25 substantially undamaged condition from its condition at the time of the taking,
26 return of the property shall be ordered in lieu of monetary restitution;
- 27 (b) The circuit clerk shall assess an additional fee of five percent (5%) to defray

- 1 the administrative costs of collection of payments or property. This fee shall
2 be paid by the defendant and shall inure to a trust and agency account which
3 shall not lapse and which shall be used to hire additional deputy clerks and
4 office personnel or increase deputy clerk or office personnel salaries, or
5 combination thereof;
- 6 (c) When a defendant fails to make restitution ordered to be paid through the
7 circuit clerk or a court-authorized program run by the county attorney or the
8 Commonwealth's attorney, the circuit clerk or court-authorized program shall
9 notify the court; and
- 10 (d) An order of restitution shall not preclude the owner of property or the victim
11 who suffered personal physical or mental injury or out-of-pocket loss of
12 earnings or support or other damages from proceeding in a civil action to
13 recover damages from the defendant. A civil verdict shall be reduced by the
14 amount paid under the criminal restitution order.
- 15 (4) When requiring fees for controlled substances or alcohol tests, or other fees and
16 payments authorized by this section or other statute, except restitution, to be paid by
17 the defendant, the court shall not order the payments to be paid through the circuit
18 clerk.
- 19 (5) When a defendant is sentenced to probation or conditional discharge, he shall be
20 given a written statement explicitly setting forth the conditions under which he is
21 being released.
- 22 (6) When imposing a sentence of probation or conditional discharge, the court, in
23 addition to conditions imposed under this section, may require as a condition of the
24 sentence that the defendant submit to a period of imprisonment in the county jail or
25 to a period of home incarceration at whatever time or intervals, consecutive or
26 nonconsecutive, the court shall determine. The time actually spent in confinement
27 or home incarceration pursuant to this provision shall not exceed twelve (12)

1 months or the maximum term of imprisonment assessed pursuant to KRS Chapter
2 532, whichever is the shorter. Time spent in confinement or home incarceration
3 under this subsection shall be credited against the maximum term of imprisonment
4 assessed for the defendant pursuant to KRS Chapter 532, if probation or conditional
5 discharge is revoked and the defendant is sentenced to imprisonment. Any
6 prohibitions against probation, shock probation, or conditional discharge under
7 KRS 533.060(2) or 532.045 shall not apply to persons convicted of a misdemeanor
8 or Class D felony and sentenced to a period of confinement or home incarceration
9 under this section.

10 ➔Section 90. The General Assembly hereby confirms Executive Order 2020-708,
11 dated August 31, 2020, to the extent that it is not otherwise confirmed or superseded by
12 this Act, relating to the reorganization of the Public Protection Cabinet, abolishing the
13 Kentucky Claims Commission, and establishing the Office of Claims and Appeals and
14 the Boards attached thereto, namely the Board of Claims, the Board of Tax Appeals, and
15 the Crime Victims Compensation Board.

16 ➔Section 91. The initial membership of the Board of Claims, Board of Tax
17 Appeals, and the Crime Victims Compensation Board shall consist of those individuals
18 appointed by the Governor in Executive Order 2020-708, dated August 31, 2020, and the
19 terms of these initial members shall expire on the dates set out in that order.
