In that same year, he was honored as an alumni fellow at the University of Louisville School of Dentistry. He is a standing member of the Pierre 20 21 Fauchard Academy, the American College of Dentists, and the International College of 22 Dentists. On March 6, 2016, Dr. Collins became the President of the Kentucky Dental 23 Association, and along with these duties he maintains a full-time dental practice in 24 Pikeville and serves as the Dental Director of the Red Bird Clinic, Inc.; and 25 WHEREAS, this august body honors Dr. Bill Collins on this day for his many years 26 of service to the citizens of eastern Kentucky, acknowledges all the work he has 27 accomplished on behalf of those Kentuckians in need, and rightfully thanks him for his
