

1 A RESOLUTION adjourning the House of Representatives in honor and loving
2 memory of Deloris A. "Sandy" Cook.

3 WHEREAS, Deloris A. "Sandy" Cook was born on March 21, 1933, in Sissonville,
4 West Virginia, to the late James Clarkson and Helen Louis Burdette Baldwin; and

5 WHEREAS, Sandy Cook graduated from Lafayette High School in 1952 and was a
6 majorette with the band. She was a member of the "Lafayette Girls" who continue to
7 meet monthly; and

8 WHEREAS, in 1994, Sandy Cook retired from the Scott County Sheriff's Office
9 after 18 ½ years of service to the people of Scott County. She earned the respect of her
10 co-workers and her community as a sworn deputy and an office administrator who would
11 do process service, collect taxes, and transport female prisoners; and

12 WHEREAS, Sandy Cook shared her faith as a member of Georgetown Baptist
13 Church; and

14 WHEREAS, Sandy Cook departed this earthly life on July 21, 2019, for her
15 heavenly reward leaving her family, her friends, and her community in solemn mourning;
