14	throughout his life. A DARE instructor who served as president of DARE of Woodford
15	County Inc., he was active with the Troy Presbyterian Church, Landmark Lodge #41
16	F&AM, and Buford Lodge #494 F&AM. He served as president of the Woodford County
17	Agency for Substance Abuse Policy ASAP, was a board member of the Kentucky
18	Sheriff's Association, and was chair of the Woodford County Democratic Party Executive
19	Committee and the Woodford County Board of Health. He was appointed to the
20	Kentucky Law Enforcement Council by former Governor Steve Beshear; and
21	WHEREAS, John Edward "Bear" Coyle, proud Woodford Countian and beloved
22	husband, father, and grandfather, departed this earthly life on November 5, 2018, leaving
23	all those whose lives he touched in solemn mourning; and
24	WHEREAS, Bear Coyle was preceded in death by his parents, John William Coyle
25	and Ethel Corman Coyle. He is survived by his wife of 42 years, Mary Don Withers
26	Coyle; sons, Andrew (Kristin), Roy (Katherine), Matthew (Jordan), and John Paul;
