1	A RESOLUTION declaring each month of the year a celebration of significant
2	historical documents.
3	WHEREAS, on July 4, 1776, the Declaration of Independence was adopted by the
4	Continental Congress, thus signaling the birth of the United States of America as an
5	independent nation; and
6	WHEREAS, the Constitution of the United States was subsequently ratified in
7	1788, becoming the supreme law of the land. Today, it is regarded as the world's longest
8	surviving written national constitution currently in use. The founders drafted the
9	Constitution of the United States to set up an important system of checks and balances,
10	comprised of an executive branch, a representative legislative branch, and a federal
11	judiciary; and
12	WHEREAS, on December 15, 1791, Congress ratified the first 10 amendments to
13	the Constitution of the United States, known as the Bill of Rights. The Bill of Rights was
14	crucial because it added essential rights and specific guarantees of personal freedoms; and
15	WHEREAS, the First Amendment guarantees the sacred protection of freedom of
16	religion, speech, and the press from government interference. It also gives those in the
17	United States the right to peacefully protest and petition the government; and
18	WHEREAS, the Second Amendment protects individuals' rights to keep and bear
19	arms; and
20	WHEREAS, the Third Amendment prohibits the involuntary quartering of soldiers
21	in private homes; and
22	WHEREAS, the Fourth Amendment protects individuals from unreasonable
23	searches and seizures imposed by the government; and
24	WHEREAS, the Fifth Amendment guarantees the right to a grand jury, forbids
25	double jeopardy, protects against self-incrimination, requires due process of law be a part
26	of any proceeding denying a citizen life, liberty, or property, and requires the government
27	to compensate citizens when it takes private property for public use; and

1	WHEREAS, the Sixth Amendment safeguards the rights of criminal defendants,
2	including the right to a speedy and public trial, the right to an attorney, the right to an
3	impartial jury, the right to confront your accuser, and the right to be apprised of the nature
4	of the charges and evidence against you; and
5	WHEREAS, the Seventh Amendment distinguishes civil claims which must be
6	tried before a jury from claims and issues that may be heard by a judge alone; and
7	WHEREAS, the Eighth Amendment prohibits excessive bail, fines, and cruel and
8	unusual punishments; and
9	WHEREAS, the Ninth Amendment addresses rights retained by the people that are
10	not specifically enumerated in the Constitution; and
11	WHEREAS, the Tenth Amendment guarantees that the powers not delegated to the
12	United States by the Constitution, nor prohibited by it to the states, are reserved to the
13	states respectively, or to the people; and
14	WHEREAS, on June 1, 1792, Kentucky became the fifteenth state of this great
15	nation when its first constitution was accepted by the United States Congress. In its over
16	two hundred years of statehood, Kentucky has adopted three more constitutions: one in
17	1799, one in 1850, and one in 1891, which is currently in force. The Constitution of
18	Kentucky governs the Commonwealth of Kentucky and established the General
19	Assembly;
