Diligently working behind the scenes, she continues to be an invaluable part of the agency as a member of the Project Center, facilitating the center's crucial mission of connecting the Capitol to the citizens of this great Commonwealth; and

WHEREAS, Sally Everman has gained the respect and appreciation of so many inside and outside the agency. She served as one of the chief organizers of the Special Advisory Commission of Senior Citizens, helping the 100 citizen members of that organization coordinate their two-day meeting in Frankfort; and

WHEREAS, Sally Everman also played an integral role in organizing and managing key components of the NCSL Legislator's Back to School Program, helping to promote civic education and sharing the principles of our democracy; and

WHEREAS, Sally Everman coordinates surveys that members of the General Assembly send to their constituents in order to gauge their feelings on a wide variety of issues. In overseeing this vital component of their communication with constituents, Sally has legislators' utmost trust for her understanding of their responsibilities and for her unwavering commitment to the democratic process; and

WHEREAS, for more than a quarter century, Sally Everman has served the Legislative Research Commission with her trademark professionalism, dedication, and dignity. Beloved by everyone who meets her—from legislators to fellow staff to the Capitol's many visitors—she truly represents the best the agency has to offer; and

WHEREAS, Sally Everman was hired into the agency by Vic Hellard Jr., and it is appropriate that she receives this award in his name. His relentless pursuit of the common good, his firm belief that "service and a commitment to the public trust have been this agency's goal," is illustrated no more strikingly than when one meets Sally in person; and

WHEREAS, the Vic Hellard Jr. Award was created in 1997 to recognize
