

1 A RESOLUTION adjourning the House of Representatives in honor and loving
2 memory of Russell Glen Mobley.

3 WHEREAS, Russell Glen Mobley was a son of this Commonwealth, having been
4 born in Clay County on November 18, 1933, to the late Elmer and Ollie Allen Mobley;
5 and

6 WHEREAS, a proud veteran of the United States Air Force, Russell Glen Mobley
7 graduated from the University of Kentucky and went on to teach high school in Lexington
8 in the 1960s. He produced and directed musical theater before becoming the director of
9 the theater program at Campbellsville University in 1971, a position he would hold for
10 more than three decades; and

11 WHEREAS, Russell Glen Mobley enjoyed a long career in state government, acting
12 as the Deputy Commissioner of Personnel and the Deputy Commissioner of Parks under
13 Kentucky Governor Louie B. Nunn. He also served as the Taylor County Judge/Executive
14 in the late 1980s; and

15 WHEREAS, from 2000 to 2008, Russell Glen Mobley was elected to serve in the
16 Kentucky House of Representatives, and his service to the General Assembly is
17 commended by all in this body today; and

18 WHEREAS, Russell Glen Mobley was an avid sports fan and a noted lover of
19 Broadway musicals, and he combined these interests to work as a radio announcer in
20 Taylor County, serving as the Voice of the Tigers for Campbellsville University; and

21 WHEREAS, Russell Glen Mobley was an active member of the Calvary Baptist
22 Church in Lexington and Campbellsville Baptist Church, and served as the minister of
23 music at the Palestine Baptist Church and Lowell Avenue Baptist Church in the 1970s
24 and 1980s; and

25 WHEREAS, Russell Glen Mobley, courageous patriot, esteemed public official,
26 and cherished husband, father, grandfather, and brother, departed this earthly life and
27 entered into the kingdom of Heaven on October 26, 2018, leaving his family, friends, and

1 all those whose lives he touched in solemn mourning; and

2 WHEREAS, Russell Glen Mobley is survived by his wife, Carole Ann McDaniel
3 Mobley; children, Gregory Mobley, Jeffrey Mobley and his wife, Diana Bain Mobley,
4 Stephanie Mobley Woodie, Suzanne Mobley Bennett and her husband, Joel Bennett, and
5 Joel Mobley and his wife, Mary Beth Edwards Mobley; thirteen grandchildren; two great-
6 granddaughters; siblings, Violet Morguson, Betty Ruth Hensley and her husband, James
7 Hensley, and Joe Lester Mobley; and a host of other family members, friends, and loved
8 ones who will dearly miss his presence in their lives;

10 ***Be it resolved by the House of Representatives of the General Assembly of the***
11 ***Commonwealth of Kentucky:***

12 ➔Section 1. The members of the House of Representatives hereby express their
13 most profound sympathy upon the passing of their former colleague in the Kentucky
14 General Assembly, Russell Glen Mobley, and extend heartfelt condolences to his family,
15 friends, and community in this time of loss.
