1	A RESOLUTION recognizing February 14, 2024, as Advanced Practice Registered
2	Nurse Day in the Commonwealth of Kentucky.
3	WHEREAS, advanced practice registered nurses (APRNs), including both nurse
4	practitioners (NPs) and nurse-midwives, are trusted providers of health care for patients
5	across the Commonwealth; and
6	WHEREAS, APRNs are five times more likely to work in rural areas, where there
7	is the greatest need, and wherever they provide care, they work to expand access to health
8	care in underserved communities and address health disparities; and
9	WHEREAS, patients depend on the more than 355,000 licensed NPs in the United
10	States and the 11,822 licensed NPs in Kentucky to diagnose, manage, and treat their
11	acute and chronic health conditions; and
12	WHEREAS, 138 nurse-midwives in Kentucky provide primary care for women,
13	including prenatal care, education, the delivery of infants, and postpartum and
14	gynecological care; and
15	WHEREAS, APRNs provide high-quality primary, acute, and specialty health care
16	services while emphasizing health promotion, disease prevention, health education, and
17	counseling, guiding patients to make smarter health and lifestyle choices; and
18	WHEREAS, the confidence that patients have in NP-delivered health care is
19	evidenced by the more than one billion visits made annually to NPs across the country
20	and the more than five decades of research that confirms the high-quality care provided
21	by APRNs; and
22	WHEREAS, better utilization of APRNs through modernized state laws and
23	improved policies has created improved health through a more accessible, efficient, cost-
24	effective, and higher-quality health care system; and
25	WHEREAS, leading governmental and policy entities, including the National
26	Academy of Medicine, the National Council of State Boards of Nursing, the National
27	Governors Association, and the Federal Trade Commission, have taken notice of the
